CONFERENCE PROCEEDINGS 1912 .

The third annual session of the Alabama Annual Conference of the Wesleyan Nethodist Connection (or Church) of America met at Ada Chapel November 7, 1912 at 2:00 P.M.

Conference was called to order by the Rev. E. Teter and devotional exercises were

conducted by Rev. R. G. Ramsey.

The Secretary (W.E.HobsonmJr.) being absent E. R. Tubb was elected secretary protem.

Roll was called and the following answered to their names; Rev. Ada Ramsey, P.C.Ramsey, J.A.S.Anderson, Elders absent, W.F.Stamey. Licentiates present R.G.Ramsey, R.E.Snipes, L. A. Bamburg, absent, Cleona Peebles, J.A. Wood and G.C.Tucker.

The following names were received as delegates from the various charges; J.O.Bailey from Friendship Station; G.W.Wall, Sudie Gleaton, V.A. Stewart and J.A. Miller, Bibb Charge, E.R. Tubb, Wayeross Charge. There being no objections their names were placed on the roll.

The president then declared the conference ready for business.

The name of G.C.Tucker was called, it was ascertained that his license was not renewed and his name was dropped from the roll. It wis ascertained that Miss Cleona Peebles had been transferred to the North Carolina Conference and J.A.Wood to the North Georgia Conference and their names were dropped from the roll as having been transferred. On motion the time of meeting of the conference was fixed as follows; Morning meeting at 8:30 a.m. Afternoon meeting at 1:30 p.m. and both adjourn by motion.

It was voted to have preaching every day at 11:00 a.m. and 3:00 p.m. and none at night.

On motion the conference bar was made to include the second seat in front of the stove.

The following persons were elected as a committee on religious services, J.A.S. Anderson, P.C. Ramsey.

It was voted that the conference consider the appointment of pastors, as the committee of the whole.

On motion Mrs. Sudie Gleaton and J.O. Bailey were elected the committee on statistics.

On motion Mrs.Ada Ramsey was teletted to fill the vacancy in the Committee on Itinerancy and Elder's Orders. The Committee now stands as follows; Mrs.Ada Ramsey, 3 years; P.C.Ramsey, 2 years, E. Teter, 1 year. J. O. Bailey and G.W.Wall were appointed lay members.

R. G. Ramsey was recommended to the conference as a suitable person to be ordained and on motion it was referred to the Committee on Itinerancy and Elder(s Orders.

On motion Rev. E. Teter, P.C. Ramsey and G.W. Wall were elected a committee on Ministerial Characters.

By motion adjourned.

Second Day - Morning Meeting

Conference was called to order by E. Teter and devotional exercises were conducted by Rev. L.A.Bamburg.

Roll called, minutes read and approved.

On motion the following committees were elected;

SECOND DAY - AFTERNOON MEETING.

Conference was called to order by P.B.
Ramsey Vice-President, and evotional exercises were conducted by Rev. R.E.Snipes.

Roll called, minutes read and approved The conference then proceeded to the election of permanent officers.

On first ballot Rev. E. Teter was elected President as a connectional afficial.

On second ballot P.C.Ramsey was elected vice-president.

On third ballet E. R. Tubb was elected secretary. By vote E Teter was elected Treasurer.

By motion J.A.S.Anderson and V.A.Stewart were elected as the advisory board.

The conference then proceeded to elect a Missionary Board as follows, Rev. E. Teter, P.C. Ramsey, Mrs. Ada Ramsey, J.A.S. Anderson W.M. Gleaton.

The Conference then by vote elected P.C. Ramsey as Conference Missionary Evangelist, to labor as instructed later by the Conference.

On motion Revs. P.C.Ramsey, Ada Ramsey, W.F.Stamey, laymen M.C.Medders and E.R.Tubb were elected the Committee on Vacancies.

Report of the work of the Y.M.W.B. was made by Mrs.J.A.B. Anderson and ordered entered upon the minutes. See report No.7

Rev. J.A.S. Anderson presented the following resolution which pertained to the work and powers of the President and Missionary Evangelist which was adopted.

First-When the Missionary Evangelist was invited to hold any quarterly meetings he was authorized to be chairman of all business meetings without a vote of the quarterly conference.

Second-As MissionaryEvangelist he is to work in the interest of missions within the bounds of the Alabama Conference but may hold meetings elsewhere by consent of the Missionary Board and Missionary Secretary.

Third-The Missionary Evangelist is to help the pastors on their work when not otherwise engaged, and is to hold all meetings when the most convenient time for holding the same.

Fourth-The Alabama Conference hereby requests help from the Parent Missionary Board or Society for said missionary evan-

gelist to the amount of \$300.00 payable quarterly, provided the money is in the treasury to pay the same.

On motion it was voted that the conference be held two weeks later next year.

On Motion said Committee was empowered to fill any vacancy in said committee that

may occur.

By motion said committee was instructed to lock up a suitable location for for the putpose of holding camp meeting and to purchase same and to solicit funds to build a tabernacle thereon in which to hold the conference camp meetings, provided they can do so with the means raised for that purpose. They are not to go in debt.

The Missionary Board made the following recommendations; that R. E. Snipes be paid \$25.00; M. A. Medders, \$25.00 and P.C.Ramsey for use of tent \$10.00. By motion it was agreed that when P.C.Ramsey's was used for the benefit of the conference camp meeting that he be paid \$1.00 per day for its use.
