DAILY PROCEEDINGS

The Canada Conference of the Wesleyan Methodist Connection (or Church) of America in Canada convened for its forty-ninth annual session in the Wesleyan Methodist Church, Ottawa, Ontario, Wednesday, April 24th at 9 A. M.

Conference was called to order by the President, Rev. S. W. Blanchard.

Devotionals were conducted by Rev. S. W. Blanchard.

Rev. D. A. Rees, our Connectional Representative brought his morning address from I Peter 5:1, using as his topic, "The Perils of the Pastor." He emphasized the following:

The church does not owe the minister a job.

The Conference does not owe the minister a place.

Helpful instruction was given on two perils of the minister, viz, Orthodoxy and individualism.

After the message Conference came to order for business. Roll Call.

Carried on motion that the first four seats on either side of the church constitute the Conference Bar.

Committees on Temporary Organizations read report which was accepted by vote of Conference. (See Report No. 10).

Committee on Credentials read a partial report which was accepted. Rev. D. A. Rees was introduced to Conference and brought words of greeting.

Mrs. C. B: Mills was introduced to Conference and spoke briefly.

Dr. Stephen W. Paine of Houghton College was introduced to Conference and brought words of greeting.

Rev. J. W. Bray, Fraternal Delegate from the Pilgrim Holiness Church was introduced to the Conference and brought greetings and good wishes from his church.

Rev. I. F. McIntyre was introduced to Conference and brought words of greeting.

Rev. L. S. Summers, pastor at North Bay, was introduced to Conference and spoke briefly.

Carried on motion that those introduced to Conference be entitled to sit within the Conference Bar and have the privilege of speaking on all questions.

Rev. D. A. Rees was asked to preside during Conference by vote of Conference.

The President, Rev. S. W. Blanchard, read his official report which was adopted to the point of recommendations. (See report No. 1).

Moved and seconded that the President's recommendations be considered item by item.

The President's recommendations were read and accepted by vote of Conference.

Carried on motion that the election of Conference Officers be Thursday morning following devotions.

Carried on motion that the President contact the Representative of group Insurance and have him come to Conference to explain the Company's Policy and answer questions.

RELIGIOUS SERVICES

The Opening service of Conference was held at 7.45 P.M. Tuesday evening, April 23rd.

Rev. E. W. Tokley brought words of welcome to which Rev. H. Kielty ably replied.

Rev. D. A. Rees preached the opening sermon using as his text I Cor. 15:21-22. His topic was "Atonement." The following divisions were stressed:

The Need of the Atonement. The Cost of the Atonement. The Provisions of the Atonement. The Far-reaching Scope of the Atonement. Our Responsibility to the Atonement.

Saturday, April 27th, 7.45 P.M. This was a Young People's service under the auspices of the W.Y.P.S.

Sunday morning. April 28th, 10.45 A.M. A large crowd of people were

in attendance at the Sabbath morning service which was an Ordination Service. The Ordination sermon was preached by Rev. D. A. Rees, our Connectional Representative from 2 Tim. 1:7. God was very manifest during the preaching of the sermon and a tender melting spirit prevailed while Stanley Lyle Summers was ordained an Elder after the impressive and solemn provision of our Church.

Previous to the Ordination sermon presentation of a Bible to Rev. D. W. Summers, from the ministers, and a Testament, from the Missionary Society, to Mrs. Summers was made. Rev. & Mrs. Summers are leaving our midst to take work in the Lockport Conference. Fitting words were spoken by Rev. S. W. Blanchard and Mrs. Edward Wilson. REPORT NO: 1. CONFERENCE PRESIDENT'S REPORT

Ottawa, Ont., April 23rd, 1946.

Canada Conference Now in Session.

Dear Fellow-laborers,-

We are again assembled as a conference in the interests of our beloved Zion. This is our 49th annual session and with the passing of the years the problems and responsibilities increase with the growth and development of the church. Another conference year has gone and its history has been written. The history of the past years should provide a profitable study for us in reference to our future. A retrospective view of the past, a careful survey of our successes and failures, and methods employed should prove profitable in the execution of well formulated plans and legislation for the future prosperity and advancement of our work.

Canada is a large territory and offers great opportunities. It is not advisable that we should undertake more than we can successfully handle. We should, nevertheless, be making definite progress. That day is past in which the work should be allowed to drift or be subjected to inadequate administration. We should conserve every inch of ground taken and steadily and persistently advance. It is not sufficient to adopt plans and methods or make legislation unless they are properly worked and, consistently observed. It was said of the conference last year that it marked a real epoch in the history of the Canada Conference. It is to be hoped that the same may be said of this conference session. Over and above all our best efforts we need the blessing of the Lord and the leadership of the Holy Spirit without which we can accomplish nothing. We must adhere to the old paths and never slacken our pace in the effort to keep spiritual, avoiding the modern trend of programs, and stereotyped forms and ceremonies.

"We want no new religion, no modern, easy way;

We want the fire and glory, we need so much to-day."

A popular radio broadcast, "Time Marches On" might make a suitable slogan for us with changing the word "Time" for the words, "The Canada Conference." It would be quite useless however, to have our slogan "The Canada Conference Marches On" if we failed to be aggressive and our annual reports revealed no growth and development.

During the year we have visited most of the churches in the conference and held revival services at several points. This has afforded us an opportunity to become better acquainted with our laity. We have been able to observe at close range the successes of the churches, the problems of the pastors and the handicaps and opportunities. In all these we find that the future of our work is indeed encouraging. Great possibilities challenge our best efforts. More finances have been raised this year than ever before. A basement church has been completed at North Bay. Work on the Belleville church is already under way. A fine parsonage has been purchased at Newington, Ont.

We trust that we may have the guiding hand of the All Wise One in all our deliberations, and that the plans and legislation of this conference will accelerate the development and growth of our Canada Conference.

Two new Sunday Schools were added to the list, the one at Belleville, Ont., the other on the Powassan charge.

On June 1, 2, and 3, a Sunday School Convention was held at Ottawa. This unusual Convention was a blessing to all who were privileged to attend. The well-planned tectures and spirit-filled evangelistic messages of our Connectional Sunday-school Sec'y., Rev. O. G. Wilson, of Marion, Indiana, the instructive Scene-O-Felt drawings of Mrs. F. G. Huson, of Gormley, Ont., and the inspirational singing of the Home Sweet Home Girls Trio, combined with the co-operation of each Sunday-school of the Conference, contributed greatly in making the Convention a real success.

In the Wesleyan Methodist Church at Wincester, Ont., Nov. 22, 1945, was a high-day in that the Sunday-school Board met to formulate plans for another Convention. Folders announcing this Convention are already in circulation. Let us make the Winchester Camp Grounds on June 21, 22, 23, a special holiday weekend. The workers will be the Rev. George Failing of our Central College Church, Central S. C., Captain L. R. Mack, of the Canadian Army Chaplaincy, and an outstanding Ladies Trio of Toronto.

During the year the Secretary visited each Sunday School in the Conference. This was done with the purpose of encouraging our Officers and Teachers and promoting an even greater and keener enthusiasm among all Sunday-school workers. These contacts, we feel, were not in vain in the Lord.

The Board gave consideration to the recommendation from Conference regarding the "Wesleyan Hour." The decision reached was that we contact each local Sunday-school Board requesting that each School subscribe a specified sum of money to this worthy cause. We solicit the interest of each pastor in making this effort a success.

The Sunday-school Board would earnestly call to the attention of our people and church leaders the vast opportunities for reaching our youth through the medium of our church schools and their correlated activities. Each local Sunday School provides an opportunity for service on the part of devoted and envisioned laymen unparalleled in any other department of the Church. Brethren, let us pray for an enlarged vision throughout this year.

MINUTES OF THE WOMAN'S HOME AND FOREIGN MISSIONARY SOCIETY OF THE CANADA CONFERENCE HELD AT OTTAWA, ONTARIO, APRIL 24th, 1946.

The Women's Home and Foreign Missionary Society of the Canada Conference of the Wesleyan Methodist Church convened for its twentysixth annual session at Ottawa, Ontario, April the 24th, 1946.

The Session was opened by our President, Mrs. E. E. Wilson. Sr. D. W. Summers conducted devotions with hymn, "Break Thou the Bread of Life," and scripture reading from the tenth chapter of St. Matthew. Sisters Fricker and Sinclair led us in prayer.

Carried on motion that Sister N. Dunbar be Committee on Credentials.

The roll was called and answered to by the name of a missionary on the Foreign field.

Carried on motion that the first four seats constitute the Conference Bar.

Carried on motion that Sister V. Hamilton be Committee on Courtesy.

A Nominating Committee was elected consisting of Sisters Wilson, Summers, Hamilton, Presley and Major.

Carried on motion that the President of the W. H. & F. M. Society, and the President of the Society on whose charge the Conference is being held, be Committee on Religious Services.

Carried on motion that Sr. A. Freeman be our Reporter.

Carried on motion that Srs. Blanchard and Kielty be Committee on Resolutions.

Carried on motion that Sr. Spearman be Committee on Thanks.

Carried on motion that the election of Officers be held on Thursday afternoon following devotions.

At this time Mrs. C. B. Mills was introduced to the Conference.

The Statistical Reports of Inkerman, Waltham, Toronto, North Bay, Newington, Cornwall, Winchester, Belleville, Shawville, Powassan and Ottawa were read and adopted.

Our President explained some of the items of our Report Blanks.

Mrs. Hamilton, Supt. of the Y.M.W.B. told us of the change in the Reports of the Y.M.W.B.

Our President again reminded us to get our Annual Report Blanks in on the date (Mar. 31) specified in our minutes of last year with receipts attached.

Sr. Wilson asked our former secretary, Sr. E. Stephens, to bring us words of greeting.

Sr. Higginson also brought us an interesting talk about the different Prayer Bands in Montreal who are working together in the interests of Missions.

Dr. Paine, President of Houghton College, was introduced to our Conference and gave us a short talk on Houghton College, and told how a great majority, who came as students, and who are not converted, find the Lord before they leave. He finished by saying: "Be of good courage and keep praying for Houghton."

Meeting was closed with prayer by Sister N. Dunbar.

Our meeting on Thursday afternoon was opened by singing: "Lord of Harvest," and Sr. E. Stephens read the scripture lesson from Luke 12:22-32.

Mrs. Wilson showed us the Missionary Picture Sheets and spoke of some of our missionaries. We were led in prayer by Sr. Blanchard. The roll was called and minutes read and approved.

The Treasurer, Mrs. W. Presley read the Annual Report and the Treasurer's Report both of which were adopted.

We then had our election of Officers as follows:

President-Mrs. E. E. Wilson.

Vice-President-Mrs. S. W. Blanchard.

Secretary-Mrs. W. J. Major.

Treasurer-Mrs. W. Presley.

Y. M. W. B. Supt .- Mrs. V. Hamilton.

Delegate to General Conference-Mrs. V. Hamilton.

Alternate-Mrs. Lyle Summers.

Sr. C. B. Mills brought us an inspiring message about her life before and after her conversion. May we catch the vision of doing personal work for the Lord in our daily Christian walk. Sr. Mills closed with prayer.

Our meeting opened on Friday afternoon with the hymn: "Take My Life and Let it Be."

Our President, Sr. Wilson, asked for prayer for our Home fields and especially for Brother M. Summers who takes our new work at Sudbury, Ontario. We were led in prayer by Sr. L. Summers.

Roll was called and minutes read and approved.

The Committee on Courtesy introduced Dr. Rees who brought us greetings from the different departments of the work of the Wesleyan Methodist Church. He spoke of the Indian work, and of seeing wonderful conversions among them. This, he said, is a very interesting work. He also said: "Why not have Bro. Newcombe, who is very well trained, a leader of a Board to develop, what might be, an Indian Conference.

He spoke also of appreciating the work of the W. H. and F. M. Society, not only regarding the money we raise, but in the prayers of our women.

Bro. Zurbrigg, of the Free Methodist Church was introduced to our group. He spoke of the Women's work in the Free Methodist Church and of some of the missionaries who went out to Foreign fields and of some of the sacrifices in the work of Missions.

The reports of the Committee on Thanks and the Committee on Resolutions was read and adopted.

Sr. Wilson asked us to not forget to pay our money to Hepzibah Orphanage.

It was carried on motion to have our minutes printed with the Conference Minutes.

Sr. Hazel Jones, returned missionary to India was introduced to our women and gave us a short message on the happenings in India during the riots against the Government and mission buildings. She told of the organizing of an Indian Conference which is called the Wesleyan Methodist Church of India, so that if the missionaries had to leave, the property of the church in India would be looked after. Some of the Indian leaders are just as responsible and careful as the missionaries could possibly be, because they have so completely given their lives over to the Lord.

Sr. Marguerite Poe and Sr. H. Jones are under appointment to go to India as soon as school closes.

Sr. D. W. Summers, our President of former years, and who has been our organizer, spoke to us by request of our President, Sr. Wilson, as she is leaving our Conference to make her home in another Wesleyan Methodist Conference. Our President spoke of our appreciation of the help Sr. Summers has been in our Society. The Minutes were read and approved, and another annual Conference session, in which our souls were refreshed and encouraged to go forward into a new year with God's blessing to do and dare for Him, was closed.

We sang, "Blest be the Tie that Binds" and we were dismissed with prayer.

RELIGIOUS SERVICES

Our Friday night service was under the auspices of the W.H. & F. M. Society and was opened by singing, "Faith of Our Fathers." Sr. Irene Tuttle led in prayer, and Psalm 98 was read by Sr. E. Spearman. Dr. Rees brought us a message on Home Missions from the scripture Isa. 54:2, 3. He spoke of the spiritually desolate places where there are no spiritual churches. There is a great need. They do not have the Gospel. One of the first things to do about it is, "To Pray." Ask God to show us where to go. We need to go where we are led. We need money. Some do not fit into Pioneer Work at all. We need someone who is able to do it, and who will take off their coat figuratively speaking and make the thing go. New Pioneer Work pays tremendous dividends. We do not know what it is worth.

Sr. Jones showed us pictures of our work in India which were very instructive, and helped, very much, in showing the need there.

The Sunday afternoon service of the W. H. & F. M. Society was opened by our President, Sr. Wilson. Sr. Marion Whitney led the song service. Nellie Dunbar led in prayer and the Scripture from Rom. 1:10-21 was read by Sr. Inda Watt. A message in song was sung by the Ottawa Ladies' Quartette after which the report of the Committee on Thanks was read by Sr. E. Spearman.

Sr. Hazel Jones gave us a very interesting and inspiring message on India. She spoke of some of the pleasing things of India, such as flowers, mountains, etc., and of the religions, the priests, the caste system, and how much prayer means to the missionaries there. How, as the people in the homeland prayed, the work of the Lord started to grow in India, and of how lives were changed.

Sr. Jones closed her interesting message by saying: "God gave two commands; one is, 'Pray Ye!' the other, 'Go Ye!'" Sister Wilson asked Bro. Tokley to dismiss with prayer.

3. We would recommend that prayer be emphasized in our monthly meetings, recognizing that, without the aid of the Holy Spirit, nothing can be accomplished.

4. We also recommend that the Local Presidents observe Paragraph 299, item 1 in our Discipline, which reads, This Society shall, if possible, hold regular bi-monthly meetings, at one of which we urge Mission Study. Prayerfully Submitted,

W.Y.P.S. PRESIDENT'S REPORT TO CONFERENCE APRIL 27th, 1946

Officers and Members of the Young People's Society of the Canada Annual Conference, and Brothers and Sisters in Christ:

With a sense of deep gratitude to God and a feeling of our own unworthiness, we humbly present our report to you at this Tenth Annual Conference gathering held in this Ottawa Church.

We are glad to report that we have victory in our souls through the Precious Blood of Jesus, and that during the entire year we have been conscious of the leadings of the Holy Spirit. We have sought His will concerning matters in the Young People's Work and we believe we have followed His directions.

We believe our Societies on the whole are doing excellent work, not only financially, but also spiritually. We know of a number of our young people who have deepened in their Christian experience. We have found in the Conference young people who are capable spiritual leaders. The great desire of our life is that our young people learn to take their place in a definite Christian way, not only in the Y.P.S. but in the Church. Our young people should realize that they are the Church of to-morrow, and earnestly prepare themselves to be able to carry the responsibilities of the Church in the days to come. The Holy Spirit is seeking young people who are fully consecrated and ready for use as clay in the Master Potter's Hands. A few of our young people are entering the ministry, but it is our great desire, as we get older in the Way, to see more of our young boys and men answer the call to the Christian Ministry that the Torch of Holiness may continue to be extended and the Sacred Trust left to us by our fathers, be held fast.

Though we have not been able to visit all our Societies personally, we have thought much of their problems and have upheld them in prayer. We have been in correspondence with them all during the year.

We believe we have the confidence and support of every minister, Y.P.S. President and Member in the Conference, and we appreciate their co-operation.

We are glad to be able to report three new Societies this year, one at North Bay, one at Toronto, and one at Powassan. We wish to welcome these three new societies in our Conference and we are glad their presidents and delegates are in our midst to-day. We were glad to have had the privilege of helping with the organizing of the society at Toronto last November. The society was organized with 23 Members and Rev. Leroy, the Pastor, was elected President. They are a fine group of young people and we understand that the attendance at their meetings is 30 to 40. Though we were not present at the organizing of Powassan society we are glad that the Pastor, Rev. McCorriston has the vision of promoting the W.Y.P.S. in his district and has organized a fine society.

Shortly after Conference last year Rev. Lyle Summers, the new pastor at North Bay, organized a Y.P.S. We were glad that he started the young people right in with an organized society. They have a fine group of young people there.

We believe the Ottawa Society and their Youth Solicitor, Rowat Deeks, are due much appreciation for the splendid increase in the number of Youth Subscriptions this year. Their subscriptions stand at 59. This is a fine record and we trust it will prove an incentive to all others.

Since most of our boys and girls in the Armed Services have returned home and are discharged, we have discontinued writing to them and have turned over any further service for them to the local societies. Though this work proved a tremendous task, we enjoyed doing even the little we could for the boys. We believe our service was appreciated.

We believe that both our Summer and Fall Conventions last year were a blessing to our Young People, and that they were well worth the effort in seeing a number of young people pray through at the altars. Our Convention last Fall at Shawville certainly proved that our young people appreciated and enjoyed having this extra convention in the Fall. We believe much good was done. All our Speakers gave excellent service and their ministry was a blessing.

We have arranged the Speakers and Singers for our Annual Summer . Convention to be held August 16, 17 & 18. They are Rev. & Mrs. H. J. Logsdon and Rev. & Mrs. Howard Noggle, all of Marion, Indiana. Rev. Logsdon is the Y.P.S. President of the Marion Area, and Rev. Noggle is the Field Director for Marion College.

Last November we had the privilege of attending the Area Mission-

ary Convention at Houghton in connection with our meeting of the Y.P.S. Area Executive. We enjoyed the Missionary Convention very much. At the Y.P.S. executive meeting our Conference was awarded the Houghton Area Honor Reward Plaque for 1945. Our percentage was 1082%, and the nearest were the Champlain Conference with 634%, and the Middle Atlantic States Conference with 361%. We have had some difficulty in getting the proper etching of letters on this plaque, having finally to send it back to the States to have this done. However we are glad it was returmed for Conference and it may now be seen on the side wall of this Church. We trust that all our efforts during this year will help us win it again this year.

At the Executive meeting plans were made for a Joint Convention this Labour-Day week-end at Houghton, with the Young People of the Free Methodist Church in the same Area. Announcement has already been made in our Wesleyan papers. We hope a number of our young people will plan to attend. It was also ruled by the Executive, that all our money raised for Pioneer work be used only for definite new Pioneer work, and that this Fund be built up in the Y.P.S. Conference Treasury ready for the need. It was urged that the young people of the Area open up new work in accordance with the plans of the Annual Conference, and sponsor and finance these projects for the Conference, and turn their responsibility over to them when a society has been organized.

At last Conference we started a new project, that of printing and circulating a Canada Y.P.S. News every two months. Our Editor, Rev. H. Kielty, has done a fine job, though under a financial handicap. Toward the latter part of the year our societies rallied more to its support and we believe that its value was appreciated. Congratulations to our Editor who did a good job for us, even though the co-operation of the Conference was slow at first. The cost of our News is shown in the Editor's report. There were 1600 copies printed and circulated. We trust our Young People will continue to print this paper as we feel it can be a great source of blessing and encouragement.

The Treasurer will give a report of our expenses during the year.

We have asked the Conference Executive Committee to prepare a report of proposed Resolutions for our Canada Y.P.S. to be submitted for your approval at this Conference. We believe we ought to have some definite Resolutions in our Young People's Societies.

We wish to make the following recommendations to the Conference:

1. That a Joint Convention with the Free Methodist Young People of the Area be planned for next year.

We have been corresponding with the Free Methodist Y.P. M.S. President regarding such a Convention, and very recently we had an enjoyable interview with Rev. Bull. He informed us that they were anxious to have such a Convention with us, and would appoint a Committee at their Conference this August to meet a Committee from our Y.P.S. to arrange plans for a Convention next summer.

2. That a Committee on Resolutions be elected to prepare any new resolutions each year to be adopted by our Canada Y.P.S.
