The Ninth Session of the Alabama Annual Conference of the Wesleyan Methodist Connection or Church of America, met at West Blocton, Ala., Nov. 6, 1918 at 10 a. m. and was called to order by Rev. J. A. Wood, President.

Devotional exercises were conducted by Rev. W. R. French. By request of the President Rev. E. Teter took the chair as chairman to preside over the conference. The Secretary then called the roll of Elders and Licentiates the following answering to the calling of their names: J. A. S. Anderson, R. A. French, J. A. Wood, R. G. Ramsey, H. R. French, J. L. Averett, W. R. French, G. W. Hilson, M. A. Medders, M. J. Kelly, W. C. Lovin.

The following names were presented with credentials as lay delegates from the various charges and their names placed on the roll: W. E. Hobson, Jr., Miss Frances French, Mrs. H. F. Shigley, Walter Coleman, Mrs. P. A. Gleaton, Mrs. J. A. S. Anderson, M. C. Medders, Mrs. John Gilbert, Mrs. M. A. Medders.

Conference was then declared ready for business.

The President made his annual report which was adopted. See report No. 1.

Committee on Nominations made its report. See report No. 2.

A petition was presented from the Church of Ada Chapel asking that it be made a station, a petition was also presented from the church of Friendship asking that they with Ada Chapel be made a circuit, a petition was also presented from the church of West Blocton asking that it be made a station, by motion these petitions were referred to the Committee on Pastoral Relations.

On motion the hour of meeting was fixed at 9 a. m. and 2 p. m. to adjourn by motion. Religious Services at 11 a. m. and 7 p. m.

Rev. E. L. Henderson representative of Central College, Central, S. C. was introduced to the conference, and by motion was made an honorary member and given a seat in its body.

On motion conference adjourned.

FIRST DAY-AFTERNOON MEETING

Conference called to order by the President and devotional exercises were conducted by Rev. J. L. Averett:

Roll called, minutes read and approved.

By motion Rev. J. A. S. Anderson was relieved of acting on Pastoral relations committee substituting that of Rev. R. A. French to act in the decision of the formation of new circuits or the division of old ones.

Committee on Bar of Conference reported fixing same to include each side and three seats in front of the pulpit.

Recommendations were presented for G. W. Hilson to be ordained an elder, which by motion was deferred until papers were presented.

On motion Rev. H. R. French was elected to fill the unexpired term of Rev. R. E. Snipes on the Committee on Itinerancy and Orders, Mrs. J. A., S. Anderson and Walter Coleman were elected as the lay delegates on this committee.

By motion and vote Rev. R. A. French was elected on the Committee on Itinerancy and Orders for four (4) years.

On motion it was made the order of the day to elect permanent officers Friday morning as soon as ready for business.

On Motion Rev. E. L. Henderson was given the hour of 7 p. m. Friday to make his educational address.

By motion it was made the order of the day for the connectional representative address to be made at 3 p. m. Friday.

The Committee on Pastoral Relations made a partial report.

By motion G. W. Hilson was elected a committee on Sunday School Statistics in the absence of the Sunday School Board Secretary.

On motion conference adjourned.

SECOND DAY-MORNING SESSION

Conference called to order by the President and devotional exercises were conducted by Rev. W. C. Lovin.

Roll called, minutes read and approved.

H. F. Paire presented credentials as lay delegate from Pell City charge, which were accepted and his name entered on the roll.

A letter of Greetings from Rev. R. E. Snipes of the Georgia Conference was read before the conference and on motion the Secretary was instructed to make reply to it and all other letters of greetings to our body.

Committee on Pastoral Relations made a partial report, relating to the division of Bibb Circuit, recommending that the churches of said circuit under their present conditions remain as they are in one circuit, which by motion and vote was adopted.

Roll called, minutes read and approved.

The order of the day was called for and proceeded to the election of permanent officers which resulted as follows: J. A. Wood, President; R. A. French, Vice-President; W. E. Hobson, Jr., Secretary-Treasurer; Advisory Board-J. A. Wood, R. A. French, H. F. Paire; Missionary Board-J. A. Wood, J. A. S. Anderson, R. A. French, W. C. Lovin, W. E. Hobson, Jr., M. C. Medders, H. F. Paire; Missionary Executive Board-J. A. S. Anderson, R. A. French, W. E. Hobson, Jr.; Vacancy Committee-R. G. Ramsey, M. A. Medders, H. R. French, R. M. Bearden, W. E. Hobson, Jr.; Judiciary Committee-R. A. French, J. A. S. Anderson, J. A. Wood, H. R. French; Sunday School Board-J. D. Muse, G. W. Hilson, W. R. French, and on motion G. W. Conference then proceeded to the election of delegates to the General conference which meets on the fourth Wednesday in June of next year in Fairmount, Indiana, the following being elected: Ministerial delegate—H. R. French, Alternate, W. R. French; Lay delegate—W. E. Hobson, Jr., Alternate, Miss Frances French.

FOURTH DAY-MORNING SESSION

Conference called to order by the President and devotional exercises were conducted by Rev. M. A. Medders.

Roll called, minutes read and approved.

The following Elders and Pastors made their reports, which were adopted and characters passed: J. A. S. Anderson, R. A. French, J. A. Wood, R. G. Ramsey, H. R. French, J. L. Averett, W. R. French, G. W. Hilson, M. A. Meddlers, M. J. Kelly, and W. C. Lovin.

The resolution petitioning General Conference to adopt certain amendments to the discipline was again read before the conference which by motion and vote was adopted. See report No. 4.

The order of the day was called for and the Connectional Representative Rev. E. Teter made his address.

FOURTH DAY-AFTERNOON SESSION

Conference called to order by the President and devotional exercises were omitted.

Roll called, minutes read and approved.

On motion the following resolution was adopted:

"Be it Resolved by the Alabama Conference assembled at West Blocton, Ala., Nov. 6-10, 1918, that we the ministry of the Alabama Conference will not go on any man's charge where the pastor and advisory board objects to hold or assist any one in holding meetings on such charge which would in any sense influence the members of our church to divide or live contrary to the rules of our church. This would not preclude our ministry from accepting an invitation to preach for other churches upon invitation, but said preaching must only be occasional and not in any sense the holding of a protracted meeting.

2. We the ministry of the Alabama Conference will not allow our names to be considered as prospective pastors on any circuit or charge until after the present pastor has notified the charge that he does not wish to serve said charge another year. If he does not give such notice, but is to be voted on for pastor, we will not allow our names to be used until said chargge votes to change. We will not allow our names to be presented, to be voted upon unless the charge or churches composing the charge will obtain said vote through the pulpit supply committee by giving the notice required by the discipline. In case said charge or circuit waives its right to vote and leaves the matter of pastoral supply to the conference, then with the consent of the President and his advisory board said minister may enter into a contract to serve said charge. But should such a condition arise in said church or charge that if the person engaged as pastor was to be confirmed by the conference it would destroy the church or charge, then the ministry agrees not to ask the ratification of said contract so that a pastor may be appointed by the conference that is satisfactory to a majority of the members of said charge.

3. Any minister violating the above rules governing our work, and contracting with churches, the conference shall not pass his character until sufficient confession is made to the conference coupled with a promise not to repeat the offense.
