On Motion of Bro. Crooks the transfer of Br. Brewster was received by unanimous vote. When Conference adjourned to meet at 2 OClock P.M. Benediction by the President.

## Aug 19th 2' OClock P.M.

Conference met – President in the chair. Singing and prayer by Bro. Tressonrider.

Ministers of reformatory churches in attendance were invited to honorary seats with us by unanimous vote.

On motion of Bro Jones Conference proceeded to ballot for Committee on Pastoral Relations; Bros Sewell and Royce acting as tellers, which resulted in the election of the following persons: Ministers Laymen

R. Horton. G. Hagaman.

On Motion of Bro. Crooks the Committee on Pastoral Relations was constituted a Committee on Boundaries also.

[Margin: Hours of Meeting etc.]

The time of meeting and adjournment was fixed at 8 and 11 ½ OClock A. M. respectively.

[Margin: Instructions to Stationing Committee]

Conference ordered that in case the Stationing Committee should appoint an Evangelist that they fix his salary and report an apportionment of the same among the Circuits and Stations.

[Margin: Character Examine]

The examination of character, on motion of Bro. Tressonrider was commenced.

Bro Sanders name being called, his Delegate reported the affairs of the circuit, in part, and Bro Sanders character passed.

The name of Bro A.N. Hamlin was called who then gave an encouraging account of his labors as Conference Evangelist, during the year: when his character passed. [Margin: Zanesville Case]

Letters were presented, from parties in the City of Zanesville, in reference to difficulties existing in the Church there; a part of which were read; when of on motion of Bro: Evans Thompson, the Conference voted to refer the whole matter to a Committee of three [insert: who should] for to take charge of the papers, consider the case, and report to Conference at its next yearly session.

[Margin: Character Examine]

The examination of character being resumed, the names of Bros. S. D. Jones, Adam Crooks, Wm Sewell, R. McCune and Evans Thompson; were severally called characters considered, and passed.

Various announcements were then made, when Conference adjourned by benediction from the President.

Thursday morning 8 Oclock A.M.

President in the chair.

Roll called by the Secretary.

Minutes of the previous sessions read and approved.

The President announced the following names on Committees.

[Margin: Committees: Character, Wilson Case, Character]

On Missions – A. Crooks, R. Horton, and N. W. Hodges.

On Reforms – Benj. Tressonrider, S. D. Joes, and J. Oshell.

On Sabbath Schools – W. H. Brewster, Wm. Sewell, and J. B. Hunt

The examination of character was again resumed, and Bro: Richard Hoskins name was called, character considered, and passed. The name of Bro: Daniel Wilson being called letters were presented in relation to difficulties existing in N.C., when on motion of Bro: Tressonrider, the case was referred to a Committee of two; Consisting of Bros McCune and Crooks; Bro: Wilson's character being laid over, awaiting the report of the Committee. Bro: William B. Moody's character passed and name placed on the unstationed list – this being his desire as expressed, by letter, to the Conference.

It was voted that when we adjourn we do so to meet at 3 P.M.

Vacancies on the Examaining [sic] Committee were filled by the election of William H. Brewster and R. Horton.

[Margin: Preachers received on trial]

On recommendation of Huntington Circuit, Bro: Amos Foote was received, by the Conference, as a member on trial.

The Committee to take charge of the Zanesville difficulties, was named as follows Bro's W. H. Brewster, J. M. Smith, J. B. Hunt.

On recommendation of the Woodsfield Circuit, John Bartlett, was received on trial.

The President filled the Committee on Book-Concern, and Periodicals, -- ordered @ previous session, as follows A Crooks, S. D. Jones, H. Curtis.

George B. Smith, was received on trial by recommendation from Deersville Circuit.

The name of Bro: J. H. Webster was again called, when a letter from him was presented to the Conference by Bro. Evans Thompson, and read by the Secretary, representing that unless allowed some field near his present location; his circumstances were such that he could take no work from the Conference. His character was passed and name continued on the Stationed List.

(247) 1857

A letter was read by the secretary, from Geo. H. Reynolds making application to be received on trial – the application was dismissed.

Conference adjourned.

Friday morning 8 OClock A.M.

Bro: McCune Presiding

Roll called by the Secretary

Minutes read, corrected, and approved.

Devotional exercises conducted by Bro: Crooks.

The Chairman from the Committee on Sabbath Schools, read a highly interesting report, which was unanimously adopted: for which, See Report, No. 1 [Margin: Zanesville Case]

The Committee on Zanesville matters reported, which was adopted (See No 2.) when on motion of Bro: Evan Thompson a Committee of three was appointed to carry into effect the recommendations, of the Committee on Zanesville Case. Bro: Hamlin, Horton, Jones were that Committee.

Conference directed the Secretary to furnish Bro: Hamlin a copy of the Report of Committee (No. 2.) which was done.

By motion it was resolved that Conference held itself responsible to this Committee for expenses incurred in making their visit to Zanesville to adjudicate the church difficulty there, as directed by the Conference.

Bro: H. B. Knight, Agent of the Book-Concern was present and gave a statement

Of the financial condition of the Book-Concern.

[Margin: Proposed change of time]

Propositions for changing the usual time of holding our Conference were introduced and entertained by Bro. Hamlin and others. Various propositions looking to a change from fall to spring were discussed at length, when finally on motion of the Secretary, the time for holding our next session was fixed at August 25<sup>th</sup> 1858.

Mount Vernon was selected as the place for our next, yearly meet.

It was agreed that when we adjourn, we do so to meet at 3 P.M.

The Election of officers was made the order of the day, for this afternoon.

The usual announcements were made, and Conference adjourned.

Friday Afternoon – 3 P.M.

Conference met – President in the chair Singing and prayer by Bro: Evan Thompson.

Roll called, minutes read and approved.

The Report on Reforms was presented, and read by the Secretary, which lay on the table for future action.

[Margin: Reports]

Bro: Crooks, reported from the Committee on Missions, -- report was received, and read by the Secretary.

Committee on Book-Concern and Periodicals, reported; all of which lay on the table.

(249) 1857

[Margin: Officers Elected]

The order of the day was then taken up viz – the election of Officers for the ensuing Conference year. Bro's Sewell and Spear acting as tellars [sic]

Conference proceeded to ballot, which resulted in the choice of the following persons:

For President – Adam Crooks.

Secretary, Geo: W. Bainum.

The President, and Secretary of Conference were elected to the same offices in the Missionary Association.

W. H. Brewster was elected Treasurer of the Missionary Association.

A. N. Hamlin, E. Thompson, J. M. Smith, S. S. Wyeth and J. B. Hunt, were elected Board of Managers for the Missionary Association.

[Margin: Missionary Matters]

The Roll was called by the Secretary, and subscriptions and members to the Missionary Association received. In all amounting to \$107.20.

A Committee of three, was appointed to confer with Bro: Spear, to ascertain, and report the amount of his claims upon the Missionary Association; Hamlin, Sewell and Hodges were that Committee.

J. M. Smith presented the following resolution which was adopted.

"Resolved, That Bro: McCune be requested to cooperate with Bro: Crooks, our President, to secure some suitable minister for the Guilford N. C. Circuit, and recommend him to the American Missionary Association, as a missionary

For that field; to be sustained, by said Association."

[Margin: Missionary Matters]

The Treasurer of the Missionary Fund reported as follows:

Paid in to A Crooks 72.12 Collections 14.08 Paid today 16.00 \$107.20 Total Disbursements of the above To R. McCune 26.00 James Spear 56.00 Total Disbursed 82.00 Balance in Hand \$ 25.20

[Margin: Rept: of Examaining (sic) Com:]

The Examaining [sic] Committee, reported the names of Geo: C Hicks, M. B. Adams, and William Corner – as having been before them for examination, for admission to Elders Orders:

Bro: Hicks retired: And Bro: Brewster in behalf of the Committee reported favorably to the reception of Bro: Hicks to full connection, and election to the office of an Elder – which report was adopted – and Bro: Hicks was received accordingly.

Bro: Brewster reported further, in behalf of the Committee that the literary qualifications of Bro: M. B. Adams, were very fair: but [insert: that] in view of his inability to enter at once upon the work, in the travelling connection; and some lack of well digested views of theology; they could not advise his ordination, at present; but recommend that it be deferred untill [sic] another year. Which was adopted.

## (251) 1857

The Committee further reported; in reference to Bro: Wm Corner; that his views of the bible were consistent, and clear, but that in view of his advanced age, together with his want of literary qualifications; they could not advise his ordination; While they said this they left it now entirely to the voice of the Conference. Whereupon Bro: Horton, moved the Election of Bro: Corner to Elders Orders; which motion, after some discussion, was lost.

Conference adjourned By Benediction by the President.

Saturday Morning 8 Oclock

Bro: McCune presiding.

Devotional exercises were conducted by the Secretary: Roll called: Minutes of previous session read and approved.

Statistics were called for from the various Circuits and Stations resulting as follows: See Rep: No. 3.

[Margin: W. Corner elected an Elder]

Bro Hamlin moved a reconsideration of the vote adopting the report of Examaining [sic] Committee, in reference to Bro: Wm Corner: which motion prevailed. When on motion of Bro: E. Thompson, after discussion by Sewell, Hamlin and Horton, Bro: Corner was received to full connection, and Elected to the Office of an Elder, as an exception to the rule. His name was placed on the Unstationed List.

(252) 1857

[Margin: Reception of William McCullouch]

A communication was presented by Bro: Hamlin, from the Middle Port Church, in reference to the standing of Wm. McCullouch to licensed Local Preacher, who, according to the usage of the Primitive Methodists, (to which he formerly belonged) was alowed [sic] to administer the sacraments; but, who, under our Discipline [insert: it was thought] would not be alowed [sic] so to do: It was ordered that Bro. McCullouch be received by us according to his present standing, and that our President be authorized to examine the matter and if satisfied with his ordination, to issue to him a certificate of ordination. But, if, upon examination, his ordination appear not satisfactory, Bro: Crooks, our President will ordain him by the laying on of hands.

[Margin: Elders Unstationed]

The Roll of Unstationed Elders was called: and the following characters were examined and passed.

The character of Benj. Street was referred to the nearest Elder for investigation. Character of David Peachin passed and his name transferred to the Stationed List. Character of Isaac Moore was considered and passed.

The examination of character on the Stationed List was resumed:

The name of Wm. McConnell was called when it appeared that Bro: M had not always cooperated heartily with his brethren in carrying forward religious meetings. His character was passed; and Bro: Horton appointed, to exhort him to cooperation with his brethren.

Ordered that when we adjourn we do so to meet at 2 ½ Oclock P.M.

The Report on Book-Concern and Periodicals was taken from the table by consent; and Bro: Knight spoke to the report for some time; when by his request the Roll of Conference was called with a view to ascertain how many subscribers the members of Conference would try to obtain for the Wesleyan during the coming year 120 were pledged.

Various announcements were made and Conference adjourned. By limitation.

## Saturday Afternoon 2 ½ Oclock

Bro: McCune presiding.

Devotional exercises, conducted by Bro. Royce: Roll called by the Secretary. Minutes read and approved.

Committee on Wilson and North Carolinia [sic] case reported: which was received and adopted. See No. 4

[Margin: Reports]

Committee on Pastoral Relations and Boundaries, reported etc much as related to boundaries [insert: and salary of Evangelist] which was adopted. See No. 5

Committee, on Pastoral-relations, reported [insert: in full] which received and read after which it was amended, slightly, and adopted. See No: 6.

Committee further reported in reference the appointment, and salary of an Evangelist, See No: 5.

[Margin: Resolutions]

Bro: Jones offered the following resolution which was adopted.

Resolved, that Bro: Hamlin, the Conference Evangelist, be appointed general Agent of the Conference Missionary Association; to to [sic] procure subscriptions and donations and in every way to promote the interest of the cause.

The following was offered by Bro: Hamlin and adopted by the Conference: "Resolved, that the President be authorized to request, of the American Missionary Association, an appropriation for the Gallia and Laurence Mission, as soon as a suitable laborer is found to supply that work."

The report on Book-Concern and Periodicals was taken from the table and adopted. See No. 7.

The report on Reforms, was taken from the table and adopted. See No. 8. Report on Missions was adopted See No. 9.

(255) 1857

On motion of Bro: Tressonrider, three Committees were ordered: one on Missions, one on Sabbath Schools and one on Reforms: these Committees to report at the next Conference.

[Margin: Resolutions]

The following was adopted.

Resolved, that the President be and is hereby requested to deliver an opening sermon at our next Conference at the hour of ten OClock, A.M.

A vote of thanks was unanimously tendered to the citizens of Washington and vicinity for the ample amd [sic] pleasant entertainment received at their hands, during our stay among them.

Bro: Rice, of the Michigan Union College, was present and gave the Conference a somewhat entertaining and interesting account of the present condition of the above named Institution; concluding with an appeal for aid.

Conference [insert: adjourned] untill [sic] after preaching in the evening.

Saturday Evening 8 ½ Oclock A.M. [sic]

Bro: McCune presiding.

Bro: Jones offered a resolution, verbally, tendering an expression of sympathy, in the affairs of the Michigan Union College; which was adopted.

The President announced the following committees to report at next Conference On Reforms –

The Treasurer of the Sinking Fund, G. W. Bainum, reported, that there were yet \$320.97 due from us to the Parent Concern. That this obligation had lain long upon our hands and the Agent was now here, urging payment in view of the embarrassment of the Concern.

It was finally proposed to divide the amount into ten equal shares; and make personal pledges to pay the whole I one year from this date which was agreed to and the whole amount was pledged. The business of Conference being completed, the Conference kneeled, together with the attending congregation, the President leading in solemn prayer, and thanksgiving, to Almighty God, for the precious season which the Members of Conference had enjoyed together.

After which Conference adjourned: to meet in Mount Vernon Ohio Aug: 25 1858.

On Sabbath Schools – No. 1

The Committee, to whom was assigned the matter of Sabbath Schools, submit the following report:

Your Committee are deeply impressed with the importance of Sabbath schools in connection with [insert: all] our Churches. Familliarity [sic] with the truths of the Bible is indispensable to a well developed moral character, of an individual, or of a community. And it is equally indispensable that this knowledge be acquired in early life. Books of a doubtful character are being multiplied rapidly – and Bible reading – we fear, laid aside for light and trashy publications.

In a country like ours, where no parochial schools exist – where nothing positively religious can be taught in our publick [sic] schools, through a prejudice against sectarian doctrines; there is a greater demand for Sabbath School instruction than in those countries where parochial schools exist. are maintained.

No man, or community, can be said to be educated, that is not religiously educated; nor can that religious education be devolved entirely upon the pulpit; for the reason that pulpit instruction, cannot be sufficiently elementary to meet the wants of children, and at the same time meet the wants of the

Adult hearers. A faculty to preach the gospel to children profitably, is one of those rare gifts, which, though many covet earnestly, few possess. If, therefore, children are to be instructed at all, it must either – be in the sabbath school or in the family. And while Sabbath School instruction need not, we believe it will not lessen the amount of family teaching but increase it.

Where children attend these schools and have lessons assigned them, such lessons will naturally be studied during the week, and no parent who feels any religious

interests in his children, will but delight to aid them in the study of their lessons, and what sight more pleasing than to see the whole family around the "Old fashioned Bible that lays on the stand" carefully reading and studying the lesson for the coming Sabbath?

Here is a double gain, not only the children but the parents are lead [sic] to study the word of God.

And then we are to bear in mind that, in this community, may parents whole neglect the religious education of their children – not even attending public worship themselves – but at the same time they would not object to their children attending a good Sabbath School. And if there can be no other avenue to the parents' heart he may be reached through his child. Convince him that you are laboring to do good to his child, and you have his confidence – And above all let us remember that no period is so favorable to religious impressions as childhood. Almost all radial changes of character are confined to early life, before the habits become fixed and strong; and the heart hardened by frequent and long resistence [sic] to the

Influence of the Holy Spirit. Early impressions are the deepest and most lasting – impressing truth upon the plastice [sic] mind of a child, is like writing in the soft smooth bark of a sapling. A half a century afterward, you still read it in the rough bark of the michty [sic] "Oak of the forest deep rooted and firm."

We would lay it upon the heart of every minister, to heed the charge of Christ – "Feed my lambs" – Gather the dear children and youth on your charces [sic], into these schools – enlist the church in this work, exhort, preach, advise, aid in every way possible to promote this most important work.

And we call upon the brethren and sisters to aid their pastors to in establishing and maintaining these schools. We fear here is a great lack. Those who ought to be teachers are unwilling to become so, and thus embarrass their pastors. Others who should be in Bible Classes absent themselves. Such indifference we cannot justify or excuse. We lay these proposition down as axioms: --

All who know too much to be scholars should be teachers; and those who are not prepared to teach, should be scholars; if it be practicable to attend. By your love of public virtue, by your desire to see truth triumph, by your love to Christ we call upon you to espouse this cause at once; and let the reports that shall come up at our next Conference be such as to inspire confidence in our future success. Though this falls legitimately, to another committee, we cannot forbear to urge upon the patronage of our friends our Juvenile paper – now as it has always s been a deeply interesting childs [sic] publication.

## Report NO. 4

#### Wilson Case

Report of Committee on the cases of Daniel Wilson and Joseph Evens, and Guilford Circuit matters.

Your committee beg leave to report that they have perused all the papers in their possession, and find –

1<sup>st</sup> That there are various complaints against Bro: Wilson, mainly growing out of an unhappy strife between certain official members on the circuit, The truth or falsety [sic] of these charges or complaints, it is impossible for us, at our distance from the parties involved, to ascertain. It is evident from the papers before us, that hard speeches and ill tempers have been indulged in by the parties at variance, and that both parties greatly need, more of the spirit of conciliation, and forbearance.

We cannot find evidence to convict Bro: W. of any of the allegded [sic] faults, therefore we cannot recommend any action against him. From all we know personally, we are of opinion, that Bro: Wilson's course has not been as conciliatory as it should have been, nor do we think he carried out the wishes of Conference, in regard to brethren whom he now calls seceeders [sic] on that work. No 8 Report on Reforms The Committee on Reforms ask to present the following:

## On Slavery

Resolved, that all our former declarations of hatred and opposition to the system of Slavery, are by us now most emphatically reaffirmed. We still believe slavery to be evil, and only evil; opposed to the well-being of the enslaver as well as the enslaved; opposed to the prosperity of the nation, to the spread of the Christian religion, and to the salvation of men.

Resolved, that there is a one-ness of sentiment, on the subject of slavery among the Wesleyan M. Churches; that we have peace in all our borders, while other denominations are convulsed throughout, in consequence of this accursed system having a place within their pales.

Resolved, That we deeply sympathize with our beloved brother J. G. Gee, of Kentucky, in the recent outrages that have been committed upon his person; and shall most devoutly pray the God of Daniel to keep him from the power of the Enemies of truth and righteousness, while thus persuing [sic] his labors of love, in planting the Standard of the redeemer in that land of bondage.

Resolved, That the "Derd [sic] Scott decision" which declared that the "Negro has no rights that the white man is bound to respect," is a disgrace, and a burning shame to the Nations; at war with the Christian religion, strikes a blow at the rights of man, and should therefore be disregarded & conted [sic] by every lover of the Bible.

#### On Secret Societies

Resolved, That we will firmly maintain our disciplinary rule against the admission on retention in our churches of persons holding connection with Secret-Oath-Bound Societies. Resolved, That we believe the principle of secrecy as developed in the various secret organizations of the day; to be evil fraught with evil; dangerous to political purity, to national virtue, to the rights of man, to the cause of the oppressed millions of our land; and, above all, opposed to the spread of that "Light," which is the life of men.

## On Temperance

Resolved, That we are much as ever convinced of the great evil of the sale, and use of intoxicating drinks, as a beverage – and that we will oppose it in every reasonable and lawful manner. We will lecture, preach, pray, and vote against it, and will recommend all those over whom we may have an influence to forsake and eradicate this evil from our land.

#### On Peace

Resolved That as Christ is the prince of Peace – and as he has taught us in his word, the doctrine of a common Brotherhood; that all carnal war is anti-scriptural and anti-

Christian and that we will recommend to all our churches to love their neighbors as themselves.

## No. 9 Report on Missions

This success should encourage us to redoubled efforts. The times are propitious for the propagation of a reformatory religion.
