#### STANDING RULES

- !. The Conference Treasurer is authorized to close his books two weeks before the opening date of conference, therefore all receipts and monies should be in his hands by that time if credit on the statistical report is desired.
- 2. The President, after his fourth round of quarterly conferences, shall mail the delegates' credentials to the secretary who shall be the committee on credentials. It shall be his duty to prepare the roll before the conference begins.
  - 3. All persons introduced to the conference shall be given honorary seats with the right
- 4. The office expense of the President, Secretary, and the Treasurer shall be paid by the conference. Also all conference supplies shall be purchased by the conference.
- 5. The secretary and treasurer shall be paid twenty-five dollars per year for their services.
  - 6. The Conference Treasurer shall be bonded.
- 7. An abbreviated form of the pastor's statistical report shall be used for conference reading.
- 8. The Annual conference shall elect a Nominating Committee of five, of which one shall be the Conference President, to meet prior to the next annual session and nominate the working committees for the session.
- 9. The Conference President and the Board of Trustees shall constitute a Committee for the Building and Location of Churches and Parsonages.
- 10. Each pastor shall be allowed time out from his duties as pastor to hold two revivals each year if he so desires. The church he serves as pastor shall not withhold his salary while he is absent on such authorized revivals. In case any extra expense is involved in filling the pulpit while the pastor is engaged in such said revival such extra expense shall be paid by the church whose pastor is absent holding the revival.
- 11. All church records shall close the fifteenth day of June, and all statistical reports shall be sent to the Conference Treasurer by the 20th of June. After his approval, he shall mail them to the Committee on Statistics.
- 12. It is the duty of all the pastors to look after the insurance of the church and parsonage property. All insurance shall provide for fire, lightning, and tornado. If the church fails to do so upon reasonable effort by the pastor, the Conference President shall be notified and he shall take care of such business. A failure upon the part of the pastor shall be a censurable offense.
- 13. This conference asks that each pastor shall keep a file of his calling list and those connected with the church and Sunday School with names and addresses, the same to be kept for his own work and to be turned over to his successor.
- 14. Each pastor should seek to organize a new class or give his services in a revival meeting to a new or weaker church to help establish it. The church which he serves as pastor should grant him such privileges without censure with full remunerations of salary while in such meetings. The President must serve as co-ordinator and help arrange such meetings.
- 15. The Conference President shall be the Ashburn Camp Meeting President and Chairman of the Camp Meeting Committee, ex officio.

#### DAILY PROCEEDINGS Tuesday, July 7, 1959 - 9 A. M.

DEVOTIONS-The sixty-fourth Annual Session of the South Georgia Conference was called to order by the President, Rev. W. M. Phillippe, Jr. The song service was led by J L. Hilliard. A devotional from the Psalms was read by the President.

ROLL CALL-The roll of Elders and Conference Preachers was called. The Secretary, as the Committee on Credentials, called the roll of lay delegates.

CONFERENCE BAR-The Bar was set to include the first three rows of seats across the left side of the tabernacle and the platform.

HOURS OF CONFERENCE-The hours of conference were set as follows: to meet at 9 am until 12 noon, to meet again at 2 pm and adjourn by motion.

COMMITTEE ON NOMINATIONS-The report of this Committee was given and adopted. See report No. 1.

ORDERS OF THE DAY-A partial report of the Committee on Orders of the Day was given stating that a church extension service will be held Tuesday at 7:45 pm with Dr. H. K. Sheets as guest speaker; at 4:30 Tuesday P.M. a discussion of the proposed merger of the North and South Georgia Conferences will be held; Wednesday at 3:00 P.M. a Memorial Service will be held; from noon until 4:00 P.M. will be used for Committee Work, with business beginning again at 4 o'clock. This was adopted.

PRESIDENT'S REPORT-The vice-president, Rev. P. L. Swauger, presided while the report of the President was given and adopted with a rising vote of appreciation.

COURTESY COMMITTEE-The committee on courtesy presented Rev. Moore of the Baptist Church and Rev. Wall of the Methodist Church in Ashburn.

DR. SHEETS PRESIDES-The President asked Brother Sheets to preside.

Orders of the day-MERGER OF NORTH AND SOUTH GEORGIA CONFERENCES

APPROVED-Minutes of the joint committee meeting for the discussion of the merger of the North and South Georgia conferences were read by the president. After discussion, a motion was carried to take a vote by ballot. Twenty-nine votes were cast-17 in favor of merger and 12 opposed.

DELEGATE SEATED-E. C. Hord was seated as alternate delegate from Crossroads Charge. ELECTION OF OFFICERS CONTINUED-The following officers were elected by acclamation: Tithing Secretary-James Griffin; Wesleyan Men Secretary-P. L. Swauger. ADJOURNED.

#### Tuesday Night Service

CHURCH EXTENSION SERVICE-A church extension service was held, with Dr. H. K. Sheets speaking on the need of new churches throughout the United States. Pledges were taken for monthly payments on our Conference Pioneer Work amounting to \$90.00 per month. This will assist in the new church building to be built in Savannah, and the work at Darien.

#### Wednesday morning, July 8, 1959

DEVOTIONS-The song service was led by Rev. P. L. Swauger. A devotional was read by Okay Highsmith. Prayer was led by Rev. E. C. Moon.

OPENING-The President called the conference to order. The roll was called. The minutes

were read and approved.

ORDERS OF THE DAY-A partial report of the Orders of the Day Committee was adopted, stating that the Denominational Address be given at 11 o'clock; that the Presentation of the new constitution of the Wesleyan Methodist Church be at 2:05 P.M.; a Memorial service at 3 o'clock; the Educational address be at 7 o'clock by Dr. R. C. Mullinax; and a Missionary Service at 7:45 under the direction of the W. M. S.

Dr. Sheets stated that a copy of the new constitution was on hand for anyone to read

before the time for the Orders of the Day.

EDUCATION-The committee on Education gave a report which was adopted. See report No. 3.

PASTORAL RELATIONS COMMITTEE-This committee was excused for Committee work. Dr. Sheets was asked to preside.

SUNDAY SCHOOL SECRETARY'S REPORT-This report was given and adopted.

CHILD EVANGELISM-The report of the Secretary of Child Evangelism was given and adopted. (See report No. 4). A recommendation was passed that each person taking the course of study in Child Evangelism be asked to pay \$1.00 fee to help in postal expense of the Secretary.

CHARACTERS COMMITTEE-The Committee on Characters gave a report which was tabled. This action was recinded and a partial report given and adopted.

#### Report No. 2

#### CONFERENCE PRESIDENTS REPORT

To the members of this sixty-fourth annual session of the South Georgia Conference of the Wesleyan Methodist Church of American, greetings in the Name of our wonderful Saviour Jesus Christ.

Dear Brethern and Co-laborers in the work of our God and Church. I am sure each one has worked hard and has been looking forward for this great annual occasion. It is not only a time of wonderful fellowship, but of going before God to help carry out His plan and program.

Brethren, if we miss God's plan for us then we have missed it all. But if we are in His will we will be successful and glorify His cause and become blessed within our own souls. We are discovering that the duties are more and greater than ever before, but our God is able to help us through it all.

"For the time is come for thee to reap." Rev. 14: 15

To mark time is only destruction. Now is the time to move. No one ever made progress marking time. In this war against sin, the Bible says "resist the devil and he will flee from you." Now is the time to resist and get him on the run.

Present day conditions demand that it is time to move. Today the world is in great confusion. Who was right when Beecher threatened to call out the militia to stop Finney? Who was right when Pilate sent Christ to the cross?

This is the eternal question. Until this is answered correctly, there will be great confusion. I am not afraid of the confusion. I am afraid of the wrong.

Once again this old world is in great confusion. We are in a country that for years has been able to hold its head up above all others. But today it is about bankrupt, the dollar is worth less than fifty cents, and if we follow this program of inflation, it will kill the purchasing power of money until another quarter of a century the dollar will be less than twenty-five cents.

We are living in an age when we are controlled by labor racketeers, political plunderers

and subversive plotters, who may liquidate all hope of solvency in America.

America is festering with crime and immorality. I grant that this is the best nation in the world, but that is not good enough. Liquor, gambling, robbery, arson, murder, dope, and crimes too terrible to describe, is running wild and loose in America.

Now is the time for a great revival. If we do not pay the price for a Holy Ghost Revival

I am afraid we will soon be fighting for survival.

Today is God's time for a revival. The American people have tried everything to satisfy the needs of their soul except old fashion salvation. In their mad search, may God help us to lead them unto Him.

In my opinion, the revival that will set the world once again upon the right course will begin at Pentecost. I think it will add to the church such as shall be saved. I know that it must be the God of the Ages, and that Jesus Christ must be enthroned in mens' hearts as Redeemer. Saviour, and Lord.

The spiritual condition of your life demands that you move for God. We cannot please God by doing nothing. One passion of the pulpit and pew should be to witness of salvation from sin and hell. We must all be soul conscious. To gain everything else andlooseisalvation and eternal life, means failure. We must preach and work for a decision on this very matter. If men do not become converted then we have failed.

We must never surrender the gospel of redeeming grace and substitute the social gospel. It would be a deadly surrender. In fact, this has been the most deadly surrender that has resulted in the darkest apostasy that has settled over the evangelical Christianity within the past two centuries. There shall be a time when we shall no longer have an opportunity to witness. Red China has been closed to the gospel. In about another ten years Africa may be closed to the gospel. With the fight between Cumminism, Catholicism, and Protestantism, how long will we have true religious free-lom in America?

It is time for the church to move and reap as the fields are white unto harvest. Time is growing short.

If we are not making gains in the field that God has called us, then we are not worthy of the position given. Pastors, officers of the church, and Sunday School, are we making additions to our group? If not, it is time for you to make some moves for God. He has not failed you; how can you be content for failing Him? When we go month after month with no gains, we are doing just what the devil wants us to do.

#### Report No. 6

### PROPOSED TEXT FOR THE CONSTITUTION OF THE WESLEYAN METHODIST CHURCH OF AMERICA

#### Preamble

In order that we may wisely preserve and pass on to posterity the heritage of doctrine and principles of Christian living transmitted to us as evangelicals in the Arminian Wesleyan tradition, and to insure church order by sound principles of ecclesiastical polity, and to prepare the way for more effective cooperation with other branches of the Church of Christ in all that makes for the advancement of God's kingdom among men, we, the ministers and lay members of the Wesleyan Methodist Church of America meeting in official assemblies, do hereby ordain, establish, and set forth as the fundamental law, or constitution, of the Wesleyan Methodist Church of America the articles of religion, rules of Christian living, privileges and conditions of church membership, and articles of organization and government, here following.

#### Article 1. Name.

The name of this communion is the Wesleyan Methodist Church of America.

Article II. Articles of Religion.

(Same as in present Wesleyan Methodist Discipline.)

Article III. General Rules.

It is expected of those who are admitted to our churches that they should continue to evidence their desire of salvation:

First, by doing no harm-by avoiding evil of every kind, especially that which is most generally practiced, such as--

The taking of the name of God in vain.

The profaning of the day of the Lord, either by doing ordinary work therein, or by buying or selling.

Drunkeness, or the manufacturing, buying, selling or using intoxicating liquors, unless for mechanical, chemical, or medicinal purposes, or in any way intentionally and knowingly aiding others to do so.

The buying or selling of men, women, or children, with an intention to enslave them, or holding them as slaves, or claiming that it is right to do so.

The giving or taking things on usury, i.e. unlawful interest.

Fighting, quarreling, brawling, brother going to law with brother, returning evil for evil, or railing for railing. The using many words in buying or selling.

The buying or selling goods that have not paid the duty.

Uncharitable or unprofitable conversation.

Doing to others as we would not they should do unto us.

Doing what we know is not for the glory of God, as--

The putting on of gold and costly apparel.

The wearing of apparel which does not modestly and properly clothe the person.

The taking of such diversions as cannot be used in the name of the Lord Jesus.

The singing those songs or reading those books which do not tend to the knowledge or love of God.

Softness and needless self-indulgence.

Laying up treasure upon the earth.

Borrowing without a probability of paying, or taking up goods without a probability of paying for them.

It is expected of all who continue in these churches that they should continue to evidence their desire of salvation:

Secondly, by doing good, by being in every kind merciful after their power, as they have opportunity, doing good of every possible sort, and as far as possible to all men.

To their bodies, of the ability which God giveth, by giving food to the hungry, by clothing the naked, by visiting or helping them that are sick or in prison.

To their souls, by instructing, reproving or exhorting all we have any intercourse with, trampling under foot that enthusiastic that "we are not to do good unless our hearts be free to it."

By doing good, especially to them that are of the housefold of faith, or groaning so to be; employing them preferably to others, buying one of another, helping each other in business; and so much the more because the world will love its own, and them only.

By all possible diligence and frugality, that the gospel be not blamed, by running with patience the race which is set before them, denying themselves, and taking up their cross daily; submitting to bear the reproach of Christ, to be as the filth and offscouring of the world; and looking that men should say all manner of evil of them falsely for the Lord's sake.

It is expected of all who desire to continue in these churches that they should continue to evidence their desire of salvation:

Thirdly, by attending upon all the ordinances of God, such as:

The public worship of God.

The ministry of the Word either read or expounded.

The supper of the Lord.

Family and private praver.

Searching the Scriptures, and fasting or abstinence.

Further, by abstaining from membership in secret societies. We will on no account tolerate our ministers and members in joining or holding fellowship with Secret Societies, as, in the judgment of the Wesleyan Methodist Church, it is inconsistent with our duties to God to hold such relations.

"Jesus answered him, I spake openly to the world; I ever taught in the synagogue, and in the temple, whither the Jews always resort, and in secret have I said nothing.;; John 18:20. "Wherefore if they shall say unto you, Behold, He is in the desert; go not forth; Behold

He is in the secret chamber, believe it not.11 Mark- 24: 26.

"But above all things, my brethren, swear not, neither by heaven, neither by the earth, neither by any other oath; but let your yea be yea, and your nay, nay; lest ye fall into condemnation." James 5: 12.

Also see: Lev. 5:4,5; Isa. 29:15; Matt. 5: 34-36; 15:13; John 3:19,20; 2 Cor. 4: 1,2; and 6: 14-18; Eph. 5: 11,12; I John 4: 2,3.

(Note: This rule on secret societies does not prevent our members from affiliating with unions organized for the purpose of protecting their industrial interests where Christian principles are not violated, and where such principles are violated members shall be dealt with because of such violation, and not because of membership in the union.)

Further by abstaining from the use of tobacco. In the judgment of the Wesleyan Methodist Church the use of tobacco is a great evil, and unbecoming a Christian, and a waste of the Lord's money, and a defilement of the body, which should be the temple of the Holy Chost. We do, therefore, most earnestly require our members to refrain from its cultivation, manufacture, and sale, and to abstain from its use in all forms, for Jesus' sake.

We will not receive as members into our churches nor will we ordain or license to preach or extort, persons who use, cultivate, manufacture, or sell tobacco. Using tobacco by a member of a church or of an Annual Conference after being received from this dare (June 28, 1927) is a violation of the law of the church, and the offending party should be dealt with according to the Judiciary Rules.

Further, by observing the teachings of Scripture regarding marriage and divorce. We regard adultery as the only justifiable cause for divorce. In case of divorce for such cause the innocent party may marry again; but the guilty party has by his or her act forfeited membership in the church. In the case of divorce for other cause neither party shall be

permitted to marry again during the lifetime of the other, and violation of this law shall be punished by expulsion from the church (Matt. 5:32, Mark 10: 11, 12.) In the carrying out of these principles, guilt shall be established in accordance with judicial procedures set forth in the Discipline.

These are the General Rules of our churches; all of which we are taught of God to observe, even in His written Word, which is the only rule and the sufficient rule both of our faith and practice. And all these we know His Spirit writes on truly awakened hearts. If there be any among us who observe them not, who habitually break any of them, let it be known unto them who watch over that soul, as they who must give an account. We will admonish him of the error of his ways. We will bear with him for a season. But if then he repent not, he hath no more place among us; we have delivered our own souls.

Article IV. Elementary Principles.

- A. A Christian church is a society of believers in Jesus Christ, assembling in place for religious worship, and is of divine institution.
- B. Christ is the only head of the Church, and the Word of God, the only rule of faith and conduct.
- C. No person who loves the Lord Jesus Christ, and obeys the Gospel of God our Saviour, ought to be deprived of church membership.
- D. Every man has an inalienable right to private judgment in matters of religion, and an equal right to express his opinion in any way which will not violate the laws of God or the rights of his fellow men.
- E. All church trials should be conducted on Gospel principles only; and no ministerior member should be excommunicated except for immorality, the propagation of unchristian doctrines, or for neglect of duties enjoined by the Word of God.
- F. The pastoral or ministerial office and duties are of divine appointment; and all elders in the Church of God are equal, but ministers are forbidden to lord over God's heritage, or to have dominion over the faith of the saints.
- G. The Church has a right to form and enforce such rules and regulations only as are in accordance with the Holy Scriptures, and may be necessary or have a tendency to carry into effect the great system of practical Christianity.
- H. Whatever power may be necessary to the formation of rules and regulations is inherent in the ministers and members of the Church; but so much of that power may be delegated from time to time, upon a plan of representation, as they may judge necessary and proper.
- I. It is the duty of all ministers and members of the Church to maintain Godliness and to oppose all moral evil.
- J. It is obligatory upon ministers of the Gospel to be faithful in the discharge of their pastoral and ministerial duties; and it is also obligatory upon the members to esteem ministers highly for their work's sake, and to render them a righteous compensation for their labors.

#### Article V. Membership.

The privileges and conditions of full membership in the church are constitutional, and changes therein may be made only by constitutional enactment. The General Conference may at its own discretion establish categories of membership other than full membership. Nothing shall be included in the membership ritual that is contrary to the following definitions, conditions. and privileges of membership.

The conditions of full membership are:

- A. Confession of a personal experience in regeneration, and a pledge to seek diligently until sanctified wholly if that experience has not been attained.
  - B. Christian baptism.
- C. Acceptance of the Articles of Religion, the General Rules, the Elementary Principles, and the authority of the Discipline in matters of church government.
- D. A covenant to support the church, to live in fellowship with the members thereof, and to deek God's glory in all things.
- E. The approving vote of a majority of the members of the receiving church who are present and voting, provided that when objections are urged against the reception of a member, it shall require a vote of three fourths of those present and voting to receive.

The right of full Membership are:

- A. The fellowship of the saints and the encouragement, admonition, and spiritual guidnace of the ministry.
  - B. The access to the sacraments and ordinances of the church.
- C. The right to vote and the eligibility to hold any office for which a person in full membership is eligible, if not under discipline.
- D. The right to trial and appeal if charged with failure to maintain the conditions of membership, with the specific provision that joining another religious sect shall of itself sever membership in the church.

Church Membership may be terminated only by one of the following:

- A. Voluntary withdrawal.
- B. Joining another religious body or a secret order.
- C. Explusion after proper trial and conviction.
- n. Persistant neglect of church relationship as defined by the Discipline.

Article VI. The Ministry.

The General Conference shall from time to time enact provisions for the training, qualification, and ordination of the ministry. Every Wesleyan Methodist minister must be a member of some Wesleyan Methodist Church, and each elder must be a member of an annual conference. An elder is a minister of the Gospel fully invested with all the functions of the Christian ministry. The constitutional rights of ministers in the Wesleyan Methodist Church if not under discipline, shall include the following:

- Church if not under discipline, shall include the following:

  A. To preach the Gospel and in the case of ordained elders to administer baptism and the

  Lord's supper, to perform all parts of divine worship, and to solemnize the rite of matrimony.
- B. To be eligible, in the case of ordained elders, for election to any office in the church for which elders are eligible.
- C. To contract the pastoral relationship with local Wesleyan Methodist Churches, subject sub-sections 1,2 below.)
- D. To enjoy the use for religious meetings of the church building or buildings of the pastoral charge to which he has been appointed by the annual conference.
- E. To serve his assigned pastoral charge without interference by unauthorized activities of another minister of the Wesleyan Methodist Church.
- F. To transfer in the manner prescribed by the Discipline, from one annual conference to another, subject to reception by the annual conference to which he transfers.
- G. To have recourse, even if under Discipline, to a proper court of jurisdiction in any decision of such court.

Article VII. Organization and Government.

A. Pastoral Charges.

The members of the denomination shall be grouped into local churches, one or more of which shall constitute a pastoral charge. The following are the constitutional rights of each pastoral charge:

- 1. To receive and expel or discontinue menbers subject to the provisions of the Discipline. This right vests severally in each local church.
  - 2. To call its own pastor, subject to confirmation by the annual conference.
  - 3. To grant licenses to preach and exhort and take away the same.
  - 4. To recommend local preachers and special workers to the annual conference.
- 5. To elect its own officers and to remove the same for cause. No pastor or other official has any right to appoint an officer or declare an office vacant. This right belongs to the church alone, and vests severally in each local church.
- 6. To elect trustees and through such trustees to supervise, control, and maintain its property for the use and benefit of the ministry and members of the Wesleyan Methodist Church of America and subject to its regulations and appointments as from time to time legislated and declared. This right vests severally in each local church.
- 7. To be represented in the voting membership of its annual conference if not under discipline.
- 8. To have recourse to a proper court of jurisdiction in any matters of controversy between itself and other local conference or general units or agencies of the denomination. This right vests severally in each local church.
  - B. The Annual Conference.

The General Conference shall organize the work at large into annual conferences, which shall operate its jurisdiction and promote the interests of the denomination, whose voting membership shall include the following: All elders on the stationed, reserve, and superannuated lists; all conference preachers elected to elders' orders: all conference preachers serving as pastors of organized Wesleyan Methodist Churches; lay delegates elected by organized Wesleyan Methodist Churches as provided in the Discipline. In addition the annual conference shall include such non-voting members as the Discipline shall provide. The principle of equal representation of the ministry and the laity in the annual conference sessions shall be maintained.

In transacting the business of the annual conference the ministers and lay members shall deliberate as one body; but on the final vote on any question, at the call of one fourth of the members, the house shall divide, and the ministers and lay members shall vote separately; and it shall require a majority vote of each branch to pass any question upon which the division has been called.

The constitutional rights of each annual conference shall include the following:

- 1. The right to take charge of all the ministers and churches within its bounds except such of the general officers of theachurch as the General Conference shall define( who shall be amenable to the Board of Administration for their official conduct and to their annual conferences for their moral character), and subject to the right of the ministers and churches to enter into pastoral engagements for one year from the next session of the annual conference,, or to contract the pastoral relationship at any time during the interval of the sessions of the annual conference when this does not interrupt any arrangement which was sanctioned by the annual conference at its previous session.
- 2. To alter the agreement entered into by any pastor and charge when it deems this to be for the best interest of the charge or pastor involved or when the general interest of the conference work would be better served by such a change, provided that any such alteration of a previous arrangement between a pastor and church shall be separately reported and passed by the vote of the conference to be effective.
- 3. To elect and ordain elders, and to receive elders from other denominations subject to the restrictions of the Discipline.
- 4. To receive or decline local preachers and special workers recommended to it by the pastoral charges within its bounds.
- 5. To organize and receive local churches within the boundaries of the territory assigned to it by the General Conference, and to fix the boundaries of its circuits and stations.
- 6. To take such actions and adopt such rules as it shall judge necessary to promote the interests and prosperity of the church and to amend or rescind the same, provided it shall not contravene any provision of the constitution or of the Discipline, and provided further that if three members of an annual conference shall take exception to its action on the ground that it violates this restriction, they may make an appeal there from through the channels prescribed by the Discipline.
  - 7. To elect its own officers as outlined in the Discipline, and to dismiss for cause.
- 8. To elect in the manner prescribed by the Discipline its own board of trustees and through them to receive, hold, encumber, and dispose of all local church and conference property within the bounds of the conference, according to the provisions of the Discipline and the laws of the state. All properties held by the annual conference shall be held in trust for the use and benefit of the ministry and members of the Wesleyan Methodist Church of America and subject to its regulations and appointments as from time to time legislated and declared.
- 9. To be represented in the lay and the ministerial voting membership of the General Conference, if not under discipline.
- 10. To have recourse to a proper court of jurisdiction in any matters of controversy between itself and other conference, local, or general units or agencies of the denomination.
  - C. General Conference Membership.

The General Conference shall be composed of an equal number of elders and laymen elected by the several annual conference, and of such general conference officials as the General Conference may establish by legislation, provided that it shall at the same time enact provisions to secure such further representation as shall be necessary to continue the principle of equal lay and ministerial membership.

- D. General Conference Delegates.
- 1. Each annual conference, if not under discipline, shall be entitled to send one elder and one layman as delegates to the General Conference and additional ministerial and lay delegates according to membership on a basis of representation to be fixed by General Conference.
- 2. The delegates shall be elected by ballot. The ministerial delegates must be elders, and at the time of their election, as also at the time of General Conference, must be members of the Annual Conference which elected them
- 3. The lay delegates shall be chosen from the members of the church in full relation within the bounds of the annual conference they represent, and at the time of the General Conference they must be members of a church within the bounds of the annual conference which elected them.

- E. General Conference Sessions.
- 1. The General Conference shall meet quadrennially on a date specified by the Discipline and at such place as shall have been determined by the preceding General Conference. However, in case of emergency the Board of Administration shall have power to change both time and place of the General Conference.
- 2. The President or other elected officer of the General Conference, whenever two thirds of the annual conferences shall request it, or the Board of Administration, by such vote as the General Conference shall determine, shall call an extra session of the General Conference, fixing the place thereof and the time of assembly later than the next ensuing session of each annual conference.
  - F. Presidency of the General Conference.

The General Conference shall elect by ballot one or more traveling elders to the work of general superintendency, to which office it may assign any suitable title, and the same shall preside at the various sittings of the General Conference in such order as these may determine; but in case no general superintendent be present, the General Conference shall elect by ballot an elder as president pro tem. A general superintendent's term shall begin on the date determined by the General Conference.

G. Other Officers.

The General Conference shall elect by ballot a secretary and such other officers as it shall decide upon.

H. Board of Administration.

- 1. There shall be a Board of Administration to carry out the will of the General Conference during the quadrennium. Such board shall be made up of the general superintendents, and an equal number of elders and laymen chosen by the General Conference to represent equitably the several administrative areas of the church. The number of the representative members of the Board of Administration shall be set by the General Conference. In addition to the foregoing, the General Conference shall have power to assign ex officio membership on the Board of Administration to such elected officials as it shall deem advisable.
- 2. The Board of Administration shall have general supervision of all the activities of the church during the intervals of the General Conference, and shall constitute or create the basic board of control of each and all of the Wesleyan Methodist societies and institutions now incorporated or hereafter incorporated under the laws of any state of the United States or of any province of Canada or under any other jurisdiction where such is permitted by the laws of said jurisdiction.

I. General Conference Quorum.

At all times when the General Conference is in session, it shall require a majority of all the delegates elected by the annual conference to form a quorum to do business, but a smaller number may adjourn from time to time, until a quorum is obtained.

J. General Conference Voting.

The ministers and lay members shall deliberate in the sessions of the General Conference as one body, but upon the final vote on any question except proposed amendments to the constitution, on a call of one fourth of the members, the house shall divide and ministers and lay members shall vote separately; and it shall require a majority vote of each branch to pass any question upon which the division has been called.

Article VIII. Powers and Restrictions of General Conference.

The General Conference shall have power to designate a criterion for parliamentary procedure for itself and for the other bodies of the Wesleyan Methodist Church. The General Conference shall have full power to elect its officers and the general officials of the church and to define their duties and responsibilities, and to make and administer rules and regulations for the Wesleyan Methodist Church of America subject to the constitution and the following restrictions:

- 1. It shall not have power to revoke, alter, or change our Articles of Religion, Elementary Principles, or any General Rule or the conditions of membership, or to establish any standards of doctrine contrary to our present existing and established standards of doctrine.
- 2. It shall not change or alter any part of our government, so as to destroy the principle of equal representation of ministers and laymen in the representative bodies of the church; or to do away with the right of each General Conference to elect its own officers, or the maintenance of an itinerant ministry.

- 3. It shall make no rule that shall deny any church the right to receive, discontinue or expel its own members subject to their right of appeal; or to elect and remove its own officers; or that shall deny to preachers and churches initial negotiations concerning the same.
- 4. It shall make no rule that will discriminate against any member or minister on account of ancestry or color. This shall not be interpreted to encourage racial intermarriage.
- 5. It shall make no rule that will interfere with the supervision of established annual conferences (in distinction from mission conferences) over the ministers and churches within their bounds, except those ministers whom the General Conference makes amendable to itself because of election to the work of the general church.
- 6. It shall not have the power to deprive any member or minister of the right of trial by an impartial committee, or of the right of appeal.

Article IX. The Supreme Judiciary.

- 1. There shall be a judicial council to be known as the Board of Review whose number of members, qualifications, terms of office, and method of election shall be determined by the General Conference.
  - 2. The Board of Review shall have authority:
    - a. To determine the constitutionality of any act of the General Conference upon appeal of the General Superintendents, or one-fifth the members of the General Conference.
    - b. To hear and determine any appeal from the decisions of the general superintendents as to the constitutionality of an action by an annual conference or upon a point of church law.
    - c. To hear and determine the legality of any action by any general church board upon appeal of one-third the members thereof, or by request of the general superintendents.
    - d. To settle questions in dispute between annual conferences upon appeal by a two-thirds vote of a conference that claims it has a grievance against another conference.
    - To determine the validity of any complaints against books used in the course of study or in our schools.
- 3. A decision of the Board of Review shall be final unless the General Conference votes to overrule the same by a two-thirds vote of those present and voting.

  Article X. Amendments to the Constitution.

Upon the recommendation of a two-thirds majority of all the members of the several annual conference who shall be present and vote on a proposed change of any matter involving the Constitution and upon concurrent recommendation of a two-thirds majority of all the members of the local churches who shall be present and vote on the same, the next ensuing General Conference may by a two-thirds majority vote ratify the same and it shall become constitutional law. Also when the General Conference shall originate and recommend by a two-thirds majority vote any such change, as soon as a two-thirds majority of the members of the several annual conferences and a two-third majority of all the members of the churches present and voting shall have concurred, then the same shall be declared constitutional law.

The following Brethren, having passed at least two books this year, are recommended to continue to study and travel under the direction of the conference: G. E. Akridge, R. N. Cooley, James Griffin, J. L. Hilliard, H. J. Lewis, W. H. Morris, and Robert Wagon.

We further recommend that Joseph G. Phillippe study in college under the direction of conference; that Mrs. H. J. Lewis, as an elder on trial, pass the examination on Wesleyan Methodist Church History; that Mitchell A. Walker begin to study and travel under the direction of the conference.
