The Alabama Conference of the Wesleyan Methodist Connection (or Church) of America convened in its twenty-third annual session at Tusca-caloosa, Alabama, 9:00 a.m. Wednesday, October Nineteenth, Nineteen hundred thirty-two.

The opening sermon was preached Tuesday evening at 7:30 by the Rev. T. P. Baker, Home Missionary Secretary, using as text, Isaiah 54:5.

His message was very timely and fitting.

The first business meeting was called at 9:00 a.m. Wednesday by the President, R. E. Snipes. After song and prayer service the president spoke for a few minutes, using for a basis of his message, 1 Cor. 16:9, reviewing the doctrines of the church, its fundamental teachings and opportunities for its future progress.

The president invited Rev. T. P. Baker to preside as chairman of the

conference.

Roll called and twelve Elders and licentiates answered the roll call. A Committee on Credentials, J. M. Kemp and C. E. Myers, were appointed. Credentials were read and thirteen delegates enrolled.

By motion the conference bar was fixed to include each side and four

seats in front of the pulpit.

The President read his annual report, which was adopted as read. See report No. 1.

elected a Committee on Nominations. Recessed for committee work.

Called to order by the chairman. The Committee on Nominations

RESOLUTIONS-No. 3

We, your Committee on Resolutions, beg to submit the following report:

We purpose by the Grace of God, as ministers according to the gift of Christ, to walk worthy of the calling wherewith we are called. We resolve to stand against the popular evils of the day, especially such as are

catalogued below.

Racketeering and exploitation for greed, gain, gambling in any form, bribery, profanity, dissipation in any form. We do greatly deplore the sex-laxity, and lawlessness of the present day and age, therefore, Be it resolved, that both the laity and ministry of the Alabama Conference of the Wesleyan Methodist Connection use every means within their power to check the unparalleled spread of infidelity between husbands and wives, disloyalty between children and parents, and curb the undisciplined tem-

peraments of growing children and young people.

Believing the legislative program enacted by and pending before the Alabama State Legislature to be positively detrimental to the moral and spiritual welfare of our young people and a blot upon the fair name of our State. Be it resolved by the Alabama Annual Conference of the Wesleyan Methodist Connection assembled in executive session at Tuscaloosa, Ala., this the 21st day of October, 1932, that we go on record as uncompromisingly opposed to the legislation legalizing Race-Track gambling in Mobile County of our State, making legal the sale of near beer products, and the removal of restrictions safeguarding the Sabbath and other Christian institutions. Be it further resolved, that this body by vote register its emphatic protest against any attempt to repeal or weaken the dry laws supporting the Eighteenth Amendment in the State.

Be it further resolved, that all members of our local churches, when transferring their membership from one church to another, either pay their Connectional and Conference claims and assignments before transferring, or carry their assignments, or any unpaid part to the church to which they are transferring. Further, it is understood this resolution is effective

immediately.

Since our Discipline provides for a period of twelve months probation for ministers coming to us from other denominations, Be it resolved, That the President and his advisory board are hereby instructed to add any part or fractional part of the year just preceding the sitting of an annual conference to the period of probation as provided for in Article No. 171, Section 8 of the Wesleyan Methodist Discipline.

FINANCES-No. 4

We, your Committee on Finance beg to submit the following report: We recommend the following budget per member—Home Missions, 50c; Foreign Missions, \$2.50; Education, \$1.25; Orphanage, 25c; Conference work, 15c; Superannuated Minister's Fund, 10c; President's Salary, 85c.

We recommend that the president hold the first and fourth quarterly meetings and that his salary be paid in four equal quarterly payments. The time not spent by the president in holding the quarterly meetings is to be occupied by him in missionary and evangelistic work within the bounds of the conference, as approved by the missionary board and the advisory board. All receipts in evangelistic work to be retained by the president as additional salary.

We also recommend that each pastor collect the president's salary each quarter, and also collect the remaining part of his back salary.

MORAL REFORM-No. 5

We, your Committee on Moral Reform, beg to make the following

report:

We believe that the standard of holy living which was preached and practiced by our venerable father Wesley was the standard of Christianity found in the Bible, espoused and promulgated by the Apostles of our Lord Jesus Christ.

The preaching and living of that standard both in the days of the apostles and in the early days of Methodism was accompanied with Divine

power and glory.

We feel that there has been a decline of power and glory in some parts of our beloved Church and we attribute the cause to a departure—in some measure—from those precepts and practices which were so signally honored of God in the conversion of sinners and the sanctification of believers, as well as in the abounding joy and victory which characterized our saintly forefathers.

If we are to enjoy the presence and power of the Holy Ghost in this day as in former days, there are some reforms, which will be necessary for us to make even though to many they appear but trifles. Surely we can count nothing a trifle that cripples our influence or hinders the power and glory of God from visiting us as He wants us to have it.

We would call your attention first to the matter of dress. We have a standard laid down in the Bible and also in our Discipline relative to this subject, and it is not the standard of the world. The standard for our sisters and mothers is a modest apparel. Plain dress, a plainness which will publicly commit them to the maintainance of their Christian profession wherever they may he. Dress, in which the strictest economy has been used.

For the women of the world Dame Fashion decreed, a few years ago, that nudity should be the order of the day, hence the low-neck, sleeveless and knee-high dress.

With the aid of the Church and its ministry public sentiment became so strong in opposition to this style that Dame Fashion brought forth another style of dress which, while satisfactory as to length, has such a degree of transparency about it as to manifest that same mania for nudity which characterizes the fashions of lewd Paris and licentious Hollywood.

We are convinced that the so-called attractiveness of young women by the use of cosmetics and the immodest dress is one of the prime causes of the inflamed lust of wicked men resulting in kidnapping and the filling of brothels.

We therefore call upon our Wesleyan mothers and daughters to dress in harmony with the standards laid down in the Bible and our book of discipline, and which is, modestly, plainly and economically regardless of what the world may say.

We would call attention to the amount of money, time and labor expended by many of the young people in our churches for permanent waves, water waves, curls and kinks put in their hair, all of which is un-Wesleyan and savors rather of the world than of Christianity, inasmuch as it is a species of pride or vanity.

For what is the object of it? The answer, when truly given is, "to improve my appearance, or to make more attractive." Attractive to whom? To God? To Angels? To Saints? The truth is that this is a custom of the world, and amongst many of the world's young women, underlying it or accompanying it is a strong sex appeal.

We would, therefore, lovingly but seriously admonish our young people especially the active members of our W. Y. P. S., to strive to be admired rather for their Godliness and Christian virtues than for their physical appearance, then increasing that influence for God and the church, and avoiding unfriendly criticism.

Although we are passing through a period of financial depression we feel that quite a little money is being spent, by Wesleyans, for luxuries and needless self-indulgences, that ought to be helping to save souls. It seems to be a rule, with some people, though a disgraceful one, to purchase every thing they desire for themselves before they think of the needs of the church, consequently their pastor is robbed of a portion of his salary, the church is robbed of its running expenses, and worst of all debts are incurred, that sometimes are never paid, thus bringing reproach on the church.

We believe that one tenth of our income is the lowest possible amount that God requires for the support of church interests, and that every wage earner, and all who have an income, are under obligation to lay aside one-tenth of such income for church interests, particularly ministerial support. Under the Old Testament law the Jews paid two-tenths, the first of which was appropriated to the support of the ministering Levites, the priests. In New Testament times, it is generally conceded that the Christians gave more freely of their substance than did the ancient Jews. In view of these facts we recommend, First—That the subject of Church Finance as found in our Book of Discipline be read to the local churches, by the pastors, at least twice a year, emphasizing the necessity and duty of tithing in order to produce true loyalty to the church and the best Christian experience. Second—That where it is practicable, a weekly or semi-monthly envelope system shall be adopted by the local churches for the tithes, and that they shall be placed in the local church treasury to be distributed or disbursed in accordance with the storehouse plan. Third—That each pastor shall secure, as soon as possible after conference a sufficient number of copies of "The Storehouse Plan" pamphlet to furnish each member a copy for his perusal.

In the early days of American Methodism one of its chief attractions was its singing. At the meetings of Phillip Embury and Barbara Heck in New York spectators came in crowds, attracted by their singing. churches had their music and their hymns, but not the crowds. What made the difference? Methodist hymns were not only pleasing to the ear, but being saturated with the gospel of the atoning and cleansing blood, they

touched the heart and helped to fasten conviction upon the soul.

Not only did they sing the hymns, but the preachers, 'gave out', the hymns; recited them as carefully and sacredly as though they were divinely inspired, and why? Not because of the esteem in which they hold their

authors but because of the 'gospel of the atoning blood' in poetry.

We deplore the fact today that many of our modern songs are composed by men of various denominations, including Russellites, and contain little more than sentiment about mother, home and Heaven, set to tunes that are light and jazzy and which rather hinder than help true spiritual worship by producing revelry and a shuffling of the feet in imitation of dancing. We believe that no modern hymns have surpassed those of the Wesleys and their contemporaries for sound doctrinal content and spiritual power.

We recommend therefore, and urge that, in the selection of song books, our churches shall discriminate against those that contain light, jazzy and sentimental songs, and choose such as contain the expressions of sound doctrines and a healthful Christian experience, and which tend to move the heart to a holy joy or melt it in penitence and contrition rather than move the feet to dancing that God may be glorified in all our

singing.
