## Conference Resolutions

- 1. All Statistical reports shall be filed with the Statistical Committee no later than the close of the Tuesday morning meeting, and any pastor who fails to do so shall explain his reason publicly on the floor of the Conference.
- 2. Pastors shall equalize the amounts required for Budget before overreaching any one item, and it shall be the pastor's duty to inform his people at the beginning of the year concerning the amount to be raised and he shall at once proceed to raise the amount assessed his charge.
- 3. Inasmuch as the work of the Conference demands the attention and attendance of all its Elders and Licentiates, therefore we will not employ as pastor or evangelist any Elder or Licentiate or pass the character of any Elder or Licentiate except by vote, who does not attend the entire session of Conference. The Committee on Pastoral Relations shall not give employment to any preacher who does not meet the requirements of this standing rule, without bringing his excuse before the Conference for its action in the matter.
- 4. Any minister accepting work on a charge at the hands of this Conference who resigns or abandons it before the year is out without a good excuse or lawful reason, shall be considered by said Conference and it shall take a vote of Conference to pass his character.
- 5. Inasmuch as the work of the Conference demands the attendance of Delegates as well as preachers, therefore we discourage the election of any person as Delegate to Conference who does not intend to attend the entire session. Information of the Delegate's intentions shall be incorporated in their credentials.
- 6. We recommend that each church pay travelling expenses, board and room of Delegates and Pastor at Conference.
- 7. The Secretary shall prepare blanks for Delegate's Credentials, including the statement required by Resolution No. 5. Said blanks are to include the address of the Delegate and the address and telephone number of the pastor. The blanks are to be mailed to the pastors shortly before Conference, and when filled out by them are to be sent to the standing Committee on Credentials, in order that it may report immediately after the opening of the Conference. Said Committee on Credentials shall be appointed by the President.
- 8. The Secretary shall send a statistical blank to the clerk of each charge having no pastor, requiring that the same be filled out with all available statistics and return to the Conference Secretary.
  - 9. For the future the Conference shall observe the disciplinary rule

requiring each pastor to read his statistical report on the floor of the Conference, but that to expedite business he shall read only: item 1; the first 3 lines of item 2; of item 3 the number last year and the present number; in item 4 the total number in the main school and the average attendance. He shall omit item 5 and read items 6 and 8. He shall read totals only for items 7, 9, and 10.

- 10. Friday preceding Conference shall be set aside as a day of prayer for the Conference.
- 11. Robert's Rules of Order shall be the Parliamentary guide of this body.
- 12. The Special Orders of the Conference shall be: Monday evening, a communion service; Tuesday evening, Educational service; Wednesday afternoon, one hour each to Tithing Secretary and the Sunday-school Secretary; Wednesday evening, W. Y. P. S. Rally; Thursday evening, Missionary service under the W. H. & F. M. S.
- 13. We authorize the closing of the Conference Treasurer's and the Camp Meeting Treasurer's books one week before Conference.
- 14. We recommend that pastors, Sunday schools, W. H. & F. M. Societies and Y. M. W. Bands remit all funds at least quarterly.
- 15. Pastors shall preach on the subject of church benevolences at least once each year.
- 16. We understand Paragraph 51 in the Discipline to require that no one be received into membership of our local churches unless they have left off the wearing of gold including the wedding ring. Be it further Resolved, That Paragraph 52 regarding plain apparel be strictly adhered to.
- 17. Be it required that all pastors of the Ohio Conference attend all sessions of the Camp Meeting unless providentially hindered.
- 18. All charges receiving a new pastor pay the moving expenses, the amount being agreed upon by the pastor and the church.
- 19. We order that no money be paid from the Conference Missionary Fund except by written order of the Missionary Board.
- 21. Each occupant of the dormitory during Conference is to furnish his own bed linen and towels.
- 22. The new churches shall be assessed 25 per cent the first year; 50 per cent the second year; and full Budget the third year.
- 23. Be it required that all our workers, preachers and singers on the platform at Conference and Camp Meeting, wear sleeves at least to the elbows, and all their apparel in accord with the Discipline.
- 24. We recommend that each church grant their pastor a two Sundays leave of absence with pay; at which time he will work under the direction of the Conference Missionary Board in a pioneer evangelistic

campaign, both time and place to be chosen by that Board.

- 25. We shall have a travelling Conference President who shall receive \$1,800.00 annually, which shall be apportioned to the churches and paid by them to the Conference Treasurer, who shall on the first of each month beginning with August 1, each Conference year forward a check for one twelfth of the amount to him. He shall be required to travel the Conference and counsel and advise with the churches in matters of doctrine, finance and other affairs that effect the spiritual and temporal welfare of the work. After consulting with the pastors, he may confer with the stewards if necessary with the purpose in mind to increase the pastor's salary. He shall hold at least two quarterly meetings on each charge annually, the slate to be arranged by the President and published in the Wesleyan Methodist. Each charge shall have at least one Sunday service each quarterly meeting except where other satisfactory arrangements can be made by the President with the pastor.
- 26. Inasmuch as it is necessary for both pastor and Conference President to arrange their program for the year, be it required that the President, at the Annual Conference prepare his slate for six months in advance, and post the same on the Conference bulletin board, as a guide for the pastors in arranging their programs for the Conference year.
- 27. All persons having business with the Committee on Itineracy and Orders shall appear before said committee not later than the second day of Conference; and each candidate taking the course of study shall appear before some member of the Committee or some person appointed by them to take his examinations; also all examination papers shall be in the hands of the Examiner not later than July 10.
- 28. We recommend that all our pastors make special effort to inform all local preachers on their charges of the disciplinary requirements needed preparatory to study and to travel under Annual Conference direction.
- 29. Our pastors shall urge each family in the church to set aside at least one can of fruit, vegetables, meat, and pickles to be send to the seat of Conference and Camp Meeting, for use there.
- 30. We recommend that the churches in the Ohio Conference receive all members or candidates for membership, as associate or probationary except those coming in by letter of transfer, and that we strictly adhere to the disciplinary requirements in receiving them.
- 31. In order to assist the local church in meeting all its financial obligations, we recommend a study of the discipline relating to finance and that the duties of all officers of the church be explained. We recommend the adoption and use of the Storehouse Plan as outlined in the discipline. We recommend that a Donation Steward be elected by the church to provide a regular donation for the pastor, at least quarterly and monthly if possible; that the church be requested to provide a do-

nation for the Conference President at the time of his visit to the church. We recommend that the Board of Stewards ascertain the financial condition of the church from the Treasurer and communicate the same at least quarterly to all non-resident and non-attending members, urging their support. We recommend that the church elect a secretary to provide tracts and information on tithing to its constituency. An offering shall be taken at least annually which shall be used to provide a tract box and suitable tracts, especially those of our own publication, on tithing, holiness, regeneration, etc. We recommend that each pastor transfer his membership to the church he is serving. We recommend that a definite agreement regarding pastor's salary be entered into within 2 weeks after Conference, through the local Board of Stewards, which shall stand until time of the First Quarterly Conference, providing no plan was agreed upon at the time of his employment. At the First Quarterly meeting an agreement shall be made for the balance of the Conference year. We recommend that the salary of the pastor shall include the two weeks of Conference and Camp Meeting; the tenur of the pastor's labors beginning the week following Camp Meeting.

- 32. We shall have a Camp Meeting Committee consisting of 5 members, 3 ministerial and 2 lay, elected by the Annual Conference, to have entire supervision of the Campgrounds and its improvements and the making of complete arrangements for camp and Camp Meeting services, and also provide for the entertainment of the Annual Conference. One ministerial member of this Committee shall be designated as Chairman by the Conference, annually at its regular session. That the ministerial members shall serve for a period of 3 years and the lay members for 2 years, except when first elected the ministerial members shall be elected for 3 years, 2 years, and 1 year, respectively, and lay members for 2 years and 1 year respectively. That this Committee shall designate one of its own members as Treasurer, and another as Secretary. That the Treasurer and the Secretary shall both report to the Annual Conference and the report be incorporated in the Conference Minutes. The Treasurer's Report shall also be audited. We further recommend that this Camp Meeting Committee advise with the Conference Board of Trustees as to the location, erection, and improvement of Conference buildings on the Campground.
- 33. The fourth Monday in July shall be the permanent date for the opening of Conference; the Camp Meeting to follow.
- 34. The Conference Missionary Board shall hereafter be elected by ballot.
- 35. To further Church Extension we reccommend that the pledge plan be continued, but that the President appoint a Secretary-Treasurer who shall take the responsibility of administering the same. He shall secure pledges and the payment of them shall be made to him, after the new building project have been approved by Conference President and

Trustees. (Not to exceed three appeals in one year.) He shall notify those who have made pledges, also the pastors who are building may write a personal letter to the pastors of the Conference, asking them to take an offering and send it to the Secretary-Treasurer of this fund, who in turn will forward it to pastor or the Building Committee. Expenses of printing cards and mailing to be paid from the Conference Incidental Fund.

- 36. We recommend that the Treasurer's and Sunday School Treasurer's books of the several churches be audited annually.
- 37. Hereafter the Ohio Conference shall be authorized to charge 4% on loans from the Superannuated Elders' Fund; all others to draw 2%. (Any notes for loans on the Conference Treasury shall from now on be drawn up on the form in the 1940 Minutes.)
- 38. We recommend a standard traveling expense of .04 a mile to the Conference Board of Trustees, Missionary Board, and Camp Meeting Committee, to be paid from the Conference Incidental Fund, the Conference Missions Fund and the Camp Meeting Treasury, respectively.
- 39. We will not pass the character, except by vote, on any pastor who fails to send in his quarterly Sunday School report.
- 40. All money raised on Educational Budget must henceforth pass through the Conference Treasury.
- 41. The travelling expenses of the Conference Prsident shall be guaranteed him from the Conference Incidental Fund, at the rate of .04 a mile for automobile travel, and actual train and bus fare; also that his desk expense and all long distance telephone bills pertaining to his conference work be paid from the same fund.
- 42. The Conference shall elect by ballot from a list of nominees, submitted by the pastoral Relations Committee, a Conference Missionary Scretary, who shall work with and under the direction of the Missionary Board. He shall be employed for a period of 7 months and not to exceed 8 months, at a salary of \$125 a month plus travel expense, desk expense, and long distance telephone calls involved in the work of pioneer evangelism. He shall be paid from Conference Missions Funds. In the balance of his time he shall be allowed to engage in evangelistic work. His duties shall be to travel the Conference and raise money for Conference Missions, to have supervision of the pioneer works, to investigate opening for new work and report same to the Missionary Board, and to hold revival meetings at pioneer points as necessity may demand.

## Reports

#### Report No. 1

REPORT OF THE CONFERENCE PRESIDENT TO THE THIRTY-SEVENTH ANNUAL SESSION OF THE OHIO CONFERENCE

We call the Conference to join with us today in gratitude and praise to God for His blessings which have marked our way throughout the months past since we last met on Victory Camp Ground. The year has not been without its problems. In fact, in many ways, they have been peculiarly difficult and unusually numerous this year. But God has been good to us, has over-ruled the difficulties, has given increase to the work and blessing to the workers. It seems to us that the work of the Conference is in perhaps the best state it has ever been. Good gains have been made during the year in several ways; in number of churches, in the launching and progress of pioneer projects, in local revivals, and in the general spiritual tone and condition of the work of the conference as a whole. The prospects for the future look bright. Opportunities for further advance abound on every hand. God has been blessing and we confidently look for a continuation and an increase of that blessing. This does not mean that there are no problems remaining to be solved; nor does it mean that there are no situation capable of betterment. It does recognize the help which God has thus far given, and the help which He will continue to give as we meet the qualifications. It is our conviction that a future rich with blessing lies just before us. If we maintain the attitude of utter dependence on God and look to Him for whatever increase may come our way; If we maintain the emphasis upon the distinctive tenet of Wesleyanism, Scriptural, secondblessing holiness; if we maintain our margins of safety from all that would undermine spiritual life or obviate our testimony to holiness of heart; if we keep our hearts hot with the love of God and filled with compassion over the condition of lost men; that future of rich blessing shall be ours.

I have continued throughout the year in the work assigned me by the last annual conference. We have contacted all the churches through quarterly meetings, special visits, and correspondence, endeavoring to the best of our ability to encourage and further the work in each locality. This has required travel amounting to a little more than 9000 miles, not including local travel involved in the work of the conference. Approximate traveling expense is \$228. In addition to this, the extra press of duties this spring made it necessary for us to ask the Vice-President for some help. He consented to assist with the fourth quarterly meetings, and accordingly has made trips in recent weeks to Zanesville, Senecaville and Clark's School, and to Northridge, Burns Ave., and

Piqua. These trips covered approximately 600 miles. I have received from the conference treasurer the sum of \$1800 salary, also cash gifts, fees, donations etc., amounting to \$404.39.

#### Pastoral Appointments

The churches left in the hands of the President have been cared for as follows;

Coshocton was supplied by Harry Stanley until early October when Melvin Mitchell was appointed pastor.

On Aug. 11, West Dayton chose Walter Jeffries as their pastor. I sanctioned the choice and appointed him as pastor.

Zanesville was supplied by G. W. Morse for a few weeks following last conference. The church was unable to come to a conclusion regarding the calling of a new man, and on Sept. 29 they waived their right to select a pastor and asked the President and Advisory Board to appoint. On Oct. 2, D. T. Mullings was appointed pastor.

On June 15 I received the resignation of Paul Robinson as pastor at Piqua. The work has since been supplied locally.

One church has been disbanded during the year. The work at Southwest Sharon has for some time been falling off. An attempt was made to revive it by a special meeting. But we were unable to secure a pastor at the proper time and services have been discontinued.

To offset this loss, there have been three new churches received into the conference.

July 14 a new class was organized at Chillicothe. This came from a group of independent holiness people, pastored by Bro. Bond. Early this month they decided to become Wesleyan and the organization was effected on the date given above. Total membership to date is 19.

Another group of people at Nelsonville requested the Conference for admission as a Wesleyan Methodist church. On July 22 this class was organized with a membership at that service of 13. More are expected to be received soon.

The third new church came from a pioneer work at Oakfield, which was begun a little over a year ago. Splendid progress has been made and on July 23 a church was organized with 28 members.

#### Membership of the Conference

On Aug. 29, I received the transfer of Elder Edward Angell from the Indiana Conference.

On Sept. 23 I granted a certificate of reception to A. E. Halbert on

reception of his credentials from the Annual Council of the Churches of Christ in Christian Union. This is a temporary certificate to be replaced by regular credentials on the completion of certain requirements made by the Committee on Itineracy and Orders.

On Sept. 29, G. W. Morse surrendered his credentials of ordination.

On Jan. 6, D. T. Mullings was granted a certificate of reception as an ordained elder on letter of standing from the Christian and Missionary Alliance.

On Jan. 18, A. L. Vess was received as an elder by letter of standing from the South Carolina Conference.

May 6, I received a certificate of character for Joe Daniel Keller, from the Free Methodist District Superintendent, G. A. Hall of Zanesville, Ohio. Bro. Keller was an ordained deacon and as such is to be received as a conference preacher of the Wesleyan Methodist Church. His standing in the Free Methodist course of study is shown on pages 216, 217, 218 of the Free Methodist Conference Minutes of 1943.

June 23, Paul Robinson voluntarily surrendered all credentials of ministerial standing in the Wesleyan Methodist Church.

This makes a loss of two ministerial members during the year, offset by a gain of five.

Walter McKee and Evart Bond having met all conditions stipulated by the Committee on Itineracy and Orders, I recommend that they be received by the Confernce as ordained elders.

#### Report No. 2

#### REPORT OF THE MISSIONARY BOARD

Time in its unaltered course has again closed the door of another. Conference year behind us; and as we come to this time of statistical reckoning for the year just past, we bow our heads in humble thanksgiving and adoring praise to Him from whom all blessings flow and from whom we have received the literal fulfillment of that promise, "He is able to do exceedingly, abundantly, above all—". The victories are yours and ours; let us rejoice together.

Our constant aim in the work with which you have entrusted us as a Board, has been to accomplish the most possible for God and the salvation of souls, with the means, the workers, and the opportunities which have come our way. The year past has witnessed some revision in our plans. The common method heretofore employed has been found-

ed on the premise that one pioneer evangelistic meeting, whether in tent or building, should produce a church, or at least the beginnings of a church. The obvious result has been to put everything into that one meeting, and if it succeeded, to organize a church; but if it did not succeed, to withdraw from the field. Experience has taught us the fallacy of this type of procedure. One meeting does not always produce a church. Nor does such failure necessarily indicate that further effort in that field is impossible or impracticable. Furthermore the old system was subject to a serious crisis in the shift from evangelistic workers to pastor at the close of the meeting. Sometimes the work has been too weak to stand such a change, sometimes the contrast between workers has been too great, and sometimes, even, no suitable pastor was obtainable at all. Any of these circumstances meant the complete wreck, or the serious injury of the new work.

Accordingly we are revising our approach to the problem of pioneer work. This does not mean that the old method should be abandoned altogether. We still employ it where practicable. But we are supplementing it with a new type of program built around a pastor, rather than around an evangelistic party. The new-type of approach demands a longer-range program. It is begun with the idea of permanence and may even necessitate the purchase of property prior to the organization of a church. This necessitates more careful choosing of sites, greater care in the selection of workers, larger investment in every way. But as a Board we are convinced it will yield more substantial churches, and while it may temporarily appear slower, it will in reality produce the greatest lasting growth of our work.

The work which has come directly under our supervision includes four churches which were placed under the direction of the Missionary Board by the last Annual Conference. We report on them as follows:

- 1. Allen's Chapel. The work here has lost its most dependable support either to the army, or to the war industries, and hence is at low ebb.
- 2. Empire. Allen Baker has continued as pastor throughout the year. It has suffered various discouragements, particularly through evangelists cancelling meetings, or being hindered by sickness from completing a campaign once begun. But finally in recent weeks, the Sisk party was engaged for a meeting which has produced good results and much brightened prospects.
- 3. Riverside. Mrs. Fred Shockley has continued in charge of the work and is reporting its statistics.
- 4. Southwest Sharon. A good revival was held last fall and the work showed good promise. But the former pastor resigned and we were unable to secure a new one at that time. Consequently the work has had to be closed.

As regards the mission points under our care, we submit the following brief summaries of the work. For details we refer you to the statistical reports of the various pastors.

Hammondsville and Dresden have both been discontinued due to lack of a worker to care for the services at these places.

Clark's School. This work developed from a meeting held last fall by Bro. Blankenbicker. A good group of people, definitely interested in Wesleyan work, are meeting together under the leadership of Bro. Stickle. This is a country point a few miles from Ava.

Columbus. This has been our major project of the year, because we felt the great importance of a good church in the capital of the state. Immediately after Conference of last year plans were made for entering this field. A hall was rented, and thru the cooperation of the Conference Trustees and the assistance of the Young People's Societies a parsonage was purchased, the monthly payments being cared for by the Y. P. Societies of the Conference. We greatly appreciate the splendid way in which they have helped in this project. Claude Scott was employed as pastor and has been on the field ever since early September when the first services were held. We believe this new project shows good promise for the future. Definite results are being accomplished and the local people are already assuming a large share of the financial load of the church.

Fairmount. This mission point in Cincinnati has remained under the oversight of Bro. Zuch. Services have been carried on by a group of workers from the Bible School. In spite of great devotion to the work, the response has been small.

Holliday's Cove. This is another of our very promising prospects. At the beginning of the year we were left without a worker. We finally arranged with Bro. Haines to go over for a time to supervise and take care of the work. After a few weeks on the field, Bro. Harry Ward, came as pastor and has remained ever since. In recent weeks he has been able to give full time to the work of the pastorate. It has also seemed expedient to move the location from Holliday's Cove to near-by Weirton Heights where by increased attendance and interest the work gives a better promise for the future.

Nelsonville. Contacts have been maintained here throughout the year. And finally just before conference the group in this city pastored by Bro. Bond made application for admission to the Ohio Conference as a Wesleyan church.

Oakfield. This new work has prospered greatly under the pastoral oversight of Bro. Bond. Early in the year a definite mission organization was effected, culminating in the organization of a church on the last Sunday of the Conference year.

Paden City. This work continued under the direction of Harry Kastle until Nov. when it seemed wise to send Bro. and Sister Gladstone Woodhouse as full time workers. This place appears to be one of our best prospects for the future. Definite spiritual work has been manifst and the financial increase has been very satisfactory.

Springfield. Contacts have been maintained with the group pastored by Bro. Haerr in this city, but there has been no further development.

We now have immediate prospect of a new work in Utica, Ohio. Three or four families there are definitely interested in Wesleyan work and a meeting has already been planned to begin soon after conference.

Financially the Ohio Conference has caught the vision of Pioneer Evangelism by responding to our appeal last fall far in excess of our expectations. The Board had set as a goal the sum of \$3000.00 which seemed to us the minimum requirement for proper conduct of the work. You responded with a pledge of \$3850.00 of which \$3400.00 has been paid to date. This amount represents a total of \$1400.00 in excess of that raised last year and nearly four times the amount raised two years ago.

The expenditures of the year have totaled \$3432.00. This breaks down as follows: We have expended around \$1700.00 at Columbus plus the \$420.00 paid by the Young Peoples Societies on the parsonage and a \$100.00 gift for the same purpose. At Paden City we have spent \$875.00. At Weirton, \$350.00. At Empire, \$100.00. At Fairmont, \$67.00. At Sharon, \$92.00, and for travel and miscellaneous, \$150.00.

With our change of emphasis a larger number of full time workers have been employed. We wish to report to you the guarantees we made these men. Rev. Claude O. Scott has been in our employ throughout the year at Columbus with a salary of \$98.00 per month plus parsonage. In recent months the local congregation has assumed nearly all this salary. At Paden City Rev. Gladstone Woodhouse has been our worker since December with a guarantee of \$91.00 per month plus parsonage rent. In May Rev. H. E. Ward became our full time worker at Weirton Heights at a salary of \$96.00.

If the Conference continues to stand back of the pioneer program as splendidly as they have done for the past twelve months, we should be able to take another advance step this year, either in the form of closer supervision of the work, or in the form of an entrance into another large city with a program similar to that adopted in Columbus a year ago.

May God grant His Grace for a greater and more glorious future under His leadership.

Wheelrim, Ky.: Piqua, Westerville, Cincinnati, Marion, Toronto.

We recommend that each society send feed sacks to Mother Wilcox as soon as possible after Conference. She needs them to cover pillow ticks.

We also recommend that each society bring at least one towel rack to conference next year for use in the dormitories.

We recommend that the following societies bring dish towels and hot pads: Fargo, Africa, Harrison, Jelloway, Greer, Sunbury, Dunkirk, West Dayton, Chippewa Lake, Osage, Rittman, and Toronto.

The following societies are to bring water pitchers and glasses: Athens, Cincinnati Vine St., Coshocton, Dayton (Belmont), Dayton (Northridge), Fairview, Findlay, George's Run, Kenton, Marion, Piqua, Westervile, West View, Zanesville, Columbus, and Senecaville.
