Rev G. L. Paine Chairman of the committee in the interests of

Mr. President,

Your Committee in

the interests of Towanda Church property beg leave to report.
In making our report to this
body one year ago, the question was raised by Brother Marshall
Frink with regard to the title; he having the impression that property
was made over to the W. M. Connection, and therefore the title was
in them.
On this statement brother Frink was placed on your Committee, to
associate with the same with power to go to the bottom of things, &
find out in whom the title was resting, When the time came that we
should go and do the work, Brother Frink wrote me he could not
leave then, as he had a Quarterly meeting to attend, and therefore
would delegate all his

power to the former Committee.

Your Committee went to Towanda, and with the help of the Recorder
spent a part of two days in looking over the Books of Deeds, and
found that The First Wesleyan Methodist Church of Towanda, was
not known nor never had been known in said Books as a title owner.
– But found June 1st 1860, recorded in Book as title owner page 171.
That Solomon Cooper bought of D. M. Bull a certain parcel of land in
the center of the town as it now stands, and paid for it with the
Church's money, and took the deed in his own name, as at that time
The First Wesleyan Methodist Church of Towanda was not
incorporated.

We then searched the record for three hours to find where Solomon
Cooper deeded the said land to the First Wesleyan Methodist Church
of Towanda. We looked in vain: but we found in Book of Deeds Page
246. March 5, 1866 where Solomon Cooper had for a consideration,
deeded this said property to C. S. Ward, and there it rested.

Having satisfied myself how the Records were touching the property, I went and took counsel of Lazer Sanderson who had defended the church all through with out fee, He said "it did not make any difference who had the deed, it was only a deed of trust; for the Church's money paid for it, and therefore all that Solomon Cooper

could transfer was what he had, All that Mr Ward had was a deed of trust, and Mr Ward knowing how it was never made any trouble about it. Thus the matter stands All of which is submitted
