Daily Proceedings

Tuesday Evening, July 9, 1983

The 121st Annual Session of the Champlain Annual Conference of The Wesleyan Methodist Church of America convened on the West Chazy Campground, West Chazy, New York on July 9, 1963 at 7:00 p.m. The Conference was called to order by the President, Rev. Charles A. Dayton.

The Roll was called and twenty-one (21) Elders with twenty-two (22) laymen responded.

Rev. Edwin Seaman, Vice President of the Conference, led the devotional period. Bro. John Lamos led us in singing "I Know Whom I Have Believed." Rev. Floyd Tyler read I Cor. 13. We were led in prayer by Rev. George D. Jock.

Conference President's Report: Rev. Charles Dayton was introduced and presented his annual report, a resume of his official acts, and a listing of the Committees appointed by the President. With the exception of a recommendation that we have a Campmeeting Budget Item which was referred to the Campmeeting Committee, this report was adopted. (See reports)

Orders of the Day: The President read the Conference Agenda. Voted that on Wednesday at 3:30 p.m. we have as an Order of the Day a report from the Champlain Conference Delegates to General Conference.

Conference President's Address: The W.M.S. and W.Y. gathered in the tabernacle at 8:00 p. m. to hear the Conference President's Address.

The congregation sang "Living By Faith."

As Rev. Seaman introduced President Charles A. Dayton, the Conference Body stood in token of respect.

Reading from Exodus 13:16-14:14, Brother Dayton spoke to us of the leadings of the Lord, and those who are led. At the conclusion of his message, the congregation came to the front and were led in prayer by Dr. H. K. Sheets.

Recess: Voted to recess.

Wednesday Forenoon, July 10, 1963

The Roll was called at 8:30 a.m.

Devotions: Rev. C. C. Murray was the devotional leader. Rev. Jesse Russell led us in singing "I Will Praise Him." Bro. Edwin Seaman offered prayer. Bro. Murray read from Psalm 87 commenting upon the words "All My Springs Are In Thee."

The Minutes of the Tuesday Evening Meeting were read and approved.

The Committee on Courtesy presented Dr. H. K. Sheets, General Superintendent of the Wesleyan Methodist Church who brought us words of greeting and remarked upon "What Does It Mean To Be A Wesleyan."

Order of the Day: The Report of the Conference Treasurer. Rev. Otto Finch gave his report and it was adopted. (See reports)

Passage of Character: During the forenoon session the characters of the following persons were passed: Otto Finch, George Jock, Hazel Perry, Diana F. Miller, Russell Frase, L. C. Mattoon.

Order of the Day: Report of the Conference Director of Wesleyan Men: Rev. John Lamos reported the organization of one Wesleyan Men's group at the Mooers charge. The pastor spoke concerning its formation. Dr. Hollis Stevenson, Denominational Director of Wesleyan Men, challenged us concerning the importance of this vital laymen's organization. The report was adopted.

Committee on Itineracy and Elders Orders: Dr. Hollis Stevenson, because of other committee responsibilities, resigned from the Committee on Itineracy and Elders Orders. Isabelle Riggs was elected to take his place on this committee.

Prepared Ballot: It was voted that the Nominating Committee supply a prepared ballot for the election of Conference Officers and Committees.

Order of the Day: Report of the W.M.S. President. Mrs. Josephine Dayton gave her report and it was adopted. (See report in W.M.S. Minutes.)

Order of the Day: Report of the Statistical Committee. Rev. Charles McCallum, Statistician, gave his report. It was moved that the report be adopted. The motion was amended to include the signature of the Auditor of Statistics upon the report. The motion with its amendment was carried. (See reports)

Order of the Day: Report of the Conference Missions Treasurer. Rev. Aldis Lamos gave his report and it was adopted.

The Committee on Courtesy presented Dr. Willard G. Smith, Business Manager of Houghton College. He brought words of greeting.

Recess: Voted to recess for committee work.

Dismissal by Rev. Howard Chapman.

Wednesday Afternoon, July 10, 1963

The Roll was called at 1:30 p.m.

Devotions: Rev William Knecht led the devotional period. We sang "Leaning On The Everlasting Arms." Bro. Knecht read from Jn. 15:1-15. Rev. A. O. Northrup offered prayer.

The Minutes of the Wednesday forenoon session were read and approved.

The Nominating Committee gave the first reading of its report for information.

Passage of Character: During the afternoon session the characters of the following persons were passed. Maurice Jesmer, John Lamos, C. Lawrence Hill, Leland Boring, Clifton Chapman, Everett Elliott, Fenton Harvey, Harry Johnson, James Keysor, Gerald Matson, Wilbur Matson, Charles McCallum, A. O. Northrup, Sr., Florence Northrup, Kenneth Ross, Edwin Seaman, Aldis Lamos, Charles Dayton, Ralph Seaman, Hervey Taber.

Order of the Day: Report of the Campmeeting Treasurer. Mrs. Betty LaPlante gave her report. It was adopted. (See reports)

Campmeeting Budget: A report was submitted by the Campmeeting Committee as follows: "The Campmeeting Committee met at noon, seven (7) members being pressent, and unanimously approved the recommendation of our President, Rev. C. A. Dayton, that we as a Conference adopt a budget item of \$2.00 per member to be known as 'Campmeeting Advance.' — Kenneth Ross, Secretary' Voted to adopt the report.

Order of the Day: Educational Service. Rev. C. L. Hill, Conference Educational Secretary, introduced Dr. Willard G. Smith, Business Manager of Houghton College. Speaking of the history, purpose and character of the educational work of the Church, Houghton in particular, he cited a number of things about Houghton College indicative of its progress, and its mission. Dr. H. K. Sheets presented information regarding the Wesleyan Seminary Foundation, and its importance to the Wesleyan Methodist Church.

Order of the Day: Report of Delegates to General Conference. Rev. Howard Chapman gave us some of the highlights of the 1963 General Conference of the Wesleyan Methodist Church. Dr. Sheets and President Dayton with Brother Chapman freely answered questions from the members of the Conference Body.

Recessed: Dissmassal by Mrs. Bowden.

Thursday Forenoon, July 11, 1953

The Roll was called at 8:45 a.m.

Devotions: Rev. A. O. Northrup, Sr. had charge of the devotional period. Rev. Florence Northrup led us in singing "O Happy Day." Bro. Northrup read to us from Acts 2:1-7 commenting upon the importance and meaning of the Church, and closed with prayer.

Delegate: Voted that Mrs. Grant of the Chichester charge be seated as delegate for Rev. Harris Earl.

Following a period of testimonies and announcements by the Conference President, Dr. H. K. Sheets was asked to assume the Chair and preside over the Conference Elections.

The Roll was called to determine that there were eighty-six (86) voting members present.

Tellers: The Conference President appointed Rev. Everett Elliott and Rev. Reginald Hewitt as tellers.

Voting: The Conference Body proceeded to vote using a prepared ballot.

Assistant Treasurer: It was voted that there be created the office of Assistant Conference Treasurer.

Postponement: Voted that the Order of the day be postponed until 10:20 a.m. Sunday School Board: Voted that the nominations upon the ballot for members of the Sunday School Board not be voted upon at this time; such election to take place on Thursday Afternoon.

District Chairmen: District Chairmen were elected by acclamation as follows: Southern District: Rev. Reginald Hewitt; Central District: Rev. Everett Elliott; St. Lawrence District: Rev. Floyd Tyler; Northern District: Rev. Aldis Lamos.

Canvass of Ballots: Gerald Ralph and Royal Mattoon were appointed by the President to assist in the Canvassing of the ballots. The report of the election will be given at a later time.

Order of the Day: Superannuated Ministers' Relief Association Meeting. (For a report of the business transacted during this session, please see reports.)

Extension of Time: Voted that there be an extension of time until the completion of the Superannuated Ministers' Relief Association Business.

Recessed by limitation of time.

Thursday Afternoon, July 11, 1963

The Roll was called at 1:30 p.m.

Special Music: The Trumpet Trio played "A Mighty Fortress Is Our God."

Order of the Day: Denominational Address. Dr. H. K. Sheets, General Superintendent of the Wesleyan Methodist Church, challenged us to salute the Church; its place, nature, image and mission in the world. "The Church is God's Agency in the World." Speaking of the events of General Conference he called our attention to a theme and year by year accent for the new quadrennium. REPORT OF THE CONFERENCE PRESIDENT

To the members of the Champlain Conference — Greetings: It is our pleasure under God to submit our report to the 121st Annual Session of the Champlain Annual Conference:

Our gracious Heavenly Father has given us the privilege of laboring together with Him as a unit for — lo, these 120 years as a Conference. We have the distinction of being one of the very first Annual Conferences of the Wesleyan Methodist Church. While the scenes have changed many times in this century plus, and very often in the last score of years, the greatest days of our church can be just ahead.

There are millions and millions of men, women, boys, and girls within our reach who are without God and without hope. The Lord commands, "Go ye, and preach the Gospel to every creature." Pray ye the Lord of the harvest to send forth reapers." It is not a soothing fact to know that there are many great cities and areas where Wesleyan Methodism is unknown; and our gospel is either forgotten or ignored by over twenty million people.

We have a job much greater than we are; but we need not be discouraged, for He has said, "My grace is sufficient for thee." Let us give ourselves fully into the hands of the Holy Spirit who will produce power from weakness, and perform miracles that will astonish the world and convince mankind.

God has given the Conference a new church group which was organized this year. Though the number composing the new church at Crescent is not large, we give them a hearty welcome as "workers together."

There have been emergencies this Conference year when it looked very dark for some of our churches and their future. We join in praise to God that a way was opened up to save the situations. It seemed quite necessary in the estimation of those who were acquainted with the situation at Springfield that the president should go to Springfield and serve as pastor for the last six months of the Conference year. This action was also urgently requested by the local church. With the concurrence of his Advisoy Board the move was made. (By the way, the moving cost neither the Conference nor the local church anything at all.) Although it is freely admitted that neither the duties of the pastorate nor the presidency were fulfilled as they should have been, yet the day was saved. Praise God!

Just a word about General Conference! It was a pleasure for your delegates to represent you at that great gathering of our church. Also, our Conference can be pleased with the quality of representation which these delegates gave.

Concerning the West Chazy President's Home and the West Chazy Campgrounds, for several years it has appeared necessary due to the pressure of growth and health consideration that we have a new dining hall, kitchen, etc. This proposition imposed too great responsibility until the fire last year pushed us into a building program. Through the very devoted labors and consecrated giving of God's people we have today a well planned dining hall and kitchen with good refrigeration and fair facilities. This has been done with an indebtedness of no more than \$7000.00 at any time, including the present.

The Youth Tabernacle which ordinarily cares for our Youth activity has had to be used this year to sleep our young men. Thus, we must have some place constructed for a boy's dorm very soon. These problems are serious, but not insurmountible. The maintenance and preservation of our expanding buildings and facilities are no small proportion. We can meet these items and use them to the glory of God.

Your president wishes to close this report with the proposal of one resolution; namely, that the Champlain Conference give the opportunity to its constituency of perpetuating the ministry of the West Chazy camp meeting by placing an item in the Conference budget to be called Camp Meeting Advance in the amount of \$2.00 for each full member of the Conference.

- 8. Pioneer Church Assistance —Gouverneur receive \$50 per month to be paid on its indebtedness; Plattsburgh, Elizabeth St. receive \$150 in July and \$50 per month thereafter this year; Crescent receive \$91.27 per month to be paid on its indebtedness; Hopewell Junction receive \$25 per month to be paid on its indebtedness.

Churches in need — Macomb receive \$100 this year to apply on its indebtedness; Give Colton Church dollar for dollar toward liquidation of its debt.

Due to an offer having been made by an anonymous friend, the Conference and the friend will give Ticonderoga Church \$50 each toward painting their church if the church will give \$50 and apply the paint.

REPORT OF THE SUNDAY SCHOOL SECRETARY

To the 121st Session of the Champlain Annual Conference of the Wesleyan Methodist Church: Greetings!

Brethren, I count it a joy to address this body in that the Lord has counted me worthy, putting me into the ministry. I am grateful for a number of things in the capacity of Sunday School Secretary:

1st - My hearty thanks is extended to all who have stood by so loyally and cooperated so faithfully in the great work of the Sunday School during this past year.

2nd - I do appreciate the members of the Sunday School Board who have given excellent cooperation in planning, counseling and making suggestions for a more efficient operation of the Conference Sunday School Department. It is our desire that this Department be a service organization useful to each local Sunday School.

3rd - I am grateful for the fine delegation at the church-wide and NSSA Conventions in Denver last October. We had eight persons attending from our Conference and these cooperated in conducting Workshops at the District Rallies held later. We also enjoyed the ministry and fellowship of Rev. Don Kinde at these Rallies.

4th - I wish to congratulate the Conference on winning top honors in our group

in the recent Denominational WETT contest. My personal appreciation is extended to Sister Dayton who labored so faithfully in teaching these courses and also to the pastors who pushed the program. Our new church at Crescent earned 22 credit cards, while one of our oldest churches, Brookdale with a membership of nine came up with 12 cards or 133 percent of their membership.

This year has also its darker side for due to sickness, bad weather conditions, etc. our average attendance stands at 2461 as compared with 2481 last year. While some schools registered downward trends others showed increases. Congratulations to Heuvelton on wining the Plaque for the highest percentage gain in average attendance with a 25% increase. Let us continue to promote our Leadership Training Program and also to build lives for the Kingdom of God through the Sunday School

We have a great opportunity afforded us in that the Board of Administration has approved the Sunday School Department as the recipient of the Thanksgiving Offering in 1963. One-half of the amount of the offering from each Conference is to be used by the General Department to finance Conventions in each Conference while the other half is to be returned to the respective conferences from which it came to be used in a project designated by the Sunday School Board. Your Conference Board has decided to establish a Film Library to be made available to the local Sunday Schools with our share of this offering. Let us make this a great offering.

It is our desire to have each Sunday School submit the name of the person whom they believe should be chosen as Sunday School Teacher of the Year for the Conference to the Conference Sunday School Secretary and that the reasons for the choice accompany the nomination. These entries to be judged by a panel of judges composed of the Conference President, the Woman's Missionary President and the WY President.

For the coming year we recommend the following:

1. That the Conference Sunday School Budget be continued at 10 cents per member in the main school.

- 2. That the committee on religious services establish Friday night of Conference week as Sunday School Night.
- 3. That, if possible, each Sunday School send a representative to the NSSA Convention in Buffalo in October.
 - 4. That we hold District Rallies with Workshops.
- 5. That workshops for Vacation Bible School Directors be held in each District in the early spring of 1964.

That a Sunday School Chairman for each District be elected to act as Sunday School news reporter for the Challenger, to have the oversight of arranging for District Rallics and otherwise assist the Secretary in promoting the work in his District.

Dr. Paul Kindschi and the General Department have established the following goals for the Quadrennium:

- 1. A 10% gain in attendance.
- 2. A new Sunday School every 20 days.
- 3. An Advisory Council in the field one for every 20 churches.
- 4. Regular ratings by the Standard of Achievement.
- 5. Promotion of CYC.
- 6. Use of Sunday School Quiz (SQ) by local officers, these available from the Department

REPORT OF COMMITTEE ON RESOLUTIONS

The Committee on Resolutions prayerfully submit the following resolutions for the consideration and action of the Champlain Conference in session this 11th day of July, 1963.

BE IT RESOLVED THAT:

- 1. Since the American Cancer Society and American Heart Association have revealed that cancer and heart ailments are both closely associated with cigarette smoking; and since the Safety Council of the American Automobile Association declare that from 40% to 60% of deaths on the highways are attributed to drinking, we wish to enter our protest to those in authority against using young men and women as tools to promote the beer and cigarette business on television for our young people not yet in their teens to watch. We suggest that all Wesleyans send in protests to our congressmen as well as to the Broadcasting Companies.
- 2. Believing that Juvenile Delinquency can be attributed in part to the poor discipline now maintained in many of our schools and homes; BE IT RESOLVED that we will do all in our power to fulfill the primary need of our children for someone strong enough to lean upon, realizing that when that need is unfulfilled, no amount of patience and argument is likely to compensate for it. And further that we return to the belief that there are life-long rewards from self-discipline.

Believing that broken homes, parental neglect, un-Christian character, unholy example, lack of love, lack of a sense of security, bad environment, over indulgent parents, ignorance and poverty all contribute to and aggravate the problems of young people. BE IT FURTHER KESOLVED, that we as a conference shall seek, by every God-directed agency and means at our disposal, to train the parents to in turn, Train, Teach and Discipline their own children that they might become future, citizens, worthy of the responsibilities and the glorious Heritage of a God-fearing Nation.

- 3. BE IT FURTHER RESOLVED: that we are opposed to the appointment of an Ambassador or Representative to the Vatican. And that we stand opposed to any official visit of the President of the United States, which shall include any jesture that could in any way signify obedience or obeisance to the elected leader of any nation or state. These we hold to be essential to the continued separation of Church and State, the dignity of our great Nation and as a safeguard against any foreign entanglements, which could snatch away our FREEDOM and God-given Liberty.
- 4. Whereas we recognize the need for greater unity and better understanding in the home, which could well be the greatest weapon against juvenile delinquency, posing such a great threat to our society. BE IT RESOLVED that as True Wesleyans, we establish or re-establish the Family Altar in the home and faithfully maintain the continual flow of Spiritual benefits to enrich and fortify the lives of each member, to the Glory of God.

REPORT OF COMMITTEE ON INVESTIGATION OF FINANCIAL RECORDS

The Committee on Investigation of Financial Records and Bookkeeping met on February 18 at Corinth, New York. The committee made the following recommendations for the Local Churches:

- 1. Recommend that each Local Church elect an auditing committee which shall review and verify each treasurer of the Chruch prior to the 4th Quarterly Conference.
- 2. Recommend that the local churches adopt a uniform bookkeeping system, preferrably a General Journal of not less than 14 columns, containing all records of receipts and disbursements and a running balance of each fund. The Conference shall be authorized to recommend a central source of supply of said journals.

Further recommend that a sample copy of the proper entries be attached to the inside cover of each journal.

- 3. Recommend that the local churches follow a uniform system of individual record keeping, with regard to personal giving, also to be provided by a central supply, account. Also recommend that all church treasurers maintain a file of all invoices,
- 4. Recommend that all church treasurers disburse funds through a checking receipts, sales slips, vouchers, or the like.
 - 5. Amended. See Conference minutes.
- 6. Recommended that all Conference treasurers adopt a uniform policy of rendering receipts, in triplicate, to be handled as follows:
 - 1. Original to be retained by the treasurer making out the receipt.
 - 2. Duplicate to be sent to the local for his permanent records.

Triplicate to be sent to the Conference Treasurer.

REPORT OF BOARD ON CHURCH & PARSONAGE BUILDING & LOCATION

The Conference Board on Church and Parsonage Building and Location met at West Chazy Campgrounds in the President's Office on July 8, 1962. All members were present with the exception of Bernard McClure and including the new member, Aldis Lamos, currently serving as Conference Missions Treasurer.

Rev. Cliston Randall requested permission to borrow \$500.00 for the purpose of making additional Sunday School rooms in the basement of the Gouverneur Church. This amount to be added to the current note at the Gouverneur Bank. This permission was granted.

It was moved and passed that Floyd Tyler and Elwyn Putney go to the Ogdensburg Church and investigate the roof condition there to determine whether or not it can be repaired.

It was also brought to the attention of the committee that the Church at Ticonderoga was contemplating remodeling the roof of the entry. In regard to this, it was moved and passed that prior to any such remodeling, plans be submitted to this committee for consideration.

No further meetings of this Board were held during the fiscal year 1962-63. However, following are copies of letters which the Secretary received from the Conference President:

March 13, 1963 — Dear Board Member: Recently Rev. Russell Frase notified me that Cobleskill was delinquent on their semi-annual payment and that they could not pay it. As it was overdue, I authorized a grant of \$40.00 to Cobleskill Church to pay the balance of their payment.

Feb. 26, 1963 — Rev. Gerald Matson writes that Plattsgurgh is in very extreme need. Their bare budget needs are \$80.00 weekly and they have not been able to raise \$40.00 per week since January 1st. This is a grave situation in view of their large debt. I recommend that we give them \$300.00 from Conference Missions at once if available. If not, give them what is available, even if only \$100.00 and the remainder when it is available. If you agree with these proposals will you signify by a card?

March 26, 1963 — Dear Bro. Tyler: Please find enclosed a letter from the Cresent Church. I asked them to furnish details when they asked for a review by our Committee on Church and Parsonage Building and Location.

If this information is not complete enough or you feel we should meet, discuss and look the property over, please let me know at once. If necessary to meet, it would be at West Chazy W. M. Church, April 1st, at 4 p. m. If you feel that we can OK this proposition, please drop me a line at once; and it will, if everybody votes in the affirmative, be unnecessary to meet. Thank you for a prompt reply. If we have to meet, I suggest Monday, April 1st at 4 o'clock at West Chazy WM Church because Bro. Tyler and Bro. Seaman have to come to West Chazy later that evening for a Campmecting Committee meeting.

Proposal from Crescent: Following is an estimate of the proposed building program for the Parsonage of the Crescent WM Church: Our aim is to convert the present downstairs and kitchen into a 5-room apartment as follows — tear off all outside walls

on the inside, insulate and recover with sheetrock; relocate stairs to enter present kitchen from downstairs; change several windows to smaller size and install new windows in proposed living rooms; put in new floor downstairs; build 2 bathrooms in location of present stairs to be used by the Church and one private bath downstairs for the apartment. The following figures have been estimated by Mr. John Beadle, one of our own parishioners and a General Contractor. Mr. Beadle has not included a figure for electrical work as he intends to donate both labor and material. Also, the heating and plumbing figures are low due to donated labor and material by Mr. Martin Bozak. All other figures are estimated high to allow for unanticipated expenses. The one item which inflates the figure, but is a necessity, is the well and sewage.

I received Bernard McClure's answer soon after I wrote. As I didn't get a reply from you or Ed I thought that you must not have wanted a meeting as I asked for an answer if you did so we could get together during the week I was in N. Y. State. Inasmuch as Dick called about the decision, I told him to go ahead as planned. Elmer and I had an opportunity to go over and look at it before that time. (The above mentioned members gave verbal replies on the April 1st date and later by letter.)

May 22, 1962 — Dear Board Member: By this time we trust that you have received, reviewed and not renounced the plans of the new parsonage which the Glens Falls church is proposing for their pastor. Please notice that with the plan there is a page of instructions and information.

Without half a try we can see that it will be difficult to get all the Board together at one time even in work-week, June 3-7. However, shall we set June 6, on Thursday at 7:30 p. m. as a time when we can discuss this matter. A long discussion is not foreseen, as arrangements and plans seem very well laid. However, it is felt that this should be brought before the Board like any other project. If it would work a hardship on any member to be present at this time, would you please drop me a card or letter before that time stating your views upon the subject so that the members present may be guided accordingly.

Standing Rules

- 1. The Resolutions of this Conference shall be printed in the Minutes of the Conference each year.
- 2. All visiting members of our own, or other Churches in harmony with our principles, shall be invited to honorary seats in the Conference.
- 3. The Conference Secretary shall receive fifty dollars (\$50) per year for his labor, and any incidental expenses shall be in addition to this amount.
- 4. The Conference Treasurer shall receive fifty dollars (\$50) per year for his services in caring for the funds.
- 5. The Treasurer of the Superannuate Ministers' Relief Association also shall close his books one week before the Conference Session.
- 6. All monics disbursed by the Conference Treasurer during the interim of Conference shall be upon order of the President, except in case of payment to the President, when such order shall be issued by the Vice President. It is understood that any payment ordered by the Conference direct may be paid by the Treasurer without an order as directed above.
- 7. No monies shall be loaned by the Conference Treasurer except by order of the Conference, or by the consent of the President and his Advisory Board.
- 8. Each Elder shall make his engagements as Pastor with the understanding that if he be elected Conference President he shall be released from his engagement as Pastor within the period of three months following his election.
- 9. The first Sunday of each month shall be known as missions Sunday; the Sunday School offering to go alternately to (new) Church Extension & Evangelism and Conference Missions in that order, and that the conference missions offering be sent to the Conference Missions Treasurer. The Committee on Finance defines "Conference Missions" as the establishing new (or) subsidizing of the needy fields of the Conference.
- 10. In securing Evangelists for the Camp Meeting the Camp Meeting Committee is privileged to secure not more than one worker outside the Denomination.
- 11. The Camp Meeting Committee shall be composed of the Conference President, as Chairman, and three ministers and three laymen, all to be elected by ballot, the term of each office to be three years, the time of one minister and one layman expiring each year; also, the Conference Vice President, the President of the Missionary Society and the President of the W.Y. shall be members of this Committee.
- 12. Pastors shall state financial items in their statistical reports in even dollars, except in items affecting the Budget, and as far as possible are requested to report all Budget items in even dollars. When such rule is not followed, the statistical secretaries are authorized to drop decimals, except as provided above.
- 13. The Committee on Credentials shall secure from each delegate the necessary credentials as provided by our Discipline, with Post Office address of the same.
- 14. May 26th to the following May 25th shall be the term of all local Church officers, except the Committee on Pulpit Supply. May 25th shall be the close of the Conference year for Statistics. By June 2nd the pastor shall send to the Conference Treasurer all monies and receipts, with both copies of his statistical report made out, except budget items raised. These items the Conference Treasurer shall fill in and sign. In the event that the Conference Treasurer discovers a deficit in any of the Budget items, he shall notify the Pastor. By June 9th the Conference Treasurer shall in turn pass the reports to the Auditor of Statistical Reports. The Auditor shall correct the reports (if mistakes are found), and by June 16th shall pass one copy to the Statistician, and one back to the Pastor. He shall also send to the Apportionment Committee the membership of the churches, Sunday Schools, and W.Y. The Statistician and Auditor shall give Pastors opportunity to explain apparent errors but (new) no changes shall be accepted after the Wednesday before Conference convenes. The auditor of statistical reports shall audit the staticians compiled statistical report before its adoption by the annual conference. A qualified professional auditor hired by the Conference President shall audit all treasurers books before their reports are given to

the annual conference. These books shall be available at the conference president's office one week before the first day of conference. The elected auditors of financial records will audit all annual financial reports before their presentation to the conference body. The closing Sunday of the Conference year shall be the Sunday following the beginning of the annual conference. The Pastor's salary for this closing Sunday shall be paid by the church of which he is pastor; and for the Sunday of the new Conference Year by the charge to which he is going.

- 15. Newly elected Conference Officers take office after the close of Conference Sunday.
- 16. The Conference shall include in the Orders of The Day a special period to consider Camp Meeting business.
- 17. A Nominating Committee shall be elected to consider and nominate all elective Officers of the Conference. The Committee shall consist of four Elders and four laymen. No one shall repeat service on this Committee until an interim of one (1) year has elapsed. The report of the Nominating Committee shall be read to the Conference the day preceding the election.
- 18. The delegates' credentials shall be sent to the Committee on Credentials BEFORE THE OPENING DAY OF CONFERENCE, and the Conference Secretary shall send printed blanks with the Statistical, Character, etc.
- 19. The Conference recommends that each Charge grant its Pastor two weeks vacation, and also grant him permission to hold a two weeks meeting (over two Sundays) away from his local Charge both vacation and meeting to be without loss of pay; and exclusive of Annual Conference and Camp meeting.
 - 20. The first Sunday in May shall be PASTORAL VOTE SUNDAY.
- 21. CONFERENCE MISSIONS: (1) Conference President shall act as Pioneer Secretary. (This does not create the office of Pioneer Secretary.) The Conference Board on Church and Parsonage Building and Location shall be the Conference Missions Committee.
- (2) There shall be at least one Conference Missions service on each Charge in the Conference this year, at which time all of the Conference Mission activities within the Conference shall be presented. This service shall be under the supervision of the Conference President, or one whom he may appoint.
- Any person traveling the Conference in the interest of Conference Missions must be appointed and under the direction of the Conference President. Those thus appointed to travel the Conference in the interest of Conference Missions shall receive not to exceed five cents per mile.
- (3) All offerings taken for Conference Missions shall be forwarded to the Conference Missions Treasurer, and credited to Conference Missions. The Conference Missions Treasurer, upon the recommendation of the Conference President and the Committee on Conference Missions, shall disburse these funds. Any designated funds can be disbursed by notice received in writing from the Conference President, and that all monies raised to subsidize, build or repair new or old churches and parsonages be listed under Conference Missions by all treasurers and societies of the Conference.
- (4) Whereas the W.Y. is an organization that is agressively supporting the Conference Pioneer projects, we recommend that as far as possible all monies for pioneer work be passed through the Local Wesleyan Youth Treasurer, to the Conference Missions Treasurer of the Champlain Conference. We further recommend that the local Conference Missions program be sponsored by the W.Y. as far as possible.
- 22. During the year each Sunday School shall take an offering for the maintenance of the Conference President's home.
- 23. The Conference President shall be ex-officio member of the Board on Church and Parsonage Building and Location; the term of the other members shall be two years each, the term of two members expiring each year.
- 24. No new business shall be introduced to the Conference Body after Friday noon, without a two-thirds vote of the Body.
- 25. Our Conference shall meet for its Annual Session the first Tuesday after the last Monday in June, except the years of the General Conference. On such years

our Conference shall begin the second Tuesday following the General Conference. (These dates to be subject to the approval of the General Board of Administration.)

- 26. Each Church member over 14 years of age shall be apportioned \$2.50 per year for CONFERENCE MISSIONS.
- 27. The Pastors shall not be required to read their statistical reports (before the Conference Body).
- 28. The Bar of Conference shall be the first seven center rows of seats; Conference shall open at 7:00 p.m., the first day (Tuesday); The 7:00-8:00 p.m. period shall be an organizational business session led by the President. At 8:00 the Conference Body shall hear the Conference President's Message; the hours of Conference following the first day shall be 8:45 to 11:30 a.m. and 1:30 p.m. to closing by vote; the roll call shall be before the devotional service; and Work Week shall be the first full week in June.
- 29. The Superannuated Ministers' Relief Association shall supplement payment of Insurance Plan assessments to the extent of \$400. (four hundred dollars) annually.
- 30. In the event of the death of a minister or his wife, churches desiring to send flowers, shall send money instead.
- 31. The Missionary Board of the Conference shall be composed of the Conference President, W.M.S. President, Wesleyan Youth President, and Y.M.W.B. Superintendent.
- 32. Each church shall take an offcring to help defray expenses of the Ministerial Institute and send it to the proper person.
- 33. The treasurer of the Superannuated Minister's Relief Association, shall give as a part of his annual report, a report on the Denominational Pension Plan.
- 34. The Treasurer of the Superannuated Ministers Relief Association shall also be Treasurer of the Denominational Pension Plan.

Camp Ground Rules

General Rules

Report No. 2 REPORT OF THE WMS PRESIDENT

To the W.M.S. Presidents, the Y.M.W.B. Superintendents, delegates and friends of the 58th Annual Conference of the Champlain Conference of the Wesleyan Methodist Church — Greetings in the name of Our Saviour:

"To open their eyes, and to turn them from darkness to light, and from the power of Satan unto God, that they may receive forgiveness of sins, and inheritance among them which are sanctified by faith." (Acts 26:18)

Encompassed within this verse of Scripture lies the reason for the very existence of our society, and its goal for achievement. How nearly we achieve this goal as a Conference W.M.S. depends upon the degree to which we as individuals have comprehended the depth of blackness of sin, the helplessness of human souls in the clutches of Satan's power, and the awfulness of the destination of those souls who have not as yet had their eyes opened and received forgiveness for their sins.

Such an awareness never permits inactivity, sluggish service, or a feeling of smug satisfaction over accomplishments achieved. It will, however, generate a spirit of real rejoicing and gratitude to God, or — on the other hand of keen disappointment, according as the battle for Christ's cause forges ahead or sags behind. Therefore, it is with a spirit of praise to our God that we report that our Conference society has either held its own or made substantial gain in the following areas: a. money received; b. membership; c.,magazine subscriptions; d. missionary book readers; e. the Y.M.W.B.; f. The WWF gained in some aspects; lost in others.

There were wour Workshops held during the course of the year - one in each

district. These workshops were led by a team of five conferenc officers (the president, vice president, treasurer, statistician, and Y.M.W.B. superintendent).

Also, each of the four districts held a Missioinary Convention with Rev. Harold Chapman, missionary teacher in Sierra Leone, as speaker. Besides the four district Conventions, five local societies (namely Corinth, Glens Falls, Schenectady, Watervliet, and Springfield) sponsored local conventions using missionaries or native workers for their speakers.

During the fall months Dr. Marilyn Birch, missionary doctor to Sierra Leone, toured the Conference visiting each church and presenting a real challenge with her pictures and message.

The Conference W.M.S. president, two duly elected delegates, and a substitute for the Y.M.W.B. superintendent authorized by the Executive Committee of the Conference W.M.S. attended General Conference in June and did their part to represent the Conference Society in transacting business of the General W.M.S., bringing back reports of the business and the inspiration received.

In addition the W.M.S. president visited two local societics, wrote monthly letters to the Conference society through the medium of the Conference Challenger, presided at interim meetings of the Executive Committee, made five long distance phone calls, sent out 106 pieces of correspondence; negotiated with headquarters for missionaries to tour the Conference and serve as speakers on World Mission Night at camp; and represented the group in a number of sessions of the Camp Meeting Board.

This year marks the close of another quadrennium. We praise the Lord that we can announce an Efficiency Rating of 85% as a Conference for the Quadrennium based on the following standards: (in brief)

- 1. Study book and reading course to be introduced at annual conference each year.
 - 2. District convention held each year in districts.
- 3. District leadership training (workshops) held and literature table stocked each year at Conference.
 - 4. Ten percent gain in total membership.
- 5. Equivalent of 5% of active members be subscribers to missionary magazine; that tag day be observed in annual conference each year; and that each local society be given a number in the conference church key combination plan.
 - 6. Missionary tour of the conference annually.
- 7. Conf. W.M.S. president to organize a W.M.S. and Conf. Y.M.W.B. superintendent organize a band, where such does not exist, if feasible.
- 8. That every society be represented in the annual conference by the president and delegates.
- 10. That the Conference Y.M.W.B. superintendent attend General Conference and be financed by conference.

As we look forward to another year and quadrennium let us do so, ever keeping in mind our goals -1. to open their eyes; 2. to turn them from darkness to light; 3. and from the power of Satan unto God.

Standing Rules

We recommend:

- 1. The Standing Rules of the Conference Missionary Society shall be printed in the Conference Minutes each year.
- 2. That the Standing Rules and the 1963-67 new Plan of Work on the local level be read in each local society as soon as available after conference and this used for obtaining the efficiency rating for the end of the year.
- 3. That the treasurer of the Conference Society be elected a committee of Remembrance with the authority to send flowers or some suitable tribute to those of our number who shall be called to their eternal reward. We further recommend that this shall include pastor's wives and officers of our Conference Misionary Society.

The continuation of forwarding Sunday School charts, flannelgraph material and Sunday School quarterlies to fields where there are English Speaking Schools.

- 5. The preparation of exhibits to be displayed at conference. Societies displaying exhibits for World Missions send sufficient funds to cover postage to Marion, Ind. (It is considerate to contact missionaries as to urgent needs)
- 6. That we send the necessary suppiles to the Campground and these needs be itemized sometime in the Challenger during the year.
 - 7. That the conference make a financial contribution annually to the Challenger.
- 8. Consult 1962's minutes under Plan of Work, Roman numeral II, Page 69, entitled Community Missions for directives in promotions of Community Missions until the New Quadrennial Handbook is printed.
 - 9. The Conference Working Fund shall continue as 50¢ per active member.
- 10. Local Magazine Solicitor should use some systematic record in keeping her records. (Preferably the double file method of alphabet and expiration date).

- 11. That the men of the Churches which do not have an active Men's Fellowship be encouraged to join the Local Societies as Honorary Members.
- 12. That a study of the statistical reports be made and charts be compiled revealing the results of the years activities in its different phases. These studies to be made by the four districts rotating in alphabetical order.
- 13. That each local president include the name of their delegate on the Conference President's Fourth Quarterly Report; and the Local Vice President include the name and address of the new Vice President on her last Community Missions Report to the Conference Vice President.
- 14. At a local meeting before Conference the amount be determined which the delegate shall pledge at the World Missions Public Service at Conference.
- 15. Along with the delegates credentials send into the Conference secretary a list of the deceased within the year, and a brief statement of their activities within the society.
- 16. That the W.M.S. president and delegate be present at least 50% of the sessions of annual conference in order to qualify for efficiency credit. (Refer to the minutes of previous conference year)
- 17. All treasurer's final reports and monies must be postmarked by May 20th; all other reports and delegates credentials (with the exception of Reading Report) postmarked by and not later than June 1st.
 - a. Credentials to be sent to Conference W.M.S. Secretary.
 - b. Statistical blanks to Conference Statistician.
 - c. W.W.F. Report to Conference W.W.F. Secretary.
 - d. Magazine Report to Conference Magazine Solicitor.
 - e. President's Report to Conference President.
 (See List of Officers for names and addresses.)
 - 18. These shall comprise our Special Projects:
 - a. Conference Mission Project money amounting to the equivalent of 10 cents per active member or \$1.20 annually. To be sent to W.M.S. Treasurer. (non-budget)
 - b. May we encourage emphais on the penny-a-meal or penny-a-day fund which provides for the support of our missionary, Mrs. Whitthunn. Due to the fact that the missionary support has been substantially increased this phase of our work should be brought to the attention of our ladics from time to time. (budget)
 - c. That we assume a responsibility for emphasizing special prayer in our societies for young men and women to answer the call of God to go as teachers in the Government schools and the Mission Secondary School of Sierra Leone.
 - d. That a Hill-Scaman Memorial Fund be continued by each society, asking an offering for the aid of Foreign Students in Houghton Academy. (non-budget)
 - c. That one yearly offering be given toward the Houghton Academy Expenses of a Missionary Child. (non-budget)

Daily Proceedings

Thursday, July 11, 1963, 1:30 p.m.
