PROCEEDINGS

MONDAY, AUGUST 5, 1968

The thirty-fifty Annual Conference of the Pilgrim Holiness Church, Tennessee District, was held at the Cumberland Grove Campground Monday, August 5, 1968 at 8:00 A.M. Rev. Paul Light, Assistant District Superintendent led us in the song "I'm Dwelling in Beulah Land," with son, Tim Light, accompanying on the piano. Brother Light gave his testimony. Prayer was offered as we gathered around the altar. Special prayer requests for Mrs. Arnold, Mrs. Lucas, Mrs.Adams, and for our youth of our District and for our thirty-fifth Annual Conference.

Rev. Paul Light introduced Rev. L. E. Galyon as the Chairman for the 1968 Annual Conference.

Rev. Galyon spoke to us of the Conference from these scriptures, with this theme (The outline of his presentation as follows):

A NEEDED URGENCY

Romans 1:14-16. A need for some sort of progress is a basic need in everyone's life. In the business world, in the political world, in the educational world, and medical world there is that sense of urgency. How sad that this same sense of urgency is not felt in the matter of proclaiming the wonderful gospel around the world. I pray that God will help us to accept the glorious opportunities for expanding the work in Tennessee as the new Wesleyan Church. To do so we must:

I. Acknowledge our own Debt.

- A. For a personal experience in Christ (Seeing sin all around us we might say, "but for the grace of God there I go")
- B. For His keeping and enabling grace (For this we are all in His debt)

II. Accept the Task that is ours.

- A. To make ready or prepare for the work at hand.

 (Preparation for the ministry, for Christian service must not be left to chance as so often is the case)
- B. To speak up and say: ("I am ready") for any as-

signment. To boldly proclaim truth. (The need for minister as well as layman who will do so is appalling.)

C. To present a gospel that is Universal. (In this day of violence in the streets this gospel must be preached)

- III. Augmentation of our personal commitment is a must. \overline{A} . To serve acceptably we must be acceptable. (The
 - A. To serve acceptably we must be acceptable. (The word from text states it, "So, as much as in me is.")
 - B. Our efforts must increase. (The next four years must not find us at the same station)
 - C. We must be faithful to that commitment. (Those who have never heard are looking to you). The Word speaks to our hearts when the writer said, "I have kept nothing back that was profitable to you." "So, as much as in me is" of love, of grace "I am ready."

<u>Conclude</u>: Let us step forward into the new church and accept the challenge and do the job for God and the Wesleyan Church.

Conference Secretary called the roll of the delegates and ministers. As the Conference convened it was voted to make the two center sections of seats and the platform to compose the Conference bar. It was voted that the time of the Conference be set at 8:00 o'clock A.M. until 12:00 or conclusion of this Conference, but if necessary reconvene at 1:00 P.M. until finished.

Brother Galyon appointed Bro. Light to Chair as he gave his report.

The report of the District Superintendent, Rev. L. E. Galyon was read and approved and a statistical report was given in written form of the Tennessee District Pilgrim Holiness Church from 1957 to 1968 for a comparison study.

Moved and seconded to authorize Rev. L. T. Wallingford to organize and prepare the history of the Pilgrim Holiness Campground and obtain a steel box to preserve same.

Rev. J. S. Hicks presented Rev. and Mrs. Garry Jefferson to conference and was accepted as honorary members into

the conference bar.

The report of the Assistant District Superintendent was read and accepted.

The report of the Auditing Committee, Rev. Paul Light and Rev. Harold Watson, was presented and accepted.

The report of the District Treasurer, Rev. Samuel E. Condon, was read and approved.

The report of the District Statistician, Rev.Paul Light, was read and approved.

Rev. L. E. Galyon, Chairman, gave recognition to each church, pastor, and delegate that had met their United Stewardship Fund for this year.

These churches were Three Star Churches: Madison, Lakeview, Jellico, Chattanooga, Clinton, Cumberland Grove, Gordon Lake, Monterey, Morristown and Paris.

One Star Church: Nashville (Woodbine).

Motion made to have the Condolence Committee report at 11:45.

Motion to take a 10-minute recess.

The report of the District Missionary President, Mrs. Chester Rhoad, was read and accepted.

The report of the Promotional Secretary, Rev. Harold Watson, was read and accepted.

The report of the Camp Meeting Treasurer, Rev. H. H. Barton, was given and accepted.

The report of the Educational and Examining Committee was presented by Rev. Light and was approved.

The District Secretary, Rev. Frank Therber, presented two special resolutions: RESOLVED that this Thirtyfifth Annual Conference of the Tennessee District be reconvened August 20, 1968 at 1:00 P.M. for the purpose of uniting with the former Tennessee Wesleyan Methodist. This Uniting Conference to convene August 20, 1968, at 1:00 P.M. at Jamestown, Tennessee on the Cumberland Grove Campgrounds and RESOLVED, that all district officers continue in office until the Uniting Conference of the Pilgrim Holiness Church, Tennessee District, and the Wesleyan Methodist Church, Tennessee Conference August 20, 1968 at 1:00 P.M. It is understood that the above reference to the two groups means Former Pilgrim Holiness and Former Wesleyan Methodist and that following the Uniting Conference they shall be known as the Wesleyan Church, Tennessee District.

The election of two youths from our Pilgrim Holiness Church to function on a committee to nominate for youth officers for election at Uniting Conference. Rev. Harold Watson and Rev. Samuel Hicks were elected.

Moved and seconded to include District Superintendent Rev. L. E. Galyon's message to Conference in our Conference Journal.

The Condolence Committee presented memorials at this time.

Then Conference adjourned with singing a verse of "Amazing Grace" and "When the Battle's Over" as we shook hands.

DISTRICT SUPERINTENDENT'S REPORT 1967-1968

To the members of the thirty-fifth session of the Tennessee District of the Wesleyan Church, greetings in Jesus' name.

Just a few days ago I was privileged to attend the uniting conference of the Pilgrim Holiness Church and the Wesleyan Methodist Church in Anderson, Indiana. Many things stand out in my mind, of course, but more than anything else I was impressed with the program of Evangelism introduced and adopted by a standing vote. Indeed, "Evangelism" is the answer. This great theme is to begin with the General Church. We should all pray that God will grant our leaders wisdom in promoting this needed program in our church. The spirit of evangelism will save us from a slow but sure death. If the 1968 encampment was any indication of what we can expect on the Tennessee District, then revival is The attendance was good, and God spoke to many hearts. The altar was lined over and over and how we thank God for the wonderful victories.

Story of Statistics

I have placed in your hands a ten year statistical comparison report. Time would not permit me to evaluate these percentages here but you have them in your hands and may wish to study this at a later date. The last line of figures show the average percentage for the General Church in the U.S.A., 1966/67.

You will note that in some areas we must improve. Membership and Sunday attendance are very important and must have our concern and attention. While this is true there are some areas which compare well with the averages over the Church in the U.S.A. One point in question is the U.S.F. giving. We are happy to report that this stands at 72% for this year. The steady growth of equity in properties by the District and local churches shows every indication of consistent effort on the part of pastors and churches to upgrade our work in this great state.

We must go forward. We are too near the end to let up and fail God now. As we go into the new Wesleyan Church, let us make it a real forward movement in our district.

Improvements

Often improvements by local churches are mentioned in detail in similar reports. With your permission, I will forego such a detailed report only to say that the steady growth of equity in the past 10 years gives every indication that faithful pastors and laymen have striven to improve and as has been said before this will ultimately be reflected in church attendance. Several churches have made an effort along this line over the last year and are to be commended.

Personal Report

This year completes 13 years of service as District Superintendent. Through much of this time there has been dual responsibility of evangelism or pastoral work. I thank God for the understanding and cooperation of the ministers and churches along with the leaders of our General Church.

I have had the privilege of conducting two revival meetings off the District and one within driving distance. My vacation time was used for that purpose. traveled approximately 22,135 miles in connection with the district, in revival and in local church activity; presided over 4 council meetings having several sessions in time of camp and ministerial convention. I worked 14 days on the camp ground, including preparations for the annual camp meeting; worked on the various committees; attended one school board meeting at Southern Pilgrim College; and had one special meeting with Dr. C. Wesley Lovin to consider and plan for a comity committee meeting of the Pilgrim Holiness Church, Tennessee District, and Wesleyan Methodist Church, Tennessee Conference. This meeting took place May 11, 1968, with both groups fully represented. I assisted in preparations for ministerial convention, youth and district camp; taught a class in the district youth camp; conducted annual meetings; and, as time permitted, visited among the churches; attended zone meetings;

and wrote articles for the district page in the "Volunteer Views," our district news sheet.

Thank the Lord for the spirit of fellowship and good cooperation found among the people on this district. Let us go onward and upward in this great work.

MISSIONARY PRESIDENT'S REPORT

The Missionary Society activities for the fiscal year 1967-1968 began with a meeting of the District Missionary Committee following the 1967 Conference. At this time it was decided to raise money to purchase 2 sets of encyclopedias to be placed on mission stations where needed. \$52.20 of this amount has been sent in.

It was also decided to raise enough money to purchase a salad maker for the Camp. This was accomplished and is an asset to the Camp kitchen.

A drive was also made for towels to be used for Camp dishes. The response was excellent with at least a total of 80 towels being donated. This also was a very worthy project.

Several books of stamps were also sent to Headquarters on the car project.

In October, 1967, it was my privilege to travel with Sr. Meeks to three churches: Clinton, Rossville and Woodbine for a Zone or Area Workshop in each place. The evening services were preceded by a fellowship meal at a restaurant with a time for questions and discussions which was enjoyed by all who were privileged to attend.

It was also my privilege to represent the Missionary Society work at the Ministerial meeting.

As a result of Bro. Barton's travels to the West Indies it was suggested that a set of Melmac dinnerware be purchased and sent to the new mission home on Grand

Cayman. The money for these dishes and postage was spontaneously given at the Ministerial meeting in February.

Then when Bro. Barton returned from the islands he told about the opportunity there was for the Tennessee District to purchase a church and mission home on Jamaica for approximately \$350.00. Pledges for this project were given at the Youth Camp in June and more than this amount has been given. This will be called the Tennessee Memorial Church. To God be the glory for this worth while project.

Six booth displays were prepared for the Camp. Paris booth received first place award and Jellico received second place award.

Again I want to say thank you to all who have contributed in any way to see these things accomplished.

May God's richest blessing rest upon each society as we labor together for the Master. With an enlarged field, brought about by the merger we should be challenged more than ever to do our best as Missionary Societies to get under the load and work while we have the opportunity.

RESOLUTIONS

LOCAL CHURCH

- 1. Be it resolved that we have five zones in the district as follows: Zone 1 Jellico, LaFollette, Lake City, Clinton; Zone 2 Oak Ridge, Rockwood, Knoxville, Morristown; Zone 3 Jamestown, Monterey, Moss, Cumberland; Zone 4 Chattanooga, Lake City, Gordon Lake; Zone 5 Paris, McEwen, Nashville. Plans are to be made for at least five zone meetings during the year.
- 2. Be it resolved that each pastor read all the resolutions and all the recommendations of the Ways and Means Committee to the church at the earliest convenience, and a few weeks before Camp Meeting.
- 3. Whereas, many of our pastors have not received sufficient financial support, be it resolved that our local church boards, with the help of the District Superintendent, impress upon the Deacons that it is their duty to see that monthly donations are brought to the pastor.
- 4. Resolved that one copy of the District Minutes be in each church; also, that pastors urge their members to have their own copies.
- 5. Be it resolved that the local churches observe the sacrament of the Lord's Supper on the first Sunday of each quarter.
- 6. Be it resolved that each church grant their pastor a two weeks vacation with pay.
- 7. Be it resolved that we put on a special drive in the District for subscriptions to the Wesleyan Advocate, and that our pastors make an effort to get the paper into every member's home; also, to put the paper into as many schools, doctors' offices, and church friends' homes as possible.
- 8. Be it resolved that no pastor or evangelist engage in a revival during Camp Meeting, Conference or Ministerial Meeting, unless excused by the District Superintendent.
- 9. Be it resolved that all church and unstationed ministers' reports be in the hands of the District Statistician not later than June 15th, yearly. Also, that no church reports be sent in until thoroughly checked by the pastor as to neatness and accuracy. A list of those who are late is to be made and these are to meet the council.
- 10. Be it resolved that where possible each local church is to conduct a Daily Vacation Bible School.
- ll. Be it resolved that building plans for local churches be first approved by a committee consisting of the District Superintendent, the Assistant District Superintendent and the District Treasurer.
- 12. Be it resolved that the district zone leaders, in cooperation with the pastors, decide upon the time and place of the zone meetings in their zone.
- 13. Be it resolved that all revivals in local churches, also, all seekers in our services in the local churches, be reported by the pastor in his pastor's report.

Sunday School and Youth

- 1. Be it resolved that each church encourage organization of a Young People's Society where possible.
- 2. Be it resolved that churches sending in reports for YPS and SS news sheets send them before the fifth of each month, that being the deadline.
- 3. Be it resolved that the 2:00 o'clock session on Thursday of District Camp be reserved for District Youth Conference; also, that the District Youth Council, comprised of the District Superintendent, Youth Secretary, and Zone Chairmen of the five zones, have direction of this service.
- 4. Be it resolved that if any church fails to make a Sunday School report to the Sunday School Promotional Secretary by the fifth of each month, the Secretary will call the pastor and reverse the charges.
- 5. Be it resolved that the District Young People's Secretary put an article in each issue of the District news bulletin.
- 6. Be it resolved that the Tennessee District have a Youth Camp to be held during the first full week of August, on the District campground. This shall be a combination Junior-Senior camp, including ages ten through nineteen.
- 7. Be it resolved that the District Youth Council, with executive members of the District Council, be empowered to select the evangelist and all other personnel of the Youth Camp.
- 8. Since there is a great need for Christian training and spiritual development of our young people, be it resolved that the Tennessee District have a "Youth Enlisted Serving" program. Rules and regulations to be set up by the Youth Council, which is subject to District Council.

District

- 1. Be it resolved that the examining committee, before recommending ministers or deaconesses to the Conference, explain the requirements and obligations of the District and urge the keeping of same.
- 2. Be it resolved that the District Superintendent be empowered to appoint the District Statistician and all regular committees.
- 3. Be it resolved that the Ministerial Convention be held in January or February, the exact date to be set by the District Council.
- 4. Be it resolved that no minister of the district receive an official transfer to another district unless his district obligations, such as ministerial tithes and other requirements passed by the conference, are paid.
- 5. Be it resolved that the District Superintendent be allowed a two weeks vacation with pay.
- 6. Be it resolved that the Condolence Committee serve also as a District Flower Committee. In the event of a death in the immediate family of a District minister and/or a death in the immediate family of a District minister's wife, one of this com-

mittee is authorized to send flowers on behalf of the District. Flowers will be sent in the event of a death of others than immediate relation only if two members of this committee agree to make an exception.

Be it further resolved that this committee be authorized to send flowers on behalf of the District in the event of the serious illness of a District minister, a District minister's wife, or one of their children.

This committee shall be appointed in the same immediate area of the District.

Camp Meeting

- 1. Be it resolved that the District Camp Meeting be year to year, starting on Friday before the first Sunday in July and continuing through the second Sunday in July, and that the District Conference be held on the Monday following Camp.
- 2. Be it resolved that no children under fifteen years of age be sent to stay at the Camp Meeting unless attended by parents or guardian.
- 3. Be it resolved that the District Superintendent check all Camp Meeting equipment by the end of the second quarter and notify each church what they are to provide.
- 4. The District Council is to provide rules and regulations for Camp Meeting and all persons attending Camp are to abide by same.
- 5. Be it resolved that those who operate the Lunch Room, those in charge of beds and all active ministers be on the Camp Ground Tuesday morning before Camp starts, unless excused by the District Superintendent.
- 6. Be it resolved that the Camp Ground be cleaned up and repairs made at least two weeks before camp begins, all pastors and pastors' wives to assist at the call of the District Super-intendent.
- 7. Be it resolved that some form of playground be prepared for the children and that there be a playground supervisor in charge of play activity, this supervisor to be appointed by the District Superintendent from the three additional Council members.
- 8. Be it resolved that due to the shortage of working personnel the District ministers and ministers! wives work during Camp Meeting, rather than pay their way, unless they are physically incapacitated.
- 9. Be it resolved that since the Camp has enlarged year after year, it is recommended that a Disciplinary Committee be appointed by the District Council, to consist of not less than two men and two women to deal with those young men and women, whose parents are not on the grounds, and who cause disturbances, even to the extent of discharging them from the Camp ground.

Camp Ground

1. Be it resolved that the District promote the building of cabins on the campground by approaching the churches that do not

have cabins on the campground, and offer them the opportunity of participating in a plan to erect a complex of cabins fourteen feet wide by a length of the number of churches participating times twelve feet (not to exceed 6 churches or 72 feet long.) Each church deciding to contribute its pro-rata share of the cost of this complex, may make use of our District Loan Fund to finance its share of the cost of construction. The use of District ministers should be encouraged in the erection of this complex. This construction shall be under the direction of the Campground and Lot Committee. The maintenance of this complex shall be under the direction of the Campground and Lot Committee and all costs for same shall be prorated to the participating churches.

2. Since the rental rooms are for the accommodation of campers on the grounds, and the need for rooms is so great, we recommend that rooms, cabins, and cottages owned by the District or local church, come under the complete rental control of the registration office if they are to be vacant for more than one night during camp. We further recommend that no one can reserve, claim or hold key to same that will result in a vacancy for more than one night.

YOUNG PEOPLE'S SOCIETY MINUTES

The eighth Annual Pilgrim Youth Conference was held August 1, 1968 at the Cumberland Grove Camp Ground, Jamestown, Tennessee.

Rev. Paul Light led the congregation in singing "Come and Dine."

Rev. Samuel Condon introduced Rev. L. E. Galyon, Chairman of the Conference. Bro. Galyon assured the young people of the Tennessee District's interest in them. He spoke briefly of the young people being a part of the past, part of the present, and of their going to be a definite part of the future.

The ministers of the District gathered around the altar and Rev. Harold Watson, Assistant Youth President, led in prayer, praying especially for the young people.

The Secretary read the roll call.

The Conference Bar consisted of the two middle sections and the platform.

The President's report was given and accepted with a standing vote of appreciation.

The Chairman recognized the former youth president, Rev. E. Ray Hotle who was visiting in the Conference, for his interest in helping promote the first youth camp.

The Treasurer's report was given and motion was made and carried to accept this report with appreciation.

The Youth Zone Leaders' reports were given: Bro.Cook, Zone 1; Bro. Pruiett, Zone 2; Bro. Cobb, Zone 3; Bro. Hill gave a report due to the absence of Bro. Oliver France, Zone leader of Zone 4. These reports were accepted with appreciation.

Youth Presidents' reports were given: Mrs. Richard Turner, Paris; Mr. Timothy Light, Jellico; Miss Carolyn Martin, Clinton; Miss Rita Langston, Lake City; Miss Carol Pruiett, McEwen; Mrs. J. D. Trimble, Jamestown; Mr. Robert Rhoad, Cumberland Grove; Bro. Samuel Hicks, Monterey; Bro. Carroll Cook, West LaFollette. These reports were accepted with appreciation.

Rev. Frank Therber, Secretary of the Board of Administration, presented the resolutions as follows:
Resolved, the new District Board of Administration will nominate two or more for W.Y. President at the Uniting Conference.

Resolved, the District Conference be authorized to elect, or if so voted, the Uniting Conference to elect the executive officers and other officers in the following manner:

- A. A nominating committee of two shall be elected from the former Pilgrim Holiness group at the August 5th Conference to work with a committee of two elected at the former Wesleyan Methodist Conference, August 20, to serve as a committee of four for the purpose of nominating persons for the election of other W.Y. officers by the Merging Conference, August 20.
- B. A caucus will be held at the Uniting Conference after the Board of Administration has set zone boundaries, of all members present from each zone for the purpose of nominating two or more for zone leaders to be elected by the Uniting Conference.

The motion was made and carried to accept these resolutions.

The motion was made and carried that the minutes be approved by the District Council.

DAILY PROCEEDINGS

TUESDAY, AUGUST 20, 1968

10:00 A.M. Session

The thirty-ninth session of the Tennessee Mission Conference of the Wesleyan Methodist Church of America convened at 10:00 A.M., CST, Tuesday, August 20, 1968, at the Cumberland Grove Camp Grounds, Jamestown, Tennessee.

DEVOTIONS - W. C. Crowe led the congregation in singing "Living by Faith." Dr. Virgil A. Mitchell had the devotional period, using Psalm 125 as a basis for his remarks.

BUSINESS SESSION CONVENES - The business session was called to order. Dr. Virgil A. Mitchell, General Superintendent, presided, assisted by Dr. M. H. Snyder, General Superintendent.

ROLL - Roll was called by the secretary.

ROLL CORRECTION - David Hagewood was seated as pastor of Grace Wesleyan Methodist Church, Nashville. The name of Bernard Smith, former pastor of Grace Church, was dropped from the roll of conference preachers.

CONFERENCE BAR - The bar was established as the rostrum and center section of the tabernacle.

PRESIDENT'S REPORT - The President's Report, in his absence, was read by the secretary. (See Report I, Pages 44-45). This report was adopted.

HONORARY MEMBERS OF CONFERENCE SESSION - Moved, supported and carried that Rev. M. L. Arnold and Rev. Claude Scott be made honorary members of the Conference with privilege of speaking.

CONFERENCE BOARD OF TRUSTEES - The Board of Trustees reported on settlement reached with seceding group. (For complete report see Report II, Page 46).

ITINERACY AND ELDERS ORDERS - Dr. Edward Schade, chairman of the Itineracy and Elders Orders Committee, presented the following recommendation:

RECOMMENDED that David Hagewood be placed in the Third Year Course of Study. Recommendation accepted.

RECOMMENDED that James Bozarth be ordained. Recommendation accepted.

CONFERENCE TREASURER - The Conference Treasurer read his report. (See Report III, Page 47). This report was adopted.

AUDITING COMMITTEE - The Auditing Committee reported the Treasurer's books had been examined and found to be in order. This report was adopted.

DR. RICKMAN INTRODUCED - Alvin A. McCammon, Board of Managers, Central College, introduced Dr. Claude Rickman, newly elected President of Central College, and Mrs. Rickman. Dr. Rickman brought official greetings and presented certificates to Knoxville First Church, Nashville First Church, and the Oak Ridge Church.

REPORTS OF PASTORS AND DELEGATES - The following pastors and delegates reported: Wayne E. Tippey, Knoxville First Church, Alvin A. McCammon, delegate; Dr. Edward Schade, Nashville First Church, Mrs. Martha Vetitoe, delegate; M. L. Gatlin, Nashville Second Church, Arnold Butts, delegate; David Hagewood, Nashville Grace Church, W. C. Lawhorn, delegate; James Bozarth, Nashville Woodbine, T. H. Coger, delegate; Claude McCabe, Oak Ridge, W. C. Crowe, delegate; and M. L. Arnold, supply pastor, Rockwood, Mrs. Louise Nash, delegate.

STATISTICIAN - Moved, seconded, and carried that the Statistician be authorized to insert her report into the Minutes. (See Report IV, Pages 48-56)

CHARACTERS OF PASTORS - Moved, seconded, and carried that the characters of the pastors be passed.

BOARD OF MANAGERS - The Board of Managers of the Tennessee Mission Conference of the Wesleyan Methodist Church of America met with like Board from the Tennessee District Pilgrim Holiness Church to act as a Comity Committee. Boundaries of the Tennessee District were established as the State of Tennessee and the churches at Lake View and Lafayette, Georgia. Agreed date be set for merging conference.

RESOLUTION OF MERGER

Whereas, the Comity Committee of the Tennessee District of the Pilgrim Holiness Church and the Tennessee Mission Conference of the Wesleyan Methodist Church of America recommended the merging of the said District and Conference, and

Whereas, the General Board of Administration of the Wesleyan Church on July 3, 1968 approved the proposed plan of merger of the said District and Con-

ference.

Therefore be it resolved that we approve the recommendation of the Comity Committee and thereby merge the said District and Conference to be one entity the Tennessee District of The Wesleyan Church - the same to be governed by the Discipline of The Wesleyan Church as from time to time legislated and declared.

MERGER VOTE - Moved by Claude R. McCabe, seconded by Wayne E. Tippey, that the above Resolution of Merger be adopted and the Tennessee District of the Pilgrim Holiness Church and the Tennessee Conference of the Wesleyan Methodist Church of America be declared merged. By count of 19 to 0 this motion carried.

MINUTES - The minutes of this thirty-ninth conference were read, corrected, and approved.

ADJOURNMENT - Adjourned on motion.

MERGING CONFERENCE

The Merging Session of the Tennessee District of the Pilgrim Holiness Church and the Tennessee Conference of the Wesleyan Methodist Church of America convened at 1:00 P.M., CST, August 20, 1968, at the Cumberland Grove Camp Grounds, Jamestown, Tennessee.

DENOMINATIONAL ADDRESS - After a spirited song service, Rev. L. E. Galyon, Tennessee District Superintendent of the Pilgrim Holiness Church, introduced Dr. M. H. Snyder, General Superintendent. Dr. Snyder welcomed all to this historic meeting and then presented Dr. Virgil A. Mitchell, General Superintendent, who brought the Denominational Address using St. John 17 as his text.

BUSINESS SESSION - The business session was called to order.

ROLL CALL - Roll was called of elders, stationed conference preachers, and lay delegates of the Tennessee Conference of the Wesleyan Methodist Church of America. Roll was called of ministers and lay delegates of the Tennessee District of the Pilgrim Holiness Church.

CONFERENCE BAR - Conference Bar was established as the rostrum and two center sections of the tabernacle. Hours set as 1:00 P.M. - 4:30 P.M., supper, reconvene at 6:00 P.M. to continue until business is completed.

COURTESY COMMITTEE - Rev. Paul Light and W. C. Crowe presented Dr. Claude Rickman, newly-elected President of Central Wesleyan College; Mrs. Rickman; Rev. Claude Scott; Rev. M. L. Arnold; and Miss Ruth Meek, Woman's Missionary Society President of the Pilgrim Holiness Church; to Dr. Edward Schade and Rev. L. E. Galyon, who introduced them to the Conference body. Those introduced were made honorary members of the Conference.

RESOLUTION OF MERGER - The following Resolution of Merger was read by Dr. Mitchell:

Whereas, the Comity Committee for the Tennessee District of the Pilgrim Holiness Church and the Tennessee Conference of the Wesleyan Methodist Church of America recommended the merger of the said District and Conference and

Whereas, the General Board of Administration of the Wesleyan Church on July 3, 1968 approved the proposed plan of merger of the said District and Conference, and

Whereas, the Tennessee District of the Pilgrim Holiness Church in session at Jamestown, Tennessee on August 5, 1968 did by an unanimous vote ratify the recommenda-

tion of its Comity Committee, and

Whereas the Tennessee Conference of the Wesleyan Methodist Church of America in session at Jamestown, Tennessee, on August 20, 1968, did by a vote of 19 favoring and 0 opposing ratify the recommendation of its Comity Committee, and

Whereas, following the unanimous ratifications of the aforesaid Comity Committee's recommendation this merging conference is hereby assembled at Jamestown, Tennessee, to implement the aforesaid authorization to merge the said District and Conference, thereby be it resolved:

1. That we ratify the action of the aforesaid District and Conference and thereby declare that we are now one entity - the Tennessee District of The Wesleyan Church - the same to be governed by the discipline of the Wesleyan Church as from time to time legislated and declared.

2. That all the property, assets, membership, and operations of the aforesaid District and Conference including local churches are hereby transferred to and become a part of the Tennessee District in accordance with the Discipline of The Wesleyan Church.

Motion by Rev. Paul Light, seconded by Rev. S. E. Condon that this Resolution of Merger be adopted. Approved by a vote of 50 to 0.

NOMINATING COMMITTEE - Moved by Rev. Wayne Tippey, seconded, and carried that the Pilgrim District Council and the Wesleyan Board of Managers constitute a Nominating Committee, with the addition of two members to the Wesleyan Board to give a like number from each denomination. The committee was composed of: Rev. Frank Therber, Rev. Paul Light, Rev. S. E. Condon, Rev. Chester Rhoad, Rev. J. W. Hill, Rev. L. E. Galyon, and Rev. Vernon Pruiett,

Pilgrim Holiness; and Rev. M. R. Gatlin, Dr. Edward Schade, Rev. H. A. Harvey, Alvin A. McCammon, W. C. Crowe, Rev. Wayne E. Tippey, and Miss Agnes Houser, Wesleyan Methodists.

RECESS - Conference recessed for a committee meeting; to reconvene in ten minutes.

Conference reconvened.

EDUCATIONAL ADDRESS - Dr. M. H. Snyder introduced Dr. Claude Rickman, who gave an Educational Address.

ITINERACY AND ELDERS ORDERS - The Tennessee District of the Pilgrim Holiness Church presented the names of Carroll Cook, Frank Therber, and Vernon Pruiett for Elders Orders. The Tennessee Conference of the Wesleyan Methodist Church of America presented the name of James Bozarth for ordination. Moved, seconded, and carried that these brethren be ordained elders.

TELLERS - The following were named tellers: Rev. Harold Watson, Rev. Paul Light, Rev. S. E. Condon, Rev. J. S. Hicks, Rev. Wayne E. Tippey, Alvin A. McCammon, Rev. David Hagewood, Rev. James Bozarth.

NOMINATING COMMITTEE REPORT - The Nominating Committee gave their report and the following were elected officers of the Tennessee District of The Wesleyan Church (by ballot):

BOARD OF ADMINISTRATION - Motion carried that the Conference Board of Administration be composed of nine members. The District Superintendent, Assistant District Superintendent, Secretary, and Treasurer will automatically become members of the Board. The other

elected members will be composed of two elders and three laymen.

Motion carried that nominations to the Board of Administration be submitted from the floor.

The following were elected, by ballot, to the Board of Administration: Rev. Paul Light, Rev. J. W. Hill, Dick Turner, Alvin A. McCammon, and W. C. Crowe.

Motion carried that the Board of Administration be authorized to name, or act in capacity of, any committees provided by the new Discipline, or as necessary for the efficient working of the Church.

WAYS AND MEANS COMMITTEE - Rev. Paul Light, Chairman, read the report of the Ways and Means Committee (See Report A, Pages 65-70). Moved and seconded this report be adopted. After debate pro and con, motion carried that debate be closed. Moved by Rev. L. E. Galyon that Items A(2), C1(a) and D1 be referred to the Board of Administration to reach a working solution. Seconded. Motion carried.

Motion carried that there be a time limit of sixty days for the Board of Administration to reach a decision.

Item Al is the official Connectional Budget, given for information only.

Items A3, B, C with exception of 1(a), D excluding (1), E and F were each approved separately by motion, support, and vote of conference body.

Items G, H, and I were referred to the Board of Administration.

MRS. MILDRED SCOTT INTRODUCED - Rev. Claude Scott was requested to bring his wife, Mildred, forward to be introduced to the Conference. Mrs. Scott is General President of the Wesleyan (Methodist) Missionary Society.

PASTORAL ARRANGEMENTS - Motion carried the pastoral arrangements be approved. (See Church Directory) Since

the Wesleyan Methodist charges and their pastors had not been given at the session of the Wesleyan Methodist Conference their report was read and approved by vote of the Conference body.

Recessed for 10 minutes.

ORDINATION SERVICE - Dr. Melvin Snyder spoke from the text taken from II Chron. 16:9: For the eyes of the Lord run to and fro throughout the whole earth to shew himself strong in the behalf of them whose heart is perfect toward him. Those ordained were: Rev. James Bozarth, Rev. Vernon Pruiett, Rev. C. L. Cook, and Rev. Frank Therber.

Conference adjourned.

REPORT A - WAYS AND MEANS COMMITTEE REPORT

ITEM A BUDGET

1. United Stewardship Fund:

The United Stewardship Fund for each year shall be an amount equivalent to a percentage of the total income of all churches for the previous fiscal year. The total income of a local church is defined as the total receipts of the local church and all its departments for the fiscal year, with the exception of borrowed money and money received from the sale of property and Building Funds.

The <u>United Stewardship Fund shall be 6.7%</u> of total income.

2. District Budget:

The District Budget shall be sent to the District Treasurer as undivided budget at the end of each month, and shall be figured on the following percentage: 8.3% for undivided District Budget.

	These	recei	pts	shall	be	apportioned	as	fol-
lows:								

- for District Administration
 for District Home Missions
 for Camp Ground
- It is recommended that each local church pay the assessment fees of the pastor and wife to the Ministerial Benefit Association.
- 4. Since it is a matter of importance that each pastor attend the Camp Meeting and Conference, it is recommended that the pastor's support from his church continue during this time.

ITEM B SUNDAY SCHOOL WORK

 It is recommended that the Editor of the "Volunteer Views" receive \$10.00 per month, to be paid from the District Youth Fund. The expense of printing, paper, etc. to be paid from District Youth Fund.

- It is recommended that February be designated as "Volunteer Views" month and that each church receive an offering to defray expenses of the paper. Offering to be sent to District Youth Treasurer.
- 3. We recommend that the registration fee for Youth Camp be \$8.00 per person, this amount includes insurance. All counsellors and Camp personnel are to be exempt from this fee except the amount for insurance.
- 4. We recommend that the Youth President visit each zone once a year and that he inform the people of the progress of the Youth work. At this meeting an offering shall be taken to promote the Youth Work.
- 5. We recommend that the District Youth President be paid 7¢ per mile for traveling expense, the same to be paid from the District Youth Fund.
- 6. We recommend that at each zone meeting an offering be taken for the District Youth Work, the same to be sent to the District Youth Treasurer.

ITEM C DISTRICT FINANCES

1. Remuneration of Officials:

- a. We recommend that the District Superintendent be paid \$100.00 per week salary.
- b. We recommend that all utilities of the District Superintendent be paid by the District. Housing Allowance of \$65.00 per month.
- c. We recommend that the District Superintendent be paid 7¢ per mile for all travel in the interest of the District.
- d. We recommend that the District pay the Ministerial Benefit Association Assessment fees

for the District Superintendent and his wife as well as the Pension Assessment.

e. We recommend that the District Treasurer be paid \$20.00 per month; the District Secretary be paid \$30.00 per year; and the District Statistician be paid \$30.00 per year.

2. Other:

- a. We recommend that any other authorized District travel be paid at the rate of 7¢ per mile.
- b. We recommend that all persons while traveling in the interest of the District be paid meals and lodging enroute to their destination.

ITEM D DISTRICT SUPERINTENDENT

- 1. We recommend that the District Superintendent devote his full time to the duties of his office.
- We recommend that the District Superintendent pay his tithes into the District Treasurer.
- 3. We recommend that the District Superintendent be allowed the privilege of holding two revivals a year off the District, and that he be permitted to keep his offerings, but he shall pay his own traveling expenses.

ITEM E DISTRICT LOAN FUND

- We recommend that the District Loan Fund be placed under the supervision of three: District Superintendent, District Treasurer, and one other person appointed by the District Board of Administration, said committee to be under the direction of the Board of Administration.
- 2. We recommend that the Loan Committee be authorized to grant loans on the basis of the need of the church requesting a loan, and upon the past record of said church in regard to its previous punctuality of payment. Interest 4% per annum figured annually.

Following announcements of forthcoming headquarters projects by Mrs. Scott, Rev. and Mrs. Banker sang Jamaican choruses and Mrs. Banker brought a message, reminding all that we who are of the household of Christ have a task to do, and that the purpose of the WMS in the new church is to promote the missionary outreach of the church.

The conference was adjourned with a prayer of benediction by Mrs. Scott.

Merger Service

The merger service of the two missionary societies began at 10:30 A.M. with a prelude, "Lead On O King Eternal." The congregation sang "Oh Thou Great Jehovah," led by Rev. L. E. Galyon; scripture was read by Rev. Sam Hicks; and Rev. Wayne Tippey led in prayer. He asked God's blessings on this merger of these missionary societies into one. There was a quiet peacefulness felt during this service —a feeling that comes from doing God's will.

The service continued with a candle lighting ceremony in which the presidents of the two missionary societies lighted one candle each, bringing their respective society into a merger with the simultaneous lighting of a center candle and the reading of a pledge of unity, extinguishing the flames of the two outer candles. The one candle in the center remained lighted, symbolizing merger and unity. A congregational song, "Great Is Thy Faithfulness," was sung intermittently with the lighting of the candles. The conference then responded verbally to a dedication pledge read by Mrs. Scott, WMS director from the general church headquarters. A duet was sung by Rev. and Mrs. L. E. Galyon. The theme chorus, "Holding Forth the Word!", that was adopted at the WMS General Merger Conference at Louis-ville, Ky., was sung by all several times.

A very effective prayer of dismissal from the merger service was prayed by Rev. Galyon.

It would have been good if all the women of the Tennessee churches could have attended this merger conference and witnessed the unity of spirit of the newly merged WMS.

Proceedings

The Merger Conference of the Tennessee Women's Missionary Society of the Pilgrim Holiness Church and the Wesleyan Methodist Church was held on Saturday, November 16, 1968 at the Rockwood Wesleyan Church, Rockwood, Tennessee. The morning session began with the merger service at 10:30. This was followed by a business session at which time the roll was called and the delegates moved into the bar.

Nominations were read for president, ballots were cast, and Mrs. Mabel Rhoad was elected on the third ballot. The chairmen of the various committees were then selected, nominations were made for the committee members and the votes were taken by a show of hands. The business session was then adjourned so that the committees could meet and start work on their plans for the future. Following this, Mrs. Scott, conference chairman, introduced Rev. and Mrs. Banker, retired missionaries, who were to speak to the conference. Bro. Banker brought a timely message to the conference, ending with a special appeal for a good self-denial offering in November. Bro. McCammon dismissed the morning session with prayer.

Following a group lunch at a local restaurant, the afternoon session began at 1:45. After congregational singing and prayer, Mrs. Scott brought to the attention of the conference various programs and pamphlets available for WMS use, including the Prayer Share card which has been of much value in the past and will be continued in all sincerity in the future. She also explained the purpose and function of the YMWB.

The Nominating Committee then reported on its nominations. Elections were held and the officers shown on Page 71 were elected. The other committees then reported as follows:

Planning Committee: Recommended that (1) the district president have one session for missions during the Ministerial Convention at Knoxville the last week of March, time to be set by the District Board of Administration; (2) the WMS meet for its annual convention on Monday following camp meeting, at 8:00 A.M.; (3) the vice president assume the responsibility of the missionary booths at camp and conference; and (4) the district missionary society request a missionary on the zone level during the year. All of these were adopted.

<u>Ways & Means Committee</u>: Recommended that (1) the societies pay 50¢ per year per active member for the district operating fund; and (2) all special district projects, such as camp ground, mission projects, etc., be left to the discretion of the Executive Committee. All of these were adopted.

Appreciation Committee: Recommended that letters of appreciation be sent to the Rockwood Wesleyan Church for the use of their sanctuary and classrooms for the conference and committee meetings, to Rev. and Mrs. Banker for their inspirational presence and messages to the conference, to Mrs. Scott, conference chairman, and to

the restaurant that so efficiently fed lunch to the conference group, numbering 51. This was approved.

Following announcements of forthcoming headquarters projects by Mrs. Scott, Rev. and Mrs. Banker sang Jamaican choruses and Mrs. Banker brought a message, reminding all that we who are of the household of Christ have a task to do, and that the purpose of the WMS in the new church is to promote the missionary outreach of the church.

The conference was adjourned with a prayer of benediction by Mrs. Scott.

Merger Service

The merger service of the two missionary societies began at 10:30 A.M. with a prelude, "Lead On O King Eternal." The congregation sang "Oh Thou Great Jehovah," led by Rev. L. E. Galyon; scripture was read by Rev. Sam Hicks; and Rev. Wayne Tippey led in prayer. He asked God's blessings on this merger of these missionary societies into one. There was a quiet peacefulness felt during this service —a feeling that comes from doing God's will.

The service continued with a candle lighting ceremony in which the presidents of the two missionary societies lighted one candle each, bringing their respective society into a merger with the simultaneous lighting of a center candle and the reading of a pledge of unity, extinguishing the flames of the two outer candles. The one candle in the center remained lighted, symbolizing merger and unity. A congregational song, "Great Is Thy Faithfulness," was sung intermittently with the lighting of the candles. The conference then responded verbally to a dedication pledge read by Mrs. Scott, WMS director from the general church headquarters. A duet was sung by Rev. and Mrs. L. E. Galyon. The theme chorus, "Holding Forth the Word!", that was adopted at the WMS General Merger Conference at Louisville, Ky., was sung by all several times.

A very effective prayer of dismissal from the merger service was prayed by Rev. Galyon.

It would have been good if all the women of the Tennessee churches could have attended this merger conference and witnessed the unity of spirit of the newly merged WMS.
