All members of the Superannuation Pension Plan are to make their payments on assessed incomes and file reports according to regulations.****Eighth:—That the Conference President be Record Clerk.****Ninth:—That the member of the Board of Managers for Houghton College also be Conference Educational Secretary.****Tenth:—That the Pastoral Vote be taken prior to February 15th.****Eleventh:—That the Churches grant each pastor two weeks vacation with pay at a time agreeable to the pastor and congregation.****Twelfth:—That only the following items of the Minister's Statistical Report be read on Conference floor:—Item 1. Appointments; Item 2. Wesleyan Methodists, Wesleyan Missionaries, Wesleyan Youth; Item 3. Present**

Number, loss or gain, number of family altars; Item 4. Total Number in Main School, average attendance, Wesleyan Young People's Societies—both parts; Item 5 & 6—to be read in full; Item 7. Total for Church; Item 8. To be read in full; Item 9. Total for Benevolences; Item 10. To be read in full.

Thirteenth:—Those who travel on Conference Assignments or to Conference gatherings where travelling expenses are remunerated:—The following will be observed:—

1. Where possible and convenient, clergy rates will be paid.
2. The expenses of meals and room, when necessary and travel to and from trains.
3. When it is judged best to travel by train, where one has come by car, clergy rates by train will be paid.
4. When travelling by car, a basis of five cents per mile will be paid.

Fourteenth:—That the Committee on Itineracy and Orders decide on those who shall receive the benefit of payment or over-payment of our Conference Educational Budget.

Fifteenth:—The Secretary of the Canada Conference be the Committee on Credentials, and all Lay Delegates' parchments to the Conference be mailed to him one week previous to the opening session of the Conference

DAILY PROCEEDINGS

The Canada Conference of the Wesleyan Methodist Church of America in Canada convened for its Fifty-eighth Annual Conference in the Wesleyan Methodist Church in Ottawa, Ontario on Wednesday, April 27th, 1955, at 9.00 a.m.

Conference was called to order by the President, The Rev. H. Kielty, who also conducted devotional exercises.

Roll called.

Report of Committee on Credentials for Lay Delegates was read and adopted on motion.

It was moved and seconded and carried on motion that the first six seats on the East side of the Church and the first five seats on the West side constitute the Conference Bar.

The Committee on Temporary Organization read its report and it was adopted on motion.

The hours of Conference were set as follows:— 9.00 a.m. to noon and 1.30 p.m. adjourning by motion. Motion adopted on motion.

Committee on Audit gave a partial report and on motion it was adopted.

The Committee on Courtesy introduced to Conference Rev. E. Burton, assistant to the President at Houghton College who brought words of greeting.

It was moved and seconded and adopted on motion that all who are

introduced to Conference be invited to sit within the Conference Bar with the privilege to speak on all questions.

Carried on motion that we hear the President's report which was read by the President, the Rev. H. Kielty.

Upon motion the report of the Wesleyan Men's Fellowship was read and accepted.

It was moved and seconded and carried that the election of Officers and Standing Committees be held immediately after the calling of the roll and reading of the Minutes on Thursday morning, April 28th.

Carried on motion that we adjourn to meet at the call of the chair.

AFTERNOON MEETING, WEDNESDAY, APRIL 27

MORNING MEETING, THURSDAY, APRIL 28

"Communism is a real menace and the church of Jesus Christ can do more to thwart their power than arms."

"We need Love for God; His Word; His Work; His Will; and for those who are united in love for the Basic principles of Wesleyan Methodism."

AFTERNOON MEETING, FRIDAY, APRIL 29

An invitation was extended from the Belleville Charge for the next Annual Conference to be held in Belleville and it was accepted on motion. (On contingent of completion of the Belleville Church.)

It was moved, seconded and carried on motion that any business that has been overlooked be left in the hands of the President and his Advisory Board for completion.

At this point Dr. R. S. Nicholson asked leave to return to Syracuse as he had reservations on the plane leaving shortly.

The Rev. H. Kielty our President took the chair and proceeded to finish the business of this Conference Session.

It was moved, seconded and carried on motion that this Conference give the Secretary of Conference the sum of Fifty Dollars as an honourarium for his services.

The Missionary Board read their report to Conference and it was moved

and seconded that Item 3 be deleted from the report. (Motion Lost.)

Moved, seconded and adopted on motion that the report be adopted as read. (See Report No. 55.)

The President of the Women's Missionary Society read a financial report to Conference which was adopted on motion.

Committee on Budget read report and it was adopted on motion. (See Report No. 4.)

Minutes of preceeding sittings of the day were read, corrected and approved upon motion.

Carried on motion that we do now adjourn.

RELIGIOUS SERVICES

The opening service of Conference was held on Tuesday night, April 26, at 8.00 p.m.

The Rev. L. M. McCorriston brought the message from Phil. 3:20, "For our conversation is in heaven." His theme: "What is the purpose of the Wesleyan Methodist Church?" He spoke of "Our Citizenship"; "Free Citizenship"; and "Our Commonwealth". He uncovered some false doctrines which are afloat and told us we have a responsibility to raise up a standard for the people.

WEDNESDAY, 8.00 P.M.

Dr. R. S. Nicholson brought the message of the evening from the text found in Romans 8:28, "And we know that all things work together for good to them that love the Lord, to them that are called according to His purpose," and Eph. 3:20, "Now unto Him who is able." He gave us a wonderful message on his travels and how he proved that God is a specialist in hard cases. He told of Rev. Jacob DeShazer, and of God's process to prepare a missionary. The happenings in our lives that are consecrated to God are not accidental but "Providential."

THURSDAY, 8.00 P.M.

Dr. R. S. Nicholson's message was based on the words found in Acts 16: 19, 10, "Come over and help us." He told us of the poverty and distress in Japan in their heathen worship. Then of Korea and Formosa and their needs. It was truly a challenging message.

FRIDAY, 8.00 P.M.

Mrs. Ruby Riesdorph, General President of the Women's Missionary Society, gave a stirring address on foreign missions and their need. She spoke of the devotion of heathen worship and of a fire that had never been allowed to go out for over 400 years at one of their heathen shrines.

SATURDAY, 8.00 P.M.

The Conference W.Y.P.S. had charge of this service. Dr. F. R. Birch, General Secretary for Foreign Missions, brought the message. In it he stressed "The Cross"; "The Challenge"; "Communism".

SUNDAY, 10.30 A.M.

This was an ordination service, when the Rev. W. D. Mack and the

CONFERENCE PRESIDENT'S ANNUAL REPORT

TO THE MEMBERS OF THE CANADA CONFERENCE NOW IN SESSION:

In the good Providence of God we are all spared and privileged to meet in this the 58th Annual Session of our Canada Conference, in the city of Ottawa, the capital of our beloved Dominion of Canada, to do business for the King of kings and Lord of lords.

Our gathering may not have the headlines of the daily papers, as another assembly of men representing this dominion will have, yet, ours is the greater work, that of seeking the lost and winning them to the Lord Jesus. May we be so devoted to our God-given task, that we may plan wisely, constructively, and progressively for the year ahead.

Three trips were made to Houghton in the interests of the School and while the business sessions were lengthy, running even to the midnight hour, yet it was a spiritual uplift to sit with men of the faculty who really love the Lord and who are sacrificially labouring in the interests of Christian Education. Houghton College, with her most efficient and saintly President, Dr. Stephen W. Pain, and her devoted faculty members, is worthy of our earnest prayers and sincere commendation.

In a one-week tour of the Canada Conference last spring, a mixed Quartette, led by Coach George Wells, thrilled the hearts of many. DAILY PROCEEDINGS

April 27th, 1955—

The Women's Missionary Society of the Canada Conference convened for its Thirty-Fifth Session at Ottawa, Ont. on April 27th, 1955. Our President Sis. Bertha Wilson opened our Session with the singing of the hymn, "Blest Be The Tie That Binds", and Sis. Ruby Walker read the Scripture lesson from Philippians chapter two, verses three to sixteen. Special prayer was asked for by our President for God's guidance in our Conference Sessions and Sis. Monck and Sis. Brown led in prayer.

The Committee on Temporary Organization gave their report and it was adopted.

The Committee on Credentials gave their report.

Carried on motion that the first five seats constitute the Conference Bar.

Carried on motion that Sis. Shirley Summers and Sis. Leita Prindle be the auditors in the absence of the Auditing Committee.

Committee on Courtesy introduced Sis. Prindle and Sis. Monck to our Conference and they brought words of testimony.

Committee on Courtesy introduced Sis. Moffat of the Free Methodist Church and she brought words of greeting also a little exhortation on intercessory prayer.

Committee on Courtesy introduced Mr. Burton from Houghton College who brought us greetings from the College. He spoke of the particular aspect the ladies had of playing a real part in college life because it took the prayers of mothers and friends to help Houghton fulfill her duties to her students. He also gave a few brief gleanings from an address given by Dr. Rorke and made particular mention of three women that played an important part in Houghton. First was President Luckey's wife who was such a wonderful help to her husband when he was President and took such a keen interest in the students. Second was Professor Smith's wife and mother of two of the present faculty members, who was devoted to the work of the College and lastly was Clara Tear Williams who was a good neighbour and friend to many besides writing the wonderful hymn, "Satisfied". The spirit of these women lives on in Houghton and the Spirit of the Lord and all who study and pray there make Houghton College. He concluded his remarks with a request that we continue to pray for the students and all who labour there. At the close of his greetings we all sang the hymn, "Satisfied."

The Prayer Partner gave a very fine report and it was adopted.

The Magazine Solicitor gave a very good report and it was adopted.

Our Treasurer Sis. Gordon not being able to be present sent a letter of greeting which was read by the Secretary to the Conference.

Carried on motion that the election of Officers be held on Thursday afternoon following the reading of the Auditor's and Treasurer's Reports.

Motion to adjourn. Prayer by Sis. Horner. Offering—\$6.65.

April 28th, 1955—

Our Session was opened by our President Sis. Wilson with the singing of the hymn, "I Will Pour Water Upon The Dry Ground". Sister Helen Smith read the Scripture lesson from 1 Cor. tenth chapter, verses twenty-six to thirty-three inclusive after which she led us in prayer.

Roll Call was given and the Minutes read and approved.

The Auditing Committee gave their report and it was adopted.

The Treasurer's Report was read and adopted.

The Y.M.W.B. report was read and adopted. Five Bands were on the Honour Roll.

The Nominating Committee read their report and it was accepted.

After the election of Officers we sang together the old hymn, "Take My Life and Let It Be".

We had a standing vote that if it were possible, Sis. Inda Watts, would represent our President at General Conference as our President is unable to go.

The Committee on Courtesy introduced Dr. Nicholson and he brought us words of greeting. There were two things he wanted to leave with us. First that Womanhood under the influence of Christianity is blessed beyond any other womanhood. Women in non-Christian lands are slaves and servants of man, bearing burdens on their heads and backs. Love is missing. It is marvellous the difference Christianity has made amongst the women in these lands. There are many things our missionaries have to fight and work against that we know nothing of. The second thing that Dr. Nicholson wished to leave with us was that he has dedicated himself never to speak or write to people without asking them to pray for the people in the heathen lands that are bound by such heathen customs. He asked us not only to pray for the missionaries but pray also for the Christian natives who need our prayers so much. We ought to spend the rest of our days thanking God we were born in a land where people worship a living God.

Dr. Nicholson was thanked by our President for his inspiring talk.

Motion to adjourn. Prayer by Sis. Gleason. Offering \$7.40.

April 29th, 1955—

Our President, Sis. Bertha Wilson opened our Session with the singing of the hymn, "From Every Stormy Wind That Blows." Sis. Gleason read the Scripture Lesson from Matt. 14th chapter, verses fourteen to twenty-one inclusive after which she led us in prayer.

Roll Call was given and the Minutes read and approved after correction.

Committee on Courtesy introduced Sis. Reisdorph to our Conference and she brought words of greeting.

The Committee on Thanks read their report and it was adopted with a recommendation that it be read in the Sunday afternoon service.

The report of the Mission Study Secretary was given and adopted with the proviso that the Secretary may add to the report any non-members who have read the reading course.

Sis. Watts asked each Society to stress the Fast and Prayer Plan.

A motion was made and adopted that on the recommendation of Sis. Reisdorph a petition be sent to the General Conference to seat Sis. Inda Watts in the Conference as a representative acting for the President of our Conference.

In the absence of Sis. Verda Hamilton, Sis. Sinclair presented the Honour Societies of the Y. M. W. B. with their Certificates.

The Statistical Report was read and adopted.

Several items of interest were discussed and clarified by Sis. Reisdorph.

Carried on motion that Standing Rule No. 4 be changed to read—One Statistical Form be sent to the Conference Secretary on or before April 15th.

The Committee on Resolutions read their report and it was discussed item by item.

Item No. 1. Approved.

Item No. 2. Discussed and approved.

Item No. 3. Discussed and approved.

Item No. 4. Discussed, amended and approved.

Item No. 5. Approved.

Item No. 6. Approved.

The Report was then adopted as a whole.

Carried on motion that the Secretary write Sis. Dunbar, Sis. Gordon and Sis. Hamilton, expressing our regrets for their absence from our Conference and a special thanks to Sis. Gordon for her labours as Treasurer through the past years.

Carried on motion that the delegates take home the suggestions of methods of raising church extension funds as discussed in our Session and use the ones that are most applicable to their Society.

Our President suggested we continue to send an offering for the printing of the Minutes.

Unless you are informed otherwise, continue to send in the Administrative Fund of twenty-five cents per active member.

Carried on motion that any unfinished business be left in the hands of the President and her Executive Board.

At the close of our Session Sis. Reisdorph gave us a short exhortation and shared with us some of her experiences in Africa.

With the singing of "Praise God From Whom All Blessings Flow", our Sessions were ended and Sis. Watts closed in prayer. Offering—\$7.15.

RELIGIOUS SERVICES

The Friday Evening service of the Annual Conference was opened with the singing of the hymn, "Jesus Saves", led by Mr. Jack Smith, after which Rev. J. S. A. Spearman led in prayer. Sis. Ruby Reisdorph favoured us with a solo, "I Heard The Voice of Jesus Say". After the announcements Sis. Reisdorph, our speaker of the evening had the ushers give out to the congregation the booklet entitled, "Moving Northward". Sis. Reisdorph showed us two flags that at one time flew on Queen Elizabeth II's car and gave us an interesting account of the duties of the Queen's Chief Yeoman. She compared his duties to that of the missionaries who are busy setting up the Standards of the King of Kings and Lord of Lords.

The offering was lifted and Sis. Grace Presley and Sis. Ethel Young sang the beautiful hymn, "How Much I Owe".

Sis. Reisdorph began her address of the evening by showing us some momentos she had brought home with her while she was on her world tour of the mission fields. With the showing of each one she had an interesting story to tell. She shared with us some of her experiences while visiting the various mission fields. Going to Africa she told of an experience she had, that of the death of an old pagan man. She told of the dances held outside and inside of his hut and how she tried to point the old man to the Sacrifice of the Lamb he could trust in and to confess his sins. Before he died three days later he sent for the native pastor to baptise him. He said he had renounced all his sins so the pastor baptised him and he passed away soon after and was given a Christian burial. While visiting the island of Formosa, Sis. Reisdorph visited a leper colony. The lepers had built a beautiful church where she had the privilege of speaking one Sunday. One young man with a shining face had led fifty-two lepers in one year to Christ. When she left they sang the hymn, "God Will Take Care of You" for her. In closing her message Sis. Reisdorph threw out the challenge to the women of the W.M.S. to put Christ in the midst and let Him lead. It is not too much to ask God to give us a tithe of our members for the foreign fields. But we don't need to go to the foreign fields, said she, to see the need which is on every hand. God is here to enable us to recognize Him in our midst. The Lord Thy God in the midst of Thee is mighty. She closed with a heart felt prayer. Offering amounted to \$23.88.

The Sunday afternoon service opened with the hymn, "Jesus Calls Us O'er the Tumult" led by Mr. E. E. Wilson, and Sis. Gleason led in prayer. Our President Sis. Bertha Wilson introduced the Executive Officers to the congregation after which the Committee on Thanks read their report. The hymn, "The Call for Reapers" was sung and Sis. Bertha Major and Sis. Ruth Irish sang a duet, "Shall I Empty-Handed Be?" Sis. Wilson introduced Dr. Birch our speaker of the afternoon who opened his remarks by giving us an account of his call to Africa. He urged young people not to be afraid to obey God's call as He goes ahead and prepares the way. He believes the worst is over for India for the time being but missionaries from the Commonwealth will be allowed in India for some time yet so he remarked he would be sending to Canada for missionaries for India. On account of a shortage in funds in the past year, Dr. Birch asked us to pray that God will undertake and send in the needed funds that the missionary activities will not have to be curtailed too much. Other fields are getting along well.

In Africa the new school building is still inadequate. They have one hundred and thirty attending with sixty sitting on the floor. There is a great new movement over the northern part of Sierra Leone. Africans are coming to the place where they can take over the leadership of their own churches. Most of the Offices of the Conference have been turned over to Native workers. The pressure in Columbia has lessened for the time being and they are going forward. One of the most encouraging fields is Haiti where four hundred and thirty have been baptised. The work there is really making progress. The greatest need is a hospital, especially a T.B. Sanitarium as there is a real scourge of T.B. caused from malnutrition and poor living conditions. Dr. Birch illustrated our missionary giving with the parable of the feeding of the Five Thousand. The small lunch that was given was multiplied to feed the multitude and just so the little we are able to give, God can take and multiply it to be used to reach out to others. Dr. Birch mentioned that if we want a carload of missionaries for a Missionary Convention he will arrange to send them. After asking us to especially remember the General Conference when we prayed, he closed his message with prayer. The hymn, "Lead On O King Eternal" was sung and Rev. Kielty pronounced the benediction. Offering amounted to \$55.58.
