DAILY JOURNAL

First Day. Tuesday. Evening Meeting

The Champlain Annual Conference of the Wesleyan Methodist Connection (or Church), of America, convened for its seventieth session at Chittenden, Vermont, April 18, 1911, at 7:30 p.m.

Rev. E. D. Carpenter, the president, called the conference to order, and declared the session open for preliminary business.

A service of song and prayer full of inspiration and spirit was enjoyed by all. S. A. Warner, one of the oldest members of the conference, led in prayer, and was followed by C. E. Hill. Immediately after this season of grace the following items of business were transacted:

Committee on Examination of Character, E. D. Carpenter, chairman; A. J. Allen, I. L. Prouty.

On Credentials, S. J. Liberty.

On Religious Services: O. G. Wyman, E. D. Carpenter, and A. P. Lienard.

Motion was approved that upon the adjournment of this service, it be to meet at 9 o'clock tomorrow, Wednesday, morning.

Pursuant to the election of the annual session of 1910, Rev. S. J. Liberty preached the opening sermon. The text used was 2 Corinthians 4:6: "For God, who commanded the light to shine out of darkness, hath shined in our hearts to give the light of the knowledge of the glory of God in the face of Jesus Christ."

The evening meeting was concluded by a testimony service

during which a large number spoke of the knowledge of the light of God as having shined in their hearts, both in saving, and sanctifying, and in preserving power.

Benediction by A. P. Lienard.

Second Day. Wednesday. Morning Meeting

C. C. Hill had charge of the devotional service, the time of which was wholly devoted to prayer.

At about 9:30 o'clock the president called the conference to order for business.

The minutes were read and approved.

The Committee on Credentials make a partial report. Said report was adopted with the provision that any further names be added to the roll who come with proper credentials. See conference roll.

The conference president now makes his report, which was adopted. See report number one.

The bar of the conference was fixed at the first four tiers of pews with the side slips.

The Connectional editor is introduced who makes remarks.

The Connectional agent is also introduced. In remarks he states that next to fellowship with God is the privilege of meeting in fellowship with His people.

A partial report is made by the Committee of Itineracy and Orders. Same is adopted. See report number two.

The Committee on Orders of the Day make their report, which is as follows: Election of delegates to the General Conference, 2 p.m. Wednesday; Election of conference officers, Thursday 10 a.m.; Hearing the report of the Connectional Agent, Thursday 2 p.m.; Superannuated Ministers' Relief Association, Friday 9:30 a.m.; Educational report, Friday 10:30 a.m.; Missionary meeting, Friday evening; Memorial service, Saturday 10 a.m.; Publishing interests of the Connection, Saturday 2 p.m.; Rev. A. T. Jennings to have charge of religious services at 3 o'clock in the afternoon each day. Report approved.

Upon approved motion the time of the meeting of conference sessions was fixed as follows: Opening, 9 a.m., and 1:30 p.m.; closing, 11:30 a.m., and to close by vote in the afternoon.

The following committees were filled, the chairmen of which had been previously appointed by the president:

Motion approved to invite to honorary seats in the conference all visiting members of our own and other orthodox churches who are not members of oath-bound secret societies.

By consent the fixing the time and place of the next session of the conference became the business of the hour. Three invitations were given, Lisbon Center, West Plattsburg, and Glens Falls. Upon the calling of the roll, Lisbon Center was chosen as the place, it having received a plurality of votes.

The time was fixed by vote as the first Tuesday after the third Monday in April, 1912, at 7:30 p.m.

S. A. Warner was elected to preach the opening sermon, and W. A. Wilson as the alternate.

The question of a change relative to the article in the Discipline on the use of tobacco was now brought before the conference. The proposed change was as to the making its use a test of membership. The vote was taken by yeas and nays. Upon the calling the roll it was found that the yeas were eleven and the nays fourteen.

A motion was approved that a vote be taken by the local churches upon making tobacco a test of membership, in the month of June, and that the result of said vote be immediately sent to the secretary of the conference.

The passage of character was now taken up. The following names were called and their characters passed: W. E. Perry, Geo. D. Jock, F. L. Wright, Wm. Rist.

A motion to adjourn was approved that the committees might meet for organization.

Benediction by E. Trowbridge.

Wednesday. Afternoon Meeting

The devotional service was conducted by C. E. Hill, who read the sixth chapter of 2 Corinthians.

The minutes read and approved.

The order of the day which was the election of the delegates to the General Conference had now arrived.

Tellers were appointed by the president as follows: LeRoy C. Mattoon, Byron Chambers.

Revs. E. D. Carpenter, C. E. Hill, and A. P. Lienard were elected as the ministerial delegates. Henry A. Elliott, Harley Hill, and Byron Chambers were elected as the lay delegates.

The order of the day having arrived Brother A. T. Jennings was given charge of the service. A most soul inspiring and heart comforting discourse was delivered by him from Genesis 1:2, "Ai.d the earth was without form, and void; and darkness was upon the face of the deep. And the Spirit of God moved upon the face of the waters."

At the conclusion of the order of the day the unfinished business was taken up and the alternate delegates to the General Conference were elected. The alternate ministerial delegates were elected as follows: A. J. Allen, L. C. Mattoon, W. A. Wilson. The alternate lay delegates were elected as follows: R. J. Johnston, I. L. Prouty, Chas. B. Armstrong.

The names of E. D. Carpenter and J. J. Davison were called and characters passed.

Adjourned upon approved motion.

Benediction by A. J. Allen.

The service was opened by song and prayer, after which Rev.

Wednesday. Evening Meeting

A. J. Allen preached the Word from Ezekiel 33:11, "Why will ye die?" Brother W. J. Seekins followed with a stirring exhortation and made an altar call. A number of needy and hungry seekers came to the penitent form. The altar service was a time of especial refreshing.

Third Day. Thursday. Morning Meeting

A. P. Lienard conducted the devotional exercises.

At the roll call thirteen elders, four licentiates, and fourteen delegates responded.

Reading and approval of minutes.

Passage of character was taken up: the following names were called and characters passed: A. J. Allen, C. E. Cahee. The request of C. E. Cahee that he be granted the privilege of supplying the St. Rhegis Indian Mission, and still retain his conference relations, was granted.

The name of E. E. Curtis was called. The president announced that the brother had fallen asleep in Jesus, and gone to his reward; also that suitable memorial services would be held Saturday in the forenoon.

The names of C. E. Hill, C. C. Hill, A. F. Lent, and A. P. Lienard were also called.

The election of conference officers was now the order of the day.

S. J. Liberty was appointed to act as teller in the absence of L. C. Mattoon.

The ballotting resulted in the election of the following officers:

E. D. Carpenter, president; C. E. Hill, vice-president; A. P. Lienard, secretary; W. A. Wilson, assistant secretary; A. J. Allen, treasurer; Charles E. Hill, trustee for a term of five years; William A. Wilson to fill the unexpired term of John L. Benton, made by his transfer to the Lockport conference.

A. J. Allen was elected to fill the vacancy made in the Com-.

mittee of Itineracy and Orders by the expiration of the term of one of its members.

W. A. Wilson was elected as Tithing Secretary.

A motion was approved to allow the president to nominate his Advisory Board.

The Judiciary Committee was filled as follows: J. J. Davison, C. C. Hill, C. E. Hill, S. A. Warner.

Committee on Presidency: L. C. Mattoon, A. P. Lienard, S. J. Liberty, Henry Elliott, I. L. Prouty.

Missionary Board: E. D. Carpenter, chairman ex officio; W. A. Wilson, O. G. Wyman, president of the Woman's Home and Foreign Missionary Society, W. G. Olney.

The matter of the Emanuel Wesleyan Methodist church of Chazy, N. Y., regarding their request to be supplied from West Chazy referred to the Committee on Boundaries.

The names of S. J. Liberty, A. E. Moses, and T. A. Moses were called and characters passed.

Adjourned by vote.

Benediction by A. H. McKnight.

Thursday. Afternoon Meeting

O. G. Wyman had charge of the devotional service.

At the roll call thirteen elders, four licentiates, and fourteen delegates answered to their names.

Minutes read and approved.

The president nominates A. J. Allen and R. H. Keyes as his Advisory Board. The same was approved by the conference.

The Connectional agent is now heard as to Connectional interests. In his report were many things of great encouragement. The great financial burden under which some of our societies have been struggling is being greatly relieved, and indebtedness encouragingly reduced. The Publishing interests are in a way much more hopeful, and the publication of the Wesleyan Methodist is entering upon a more hopeful basis. The Sunday-school supplies are producing a small profit. Our educational institutions are doing excellent work in their fields. But their financial needs are great. Anyone can

immeasurably glorify God and bring to themselves a great degree of blessing if they will honor the Lord with some of their means by making liberal donations to the Educational Society.

O. D. Putnam, J. Quay, and K. F. Schaubhuth were called and their characters passed.

Religious services now became the order of the day, and Brother A. T. Jennings thrilled the audience with a most helpful address from Genesis 41:47. This text means that there is such a thing as receiving more than enough—"The earth brought forth by handfuls." It speaks of Jesus coming to bring life more abundantly. It suggests the provident God from whose storehouse the saint can draw largely for every spiritual need. This superabundant provision is of love, sympathy, fidelity, etc. In this unusual provision lies the success and fruitfulness of the life and work of the saint. "Surely goodness and mercy shall follow me all the days of my life."

Adjourned by vote.

Benediction by S. A. Warner.

Thursday. Evening Meeting

The evening meeting was opened by a song and prayer service led by Mr. Byron Chambers. Following this the Word was preached by W. J. Seekins, Connectional agent, from Galatians 1:4, "Who gave himself for our sins, that he might deliver us from this present evil world, according to the will of God and our Father, to whom be glory for ever and ever. Amen." Quite a number came to the altar for either pardon or purity. Some of them left rejoicing in their new found grace.

Fourth Day. Friday. Morning Meeting

L. C. Mattoon conducted the devotional exercises.

At the roll call thirteen elders, four licentiates, and fourteen delegates responded.

Minutes read and approved.

The Committee on Resolutions make their report, and the same is adopted. See report No. 3.

The committee to apportion the expenses of the delegates to the General Conference make their report, which was adopted. See report No. 4.

By consent at the president's suggestion the conference takes a recess that the Superannuated Ministers' Relief Association might have the opportunity to have the meeting of said Association.

For minutes of same see report No. 5.

Upon the adjournment of the Superannuated Ministers' Relief Association the conference resumed business.

Mrs. Jennie Ayers, General Conference organizer of the Woman's Home and Foreign Missionary Society, was introduced, as was also Miss Florence Yorton, a returned missionary from the field in Africa.

The Camp Meeting Committee make their report, which was adopted. See report No. 6.

A Camp Meeting Committee was elected as follows: E. D. Carpenter, the pastor of the West Chazy charge, A. J. Allen, pastor of the Mooers charge, A. N. Bedell, J. M. Atwood, C. E. Hill.

Hearing the financial secretary of the Connectional Educational Society was now the order of the day. E. D. Carpenter had arranged with Brethren Jennings and Seekins to present the interests of the same. Both Brethren made interesting and convincing addresses showing the absolute necessity of our institutions of learning to the success and usefulness of our denomination. A clear statement of the financial condition of the various schools revealed the need of six thousand dollars above all resources to meet the expenses of the year, and close the same free of debt. At the appeal for funds to meet this need a generous response was given, amounting to \$353.

That the entire membership of the conference might bear its share of this obligation, the following committee was appointed by the president, upon the motion of the conference, to opportion to each church their proper proportion of the amount: L. C. Mattoon, O. G. Wyman, W. A. Wilson, S. J. Liberty, A. J. Allen.

Adjournment by limitation of time. Benediction by William Lamoy.

Friday. Afternoon Meeting

S. A. Warner had charge of the devotional service.

Thirteen elders, three licentiates, and thirteen delegates responded to the roll call.

Minutes read and approved.

The following names were called and their characters passed: F. E. Wood, Arthur Baker, A. S. Haven, C. A. Heath, C. E. Fox.

The Committee on Apportionment to the various churches of the deficiency in the funds for the expenses of the schools make their report. The same is referred back to the committee for reconsideration and correction.

The Committee on Boundaries make their report, which is considered item by item.

The first item of the report is adopted upon vote.

Upon an approved motion, the two parts of the second item are adopted.

A motion is now made to adopt the report as a whole which was carried. See report No. 10.

Religious services now becomes the order of the day. Brother A. T. Jennings gives a very helpful and practical address from Rev. 12:7-11, "And there was war in heaven: . . . And they overcame him by the blood of the Lamb, and by the word of their testimony; and they loved not their lives unto the death."

At the close of this service an offering was taken, the same to go to the secretary for his services. The offering amounted to \$7.76.

The committee whose duty it was to apportion the Educational Fund again report. Said report is adopted. See report No. 7.

Upon an approved motion the treasurer was authorized to pay the remainder above the offering required to make the sum of ten dollars for the services of the secretary.

The name of L. C. Mattoon was called and character passed.

Committee on Resolution make additional report. See report No. 3.

Adjourned by vote.

Benediction by Edward L. Elliott.

Friday. Evening Meeting

The service of this evening was missionary in character the report of which will occur in the minutes of the Woman's Home and Foreign Missionary Society. See report No. 8.

Fifth Day. Saturday. Morning Meeting

Devotional service led by E. D. Carpenter. The 34th Psalm was read as a Scripture lesson. J. D. Russell, C. A. Heath and A. H. McKnight offered prayer.

Roll Call. Fourteen elders, four licentiates, and thirteen delegates responded.

Characters were passed as follows: G. H. Bort, S. C. Fox, N. J. O'Brien, C. P. Sage, W. A. Wilson, Edward L. Elliott, W. H. Lamoy, O. G. Wyman.

Memorial Service.

This service was in charge of Brother C. E. Hill. Singing, "Nearer My God to Thee."

Prayer, C. C. Hill.

The following Brethren made remarks of memorial character:

A. P. Lienard, E. D. Carpenter, S. A. Warner, C. E. Hill. Singing, "Blest be the tie that binds."

Benediction, A. J. Allen.

The Committee on Itineracy and orders make their report, which was adopted. See report No. 2.

Treasurer's report adopted. See report No. 9.

An additional report is made by the Committee on Boundaries, which covers two items. See report No. 10.

A motion was supported requesting the pastors to secure and remit to the conference treasurer on or before the first of October, the apportionment made to their respective charges, to defray the expenses of the delegates to the General Conference.

By motion of the conference the President was authorized to appoint the chairmen of the various committees which are to report to the next annual session of the conference.

The president was further empowered to arrange for religious services each afternoon during the next session of the conference, and to secure some person to have charge of such services.

Upon motion the secretary was instructed to prepare the standing resolutions of the conference for printing, and to send a a printed copy of the same to each pastor of the conference.

Adjourned by vote.

Benediction by Arthur Baker.

Saturday. Afternoon Meeting

A. J. Allen was in charge of the devotional service.

Roll call: fourteen elders, three licentiates, and twelve delegates responded.

Minutes read and approved.

C. P. Sage asks for letter of standing which is granted.

Inasmuch as N. J. O'Brien failed to take his superannuated offering, it became necessary to pass his character by vote of conference, which was done.

The Missionary Society make their report through the secretary which was adopted. See report No. 8.

The Committee on Resolution make a further report, which is adopted. See report No. 3.

Because of the inconvenience and difficulty to hold holiness conventions in the Vermont and Adirondack districts, a motion was approved to unite the two, forming one district, and C. E. Hill was elected chairman of the same.

The St. Lawrence and the Champlain districts were also united

by vote into one district, to be known as the St. Lawrence and Champlain district, and A. P. Lienard elected the chairman.

The Committee on Pastoral Relations report. See report No. 11. Religious services was now the order of the day, and Brother Jennings preached a most effective discourse from 1 Timothy 1:11, "According to the glorious gospel of the blessed God which was committed to my trust." In the discourse it was clearly made evident to all who heard that the fire spoken of so much in the Word and the glory of God are the same, and that it is his covering. This glory is to be imparted to the saint as a holy fire which will make the life useful in pointing men to the Lord, as also in radiating out as a blessed illumination among the people.

Upon resumption of business the Committee on Statistics make their report and the same is adopted. See report No. 12.

The conference upon motion voted Brother A. T. Jennings a unanimous vote of thanks, expressive of their gratitude and appreciation for his faithful preaching the Word during the week of the conference. These afternoon hours of devotion were unusual sittings together in heavenly places with Jesus. As the Gospel likt oil fell from the lips of our brother, it brought healing and gracious soul development. The inspiration for nobler things in the service of the Master received from them by both ministry and laity will mean added power and success to the different churches throughout the borders of the conference. All were brought, not only in closer touch with their Lord and King, but also with their fellow man. It will mean a greater loyalty to God, and a richer sympathy for each other.

Minutes read and approved. Voted to adjourn to the call of the chair. Benediction by S. A. Warner.

Saturday. Evening Meeting

The Rev. C. E. Hill preached the Word at this service. Following the discourse was an altar service. Several came earnestly

seeking spiritual help. It is believed that at least a part of these went away rejoicing in their new found grace.

SUNDAY SERVICES

The day opened with a love feast in the charge of J. J. Davison. A goodly number availed themselves of the privilege to give testimony to the efficacy of the blood to save from the transgressions of life, and also the sin of the heart, making the soul perfect in love, thus enabling the person to love Jesus with all the heart, the soul, the mind, and the strength.

Following the love feast Rev. A. T. Jennings preached the Word from Revelation 14:6, "I saw another angel fly in the midst of heaven, having the everlasting gospel to preach unto them that dwell upon the earth, and to every nation, and kindred, and tongue, and people." The sermon was an ordination discourse. Two brethren, Orion G. Wyman, and Edward L. Elliott, were to be set apart as elders in the Wesleyan Methodist church by the right of ordnation. As such elders they are "to preach the everlasting Gospel" of Christ to all men everywhere. It is a Gospel of holiness, and must be proclaimed in all its fulness, with the idea of immediate acceptance. If the shepherd is to herald it in its entirety, certainly it is as much the duty of the flock to eat the food given. The matter of this preaching partakes of the nature of conviction, repentance, faith, regeneration, sanctification, etc. The power to proclaim this gospel comes in the line of obedience-"to them that obey him." It is intensified by prayer in which the heart is brought into the most intimate touch with God, who is the source of ability and strength.

The evening service was preceded by the administration of the Lord's Supper. Eighty-four of the children of the Lord partook of the same to their comfort and spiritual uplift. Following this service Brother Jennings again praeched the Word, selecting Psalm 90:17, John 15:2, and 1 Corinthians 15:58 as a foundation for the

gracious words which fell from his lips. Here is one of the rich gems which he scattered among the congregation: "As Christians. we will never amount to much till we come to a place where we will cheerfully give up many moderately good things on a low level of life for a very much better thing on a high level of life."

This the seventieth annual session of the Champlain conference closed in a precious spirit of heavenly fellowship. A seemingly divine unity pervaded the entire series of services. God was manifest; His glory reigned over all. The preaching was of a high order, conviction came upon the people, some yielded and were made to rejoice; the saints were comforted, and lifted to heavenly places with Christ. Pastors and laity absorbed rich food for the soul, and return to their homes with a deeper, sense of loyalty, and a more fervent and aggressive spirit.

Two offerings were taken during the day, that in the morning amounting to \$30.36; that of the evening to \$14.45.

No. 10. Boundaries

Two matters have been presented to your committee for their consideration: First, a dispute as to the occupancy of the First Wesleyan Methodist church at Johnsburg, N. Y., which appears to be quite a serious matter. Your committee can see two ways for a settlement, that of a legal process; and the other, a peaceful

settlement. Of course your committee does not advise the legal method until every other means of settlement is peacefully exhausted. We recommend the matter be placed in the hands of the Rev. E. D. Carpenter and Rev. C. E. Hill, with the request that they use every effort in their power to settle this unfortunate trouble peacefully. Second, a request from the Chazy church; this request is in two phases. I. They ask to be an appointment of the West Chazy charge. If this can be satisfactorily arranged, we recommend that it be done. As West Chazy is not represented in conference it is hard for us to fix boundaries of this new church. We recommend that the Chazy and Mooers churches settle the question of boundaries among themselves. 2. Said Chazy church requests a loan of \$1000 to pay up the indebtedness on their new church building, from the conference, and offer a mortgage on the property to secure the loan. As we understand the situation, if the church will faithfully pledge themselves to pay the interest, keep a proper insurance on the building, and pay a portion of the principal annually, we recommend the loan, providing it is within the power of the conference to do so.

Your Committee on Boundaries beg leave to submit the following additional report:

I. Inasmuch as there has been no services held by the Wesleyan Methodist people in the church at Newcomb, N. Y., for more than two years, and the membership being nearly or quite extinct, therefore we recommend that the Champlain conference relinquish all claims to the use of the property, and that the name be stricken from the roll of charges.

2. Whereas the church at Bangor is without a pastor, we recommend that instead of two charges, Bangor and Cooks Corners, there shall be but one, to be known as The Cooks Corners and Bangor charge.
