

CONFERENCE RESOLUTIONS

I. The Resolutions of Conference shall be printed in the Conference Minutes each year.

II. All visiting members of our own, or other Churches in harmony with our principles, shall be invited to honorary seats in the Conference.

III. The Conference President shall receive twenty dollars (\$20) per year for postage and stationery; also any needed traveling expense. At any time the President be required to travel the Conference, his duties and pay shall be defined by the Conference.

IV. The Conference Secretary shall receive twenty-five dollars (\$25) per year for his labor and incidental expenses.

V. The Conference Treasurer shall receive twenty-five dollars (\$25) per year for his services in caring for the funds.

VI. In making his report, the Conference Treasurer is authorized to close his books one week before the Conference session. The Treasurer of the Superannuated Ministers' Relief Association also shall close his books one week before the Conference session.

VII. In our Camp Meeting work, after the expense of the Camp Meeting has been paid by the Camp Meeting Committee, or by the person whom they may designate, any unexpected balance shall be turned over to the Conference Treasurer.

VIII. All monies disbursed by the Conference Treasurer during the interim of Conference shall be upon order of the President, except in case of payment to the President, when such order shall be issued by the Vice-President. It is understood, of course, that any payment ordered by the Conference direct may be paid by the Treasurer without an order as directed above.

IX. No monies shall be loaned by the Conference Treasurer except by order of Conference, or by consent of the President and his Advisory Board.

X. Each elder shall make his engagement as pastor with the understanding that if he be elected Conference President he shall be released in his pastoral engagement.

XI. The first Sunday in each month shall be known as Home Mission Sunday, and the Sunday School offerings shall be given to Home Missions, and should be sent to the Conference Treasurer.

XII. In securing Evangelists for the Camp Meeting work, those of the Wesleyan Methodist Church shall be secured, if this can be done.

XIII. The Camp Meeting Committee shall be composed of the Conference President as Chairman, and three ministers, and three laymen, all to be elected by ballot after the Conference of 1923, the term of office to be three years, the time of one minister and one layman expiring each year.

XIV. Pastors shall state financial items in their statistical reports in even dollars, except in items affecting the Budget, and so far as possible are requested to report all budget items in even dollars. When such rule is not followed, the Statistical Secretaries are authorized to drop decimals, except as provided above.

XV. The offerings for Superannuated Ministers shall be taken within sixty days after Conference, and forwarded to the Treasurer of Superannuate Society.

XVI. That the Preachers in reading their reports at Conference read only items in the aggregate.

XVII. That the Committee on Credentials secure the necessary credentials as provided by our Discipline, from each delegate, with the post office of the same.

DAILY JOURNAL OF PROCEEDINGS

The Champlain Conference of the Wesleyan Methodist Connection, or Church of America, convened for its Ninety-seventh annual session on the Camp Ground at West Chazy, N. Y., June 28th, 1938.

The Tuesday night meeting was in charge of the President. After singing and prayer, Mrs. Flora Ressler brought the message of the evening. The Business meeting was called for at 8:30 Wednesday a. m.

Wednesday Morning Meeting

There was a devotional period at 8:30 a.m. Leader, Rev. F. C. Taylor.

Business was called at 8:45 by the President, Rev. G. D. Jock. The roll was called, with eleven Elders, four Conference Preachers present.

The Committee on Credentials made a partial report. Motion was carried that other Delegates' names be added to the roll without a vote of Conference. The Bar of Conference was fixed to include the first five rows of seats in the front of the tabernacle. Time was fixed for opening and closing of Conference as follows: Opening with Devotions at 8: 30 a. m. Business meeting at 8:45, closing 11: 30. Afternoon, opening at 1: 30, closing by vote. The Conference President's report was called for and given. See Report. Report was accepted.

Rev. Roy S. Nicholson, our Connectional Sunday School Editor and Rev. J. O. Yount were introduced to Conference, each making fitting remarks.

Rev. C. C. Murray and Mrs. Flora Ressler were elected to assist the Statistical Committee.

Rev. D. K. Livingston and Mrs. Flora Ressler, were introduced to Conference. Rev. Livingston is pastor of the new Wesleyan Methodist Church at Schenectady, N. Y., and Mrs. Ressler is new to the Conference, being pastor at Cooks Corners, N. Y.

Rev. S. H. Miller was elected first member of the Committee on Passage of Character. Lay member, H. S Hall.

Rev. H. C. Shares of the Rochester Conference was introduced to Conference and made touching and appropriate remarks.

Committee on Pastoral Relations was elected as follows: Elders, O. M. Finch, C. A. Dayton, F. C. Taylor; Lay members, F. D. Matoon, Edward Mein, L. A. Stafford.

Conference voted that the morning prayer meeting be from 7:30 to 8:15. S. H. Miller was elected leader.

Conference took a recess, to give way for a meeting of the Superannuate Society. See report of that Society.

Conference adjourned by vote. Benediction by Rev. K. D. Livingston.

Wednesday Afternoon Meeting

Devotions at 1:30 in charge of Rev. Reginald Hewitt.

Business. Roll was called and minutes of morning meeting were read and approved.

Rev. Ann Wilson of Lawrence, Massachusetts was introduced to Conference, making appropriate remarks. The following names were called and characters passed: E. D. Carpenter, J. J. Davison.

Motion was carried that Conference recess for five minutes to an Order of the Day, that of hearing the Conference sermon. Rev. O. M. Finch having been elected to preach the Conference sermon was present and brought the message.

Conference adjourned by vote. Benediction by Rev. C. A. Dayton.

Thursday Morning Meeting

Morning devotions were in charge of Rev. Leon Barse. Scripture reading from the 34th Psalm.

Rev. F. H. Wright was introduced to Conference and brought greetings from his father, Rev. J. F. Wright, also appropriate remarks in regard to his relationship the Champlain Conference.

The name of Rev. Russell Frase was called and his character passed. Conference took a recess for five minutes until time for an Order of the Day, the afternoon sermon. Rev. H. Robb French, evangelist for the camp brought the message.

Conference adjourned by vote. Benediction by C. C. Murray.

Saturday Morning Meeting

The name of Rev. H. R. LaVere was called and his character passed. Motion was carried that Conference give Brother LaVere a rising vote of thanks for his faithful service in caring for the funds of the Conference. The Statistical Report from Hadley was read by the Statistical Committee.

The following names were called and characters passed: L. C. Mattoon, C. R. Stopp, F. C. Taylor, Leon Barse.

In the matter of a title to the Chazy church property the motion was made that the Conference give F. H. Tyler a title to the property, Mr. Tyler to pay the court order. The vote follows: Vote by roll call, 31 votes cast, all of which were AYE.

Motion was made and carried that the Ministerial Institute be not held this year, on account of the Institute at Houghton.

Motion was made and carried that the division of the Conference into Districts for the holding of Holiness meetings remain as last year, Northern and Southern. Rev. H. S. Miller was elected Chairman of the Southern District, Rev. C. L. Hill for the Northern District.

A resolution was offered by C. C. Murray, which was adopted. See resolution.

Motion was carried that Rev. C. R. Stopp investigate the matter of pastoral insurance.

Conference gave Rev. Roy S. Nicholson a rising vote of appreciation for his services.

REPORTS

PRESIDENT'S ANNUAL REPORT TO CONFERENCE

To the Members of the Champlain Conference: Greetings in the name of the Lord. Another Conference year has come and gone, reminding us of the swift passing of time.

We pause to look back over the past Conference year, to note the great things God hath done for us. I believe that God has visited nearly every charge with special revival meetings during the year, thus many great victories have been won, also a good meeting of three weeks duration was held in Malone, N. Y., the county seat of Franklin County, Rev. E. E. Reiber and Rev. C. R. Stopp were the workers in the campaign. This meeting was under Conference supervision. While we did not organize a church there, we believe that it will be possible to do so at a later date. There are some interested persons there.

We are able to report a church organized at Schenectady, N. Y. with about 20 members. They have purchased a building located on State St. suitable to be used for church and parsonage.

We predict a strong church will be developed in that thriving city within a short time.

Report No. 4

PLAN OF WORK

The Committee recommends:

1. That each local society shall have some Missionary Study or Program at each meeting to broaden our vision and inspire us to pray definitely for our work and workers. Aids to this are the study book, Missionary Magazine and correspondence with our missionaries.

2. That each society shall have at least one public meeting in which missionary needs shall be emphasized.

3. That we observe special days as Harvest Day, "Wesleyan Missionary Day" and World Day of Prayer.

4. That each society elect a solicitor for the Wesleyan Missionary to keep the Magazine in circulation.

5. That the President be a subscriber to the Wesleyan Missionary and the Wesleyan Methodist, also the Secretary and Treasurer and fifty per cent of the membership be subscribers to the Wesleyan Missionary.

6. That each local society continue the sending of \$6.00 for Southern Mountain Work and \$5.00 for Hephzibah Orphanage. This should be sent through the Conference Treasurer, and applies on Budget.

7. That each society send \$.25 per member dues to the Conference Treasurer, one half of which is to be retained in the Conference for expenses and the other to be forwarded to the General Treasurer. Also that each society send \$.25 per member to the Conference Treasurer for expense of delegates to General Conference Society which meets next June. This should reach the Treasurer not later than June 1.

8. That we continue sending supplies to the various mission fields as requested by the workers in charge.

9. That instead of buying clothing for children at Hephzibah as heretofore we send an additional cash offering which may be used as it is most needed on arrival. Our societies may do much to see that the church raises its entire Budget for Hephzibah.

10. That we make special effort to send supplies of bedding, especially quilts and pillows for the Camp Meeting dormitories, also canned goods for the Dining Hall.

11. That the societies if possible have Missionary Conventions in the different districts or groups.

12. That each Delegate report to her society at the first meeting after Conference the proceedings of the Conference Society and spread the information gained concerning the work.

13. That the Plan of Work and Standing Rules be read and emphasized quarterly in the local society meetings.
