DAILY PROCEEDINGS

The Canada Conference of the Wesleyan Methodist Church of America in Canada convened for its Jubilee Conference in the Tabernacle on the Winchester Camp Ground, Winchester, Ont., Tuesday, July 29th at 8 a.m.

Conference was called to order by the President, Rev. S. W. Blanchard, who also conducted devotions.

First order of business was the election of a Secretary Pro. Tem. Carried on motion that the Rev. L. R. Mack be appointed Secretary Pro. Tem.

Carried on motion that the first five seats in the centre of the Tabernacle constitute the Conference Bar.

Report of the Committee on Temporary Organizations was read and adopted item by item. (See report No. 10).

The Committee on Credentials read a partial report, the following delegates answering: Mrs. E. E. Wilson, Ward Summers, Hubert Hamilton, Faye Droppo, Mrs. W. Mooney, Hibbert Vipond and John Trew.

The Committee on Courtesy introduced to Conference our Connectional Representative and General Conference President, the Rev. Dr. Nicholson, who brought words of greeting both for himself, the Rev. Dr. Eddy and Rev. D. A. Rees.

The Conference came to order at 11 a.m. for the Orders of the Day and Dr. Claude Rees of Houghton gave his Educational address. Dr. Rees spoke briefly of the educational status of Houghton College. This year the College has on her Faculty ten earned Dr. degree men.

The spiritual side of Houghton was considered and a letter was read of a recent revival with the Rev. Dwight Fergusan as evangelist which re-

sulted in nearly five hundred seekers.

A moment of insight was taken of one of the classes and a meditation on the 51st Psalm was given in order that it might be seen what Houghton is striving to teach.

A rising vote of thanks was given Dr. Rees for his splendid and helpful address.

The Secretary of the W.Y.P.S. read a very fine and encouraging report.

Carried on motion that the final reading of the Minutes and the Minutes as read and corrected from time to time be adopted by vote of Conference.

Carried on motion we adjourn to meet at the call of the Chair.

RELIGIOUS SERVICES

The opening service of Conference was held at 8 p.m, Tuesday, July 29th.

The Rev. Dr. Nicholson preached the sermon using Luke 10:30_37 as a basis for his remarks. His topic was, "The Wrong and the Right in Conduct Patterns."

The three dominant patterns being followed today were discussed. The robbers represented those who clamor for personal liberty without restraint: whose philosophy is that might is right.

The Priest and Levite represent those who are apathetic and indifferent, whose philosophy is what they have is their own to be used as they desire regardless of the needs of others.

The Good Samaritan represents those who manifest compassionate self-sacrifice, whose philosophy is that what they have is a trust to be used to meet the needs of others. This was represented as the conduct pattern we are to follow.

Wednesday, July 30th., 8 p.m. Dr. R. S. Nicholson brought an awakening and gripping message from Amos 4:12. Two fundamental facts were stated, viz.: Man is away from God and Man must meet God. These facts were followed with, How Man May Prepare to Meet God and the fact that there may be a time when it is too late to prepare to meet God.

Thursday, July 31st, 2 p.m. The Rev. C. W. Reynolds, Fraternal Delegate from the Eastern Ontario Free Methodist Conference brought his Fraternal address. He took as a text John 20:21, and his subject was, "The Great Purpose of God". The main divisions of his talk were as follows: Revelation, Redemption, Reconciliation.

He closed his remarks by speaking of the fine spirit that prevailed at the Free Methodist General Conference; Our need of the Spirit of God and the need of joining hands to save men.

The response was given by the Rev. J. H. Weaver. He spoke words of appreciation of the Rev. Reynolds' address and the fellowship of the Free Methodist Church.

Thursday, July 31st, 2.45 p.m. Dr. R. S. Nicholson, our Connectional Representative, delivered his Connectional address, using for his theme, "Christ and the Church." His address was based on Eph. 5:25, and he divided his discourse in the following manner: 'The Significance of the Church; The Church of the Past; The church of the Present; The Church of the Future.

Thursday, July 31st, 8 p.m. Dr. R. S. Nicholson preached the sermon, using Luke 23:33; 1 Cor. 11:23-26; 1 Pet. 1:18-19. His topic was, "Remembering Calvary". A vivid and soul-stirring picture was given of the significance and challenge of Calvary as the minister delivered his soul from the points following: Remember Calvary as Expressing the Depths of Human Depravity; Remember Calvary its Manifestations are a Challenge to You; Remember Calvary calls to Inward Self-crucifixion; Remember Calvary and Proceed to Pentecost; Remember Calvary and Look for His Coming.

Friday, August 1st., 2 p.m. A Memorial service was held in memory of the Rev. A. J. Shea, a pioneer of the Canada Conference.

The Rev. J. A. Bain spoke fitting words of appreciation and regard for the late Rev. Shea and his acceptable ministry in the Wesleyan Methodist Church. As a preacher he was uncompromising and the Church lost a splendid man and minister when he went to heaven. He has left his mark behind and a blessed memory to all who knew him.

Immediately following the Memorial Service the Rev. Wm. Davis, our Missionary to South America, brought a Missionary address. He read the first chapter of John, and spoke on the words, "And the Light Shineth in Darkness; and the Darkness Comprehended it Not." A wonderful description of the power of the Christ and His Gospel was given and our hearts were fired with new zeal as he portrayed the almightiness of our God.

Friday, August 1st., 8 p.m. Dr. R. S. Nicholson brought a very uplifting message from the Revelation of John the Divine, chapter 21. "The Saints' Capitol City" was the theme and everyone seemed to get a lift heavenward as the sermon was given.

Saturday, August 2nd., 8 p.m. This service was a Young People's service under the auspices of the W.Y.P.S.

Sunday Morning, August 3rd., 10.45 a.m.—The Tabernacle was well filled for the morning service and Dr. Nicholson excelled as he preached on "Scriptural Sanctification." His points were clear and his remarks pungent as he stated: Sanctification was Eternally Purposed; It is Divinely Provided; Instantaneously Wrought, Freely Offered, Comprehensive in its Scope; Reasonable in its Requirements; Personal in its Experience; Eternal in its Duration, and Necessary for Admission into Heaven.

Sunday Afternoon, August 3rd., 2 p.m. The afternoon service was a Missionary service under the auspices of the W.M.S.

Sunday Evening, August 3rd., 7.30 p.m. The Rev. W. R. Schamehorn preached a great message from the Songs of Solomon 6:10. He emphasized what the Church has come through and spoke of her significance in the light of the text.

We are grateful to Almighty God for the good Conference He gave us. His Presence was very evident throughout the session and we feel that He has ordered it for His own divine purpose. We earnestly seek His guidance and depend upon His grace for the year before us.

REPORT NO. 1 CONFERENCE PRESIDENT'S REPORT

July 29th, 1947.

To The Canada Conference Now in Session.

Dear Fellow-Workers,-

We are now assembled in our fiftieth annual session of the Canada Conference of the Wesleyan Methodist Church. For fifty years our church has been proclaiming a gospel of a free and full, yea, an uttermost salvation. Our forefathers have blazed the trail, they established an organization and firmly stood for the rugged truths of the Gospel; for the faith once delivered unto the saints. Ours is the task of maintaining the standards and going forward with a flame of living fire. In

this day of drift and compromise we need to adhere more closely to the well-beaten path, the blood-sprinkled way over which the saints of the

ages have travelled in safety.

We cannot boast of great achievements or of the extensive growth of our church in the last fifty years. We cannot change history but we do have the future and may look forward to and make possible greater achievements for the glory of God. The need is great, the opportunities are on every side, all of which challenge us to strain every muscle and nerve under the leadership and anointing of the Holy Spirit to push back the enemy and take new territory for God.

A resume of our work during the past year will reveal some very encouraging features, among which we find a new day dawning for our work in Belleville. On May the 27th a new church was officially opened and dedicated. This was a very gracious occasion. Crowds filled the church to capacity, and Rev. J. Woodhouse, the guest speaker, preached under the anointing of the Holy Spirit. Since the opening of the Church new folk are attending the services and we can see even now, a strong Wesleyan Methodist Church in the making. The same can be said of North Bay. Powassan has a promising future with a church under construction. The newly-purchased property at Brockville, which is worth in real estate value, many times the amount we paid for it, is a valuable addition to the conference. Revenue from this property will carry the overhead and also make a payment on the principal. It provides a residence for the Conference President, a chapel for church services 28'-6" x 50', an apartment for the pastor, besides two other apartments. It is beautifully situated in seven acres of ground. We believe this can be utilized to good advantage in the near future as a Bible School. The purchase price was \$8000.00 with a down payment of \$1000.00, the balance on terms. Men of experience value it at \$50,000.00

Perhaps in the fifty years history of our church there has never been a time when we had a greater indebtedness on our properties. But never did we have as much property or as valuable. Our liabilities could be liquidated with ease, if the conference as a whole stood by the work and with the proper co-operation. This is our day but we may miss it. God has given the Canada Conference a chance to gain momentum and extend her borders. We trust it shall be so. Nevertheless the enemy will contend against every advance and will endeavour to frustrate God's plan for the promotion of holiness in our fair Do-

minion.

We wish to express our thanks for every help and co-operation received during our term of office as Conference President. The burden and responsibility has been heavy at times, but what we have done was as unto the Lord. We have in every instance endeavoured to work in co-operation with conference and its official boards, etc. No move has been taken at anytime without the fullest approval and sanction of conference.

Our prayers and sincere desire for the work of the Canada Conference shall continue. May the guiding hand of the Almighty direct her course.

Throughout the year we have endeavoured to keep promotional literature, quarterly report blanks and suggestive circular letters in the hands of all our Sunday School Superintendents.

Recommendations

- 1. That each paster send his Annual Sunday School Report to the Conference Sunday School Secretary not later than ten days previous to the next session of Conference.
- 2. That a Sunday School Convention be held at Belleville, Ont., over the week-end of May 24th-28th, beginning Saturday night, and that all Pastors, Superintendents, Teachers and Officers give such a Rally their hearty co-operation.
- 3. That a special Sunday School Offering be taken on the Sunday previous to Easter Sunday and that it be given to the Conference Sunday

School Secretary to be used for the promotion of Sunday School work.

- 4. That National Family Week be observed to the fullest possible extent and that messages be given with definite emphasis suitable to the occasion.
- 5. That Pastors and Sunday School Superintendents plan a special program for the last three Sundays in September as will be outlined by the Connectional Sunday School Board in the near future.

Bro. Davis gave us a talk about the work in South America. He feels Columbia is the hardest place in which to preach Christ, but counts it a privilege to be called to the hardest place. He told of the need of a new printing press, and how much prayer is needed in that priest-ridden country. Pray that God's Word may go forth with no uncertain sound and that the needs in that part of the Lord's Vineyard may abundantly be met.

Offering \$3.65. Meeting adjourned on motion. Dismissed by Mrs. Pyke. August 1st, 1947—This last session of the Woman's Missionary Society was opened by singing, "When I Survey". Devotionals were conducted by Sr. Carey.

Mrs. Spearman introduced Rev. R. S. Nicholson to us, who gave us a brief address. He said there are three things the Lord does not require:

Mrs. (Rev.) Deeks rendered a special message in song, as did also the Waltham Trio.

Sr. Wilson gave us a synopsis of, "A Story of Romance," in which our missionaries, Rev. and Mrs. Davis were the principals, telling how both had been converted, sent to the same mission field, how they met and later were married.

Sr. Davis spoke to us first and explained the different uses of the articles on display. She also told us about some of the services held, and of a trip up the mountain; of contacts made and how Phillipe, an immoral drunkard, was reached for Christ.

Mr. Davis spoke of the difficulties of a missionary in South America. So few Christians. Out of a place of 200,000 there are only fifty Christians and two missionaries for every 78,000 people.

Let us pray earnestly for our missionaries there.

Bogota is called the Athens of South America because of its Universities. Bro. Davis spoke of the call of God, and of three kinds of people:

Those who go; Those who let go, and those who help go.

The Holy Spirit was present in this service.

Help us that we may ke, at least, one of these three. We thank the Lord for His presence during our conference.

W. Y. P. S. PRESIDENT'S REPORT TO CONFERENCE AUGUST 2nd, 1947

Dear Fellow Workers:-

We are now assembled in the eleventh Conference Session of our W.Y.P.S., and with a feeling of gratitude and praise to God we humbly present to you our report.

Thanks be unto God who has given us the Victory in our own soul through faith in the Pecious Blood of Jesus during the past year. Though we were called upon by the firm for whom we work to move from Cornwall to Brockville, where there was no church of our own, and though it seemed strange to have to move thus, yet we believe we have been directed by God to Brockville. We do not know for what reason, but we are seeking His Will. We have felt very keenly the loss of the great privilege of attending regularly the services of the Church of our choice, but we have sought to keep ourselves and our family in constant attendance at the few spiritual churches in the city in order that we might have our spiritual strength renewed and not lose the vision of the need about us. We have attended as often as possible, services in our own churches in the Conference, and these times always brought great encouragement to us. We have never fully realized the value of our Church Home until we were thrust out among others who could not be to us as our own. Truly we love and appreciate our Wesleyan Methodist Church as never before.

We are glad to report that, in the Providence of God, and under the direction of our Conference President, a Wesleyan Society has been organized at Brockville with thirteen members, and we are eagerly looking forward to the opening of our Chapel in the New Conference Building, which we expect will be early this Fall. Only about half of the people of Brockville attend any Church, and many of the churches are only half filled. Already a number of people in Brockville have stated they would attend our services and are greatly pleased that we are opening a work there.

The past year has been a remarkable one for our Y.P.S. Though we have lost some in active membership, we have made great gains in Youth Subscriptions and in the Pioneer Fund. It is really wonderful how each society has raised the money for the Pioneer Fund. Over \$1,200.00 has been raised for Pioneer alone, and our total Y.P.S. receipts for the year are almost \$3,400.00. This is almost double the amount raised last year. It has been a real encouragement to us, and we want to commend each member of each society for their co-operation and the splendid work done during the year. This was achieved because each one was whole-heartedly behind the project, and we have proved to the Conference that we can fulfil our obligations. What we have done once we can do again with God's help. Up to the Conference we are glad to report that we have a Y. P. Society on every organized charge in our Conference.

Last Conference we voted to support Rev. Mervyn Summers at Sudbury, and we did stand by him with \$666.00 until it was deemed advisable by the Missionary Board to withdraw from Sudbury on account of not being able to rent a place of worship and because those who we had counted on for some support had moved away. On the recommendation of the ministers of the Conference and by consent of our societies, the Pioneer Fund was directed for use in getting the work going at Brockville as our new Pioneer Project, and we can say that this fund has helped considerable in the preparation of the opening of this work.

Shortly after withdrawing from Sudbury, Bro. Mervyn Summers went to Cattaraugus, N. Y., to assist his father in the pastorate there. His father had been taken quite sick. Since then, Bro. Mervyn has accepted a unanimous call to pastor that church this year. We are sorry indeed to lose Bro. Summers from our Conference, and also as our Y.P.S. Treasurer, in which he did a good job. We have appreciated his co-operation and fellowship in our work. We trust his leave will only be temporary. Owing to the resignation of Bro. Summers as Conference Treasurer, by consent of the Executive Committee, we appointed Nellie Dunbar as the Treasurer to complete the term to this Conference. We might say here that Nellie has done a good job as Secretary, and also as Treasurer. Our Conference Books are in good shape.

Last year we were again honored by the winning of the Houghton Area Plaque, although we did not win by as large a margin as the previous year. We hope to win it again this year. We regret we do not have the Plaque for display at Conference, for it has not been returned from Philadelphia where it was being etched, and the person who does this work on it has just recently died. Perhaps we can have it in our midst again if we

win it this year.

We do not need to comment on our two Conventions of last year. Everyone who attended will vouch that they were both times of great blessing and encouragement. With the Executive we have arranged another Annual Convention to be held in this Tabernacle, August 15, 16, 17, only two weeks from now. Our workers are The Rev. Lois Richardson and The Rev. Carrie Hazzard of Camden, N. J., with the Rev. I. Leslie Conley as Music Director, together with others of our Conference. We are looking forward to this Convention as a time of great blessing to us all. We have engaged Rev. John Woodhouse with his wife as our workers for the Fall Convention.

Regarding the proposed Joint Convention with the Y.P.M.S. of the Free Methodist Church, after several Joint Committee Meetings, it was decided that we drop the plans for a Convention this year on account of not being able to secure a suitable place to hold the Convention at the only time we could agree on. But now the Committee have plans on the way for a Joint Convention tobe held next May 21, 22, 23. The location has not been settled yet but, Rev. Ernest Keasling, General Secretary of the Free Y.P.M.S. and Rev. H. K. Sheets, our own General Secretary, have already been engaged as our speakers. Let us pray and plan that this be a great time of meeting with God and our Free Methodist brethren.

We would like to submit a brief report of some of our engagements during the year.

Attended the Y.P.M.S. East and West Ontario Convention of the Free Methodist Church at Niagara Falls, just after our last Conference.

Had charge of the singing in two Youth Services in the Free Methodist Church at Kingston.

Served as speaker in one service in the Free Methodist Church at Kingston.

Had charge of the singing in the Canadian Holiness Federation Convention at Hamilton last Fall.

Had charge of the singing in three Sunday services in our church at Belleville, including a Radio Broadcast.

Served as Speaker in one service in the Belleville Church. Served as Speaker in one service in the Cornwall Church. Had charge of the singing at the opening of the new Belleville church.

Had charge of the singing in the Mother's Day Services at Shawville and Campbell's Bay, including a Song-Fest at Shawville.

Had charge of the singing in the Anniversary Services in the Toronto church.

Served as Speaker in one Youth Service in the Salvation Army Citadel at Brockville.

Attended three Joint Committee Meetings with the Free Y. P. M. S. regarding the Joint Convention.

And lastly, attended our General Conference in official capacity. General Conference was to us a wonderful time of uplift and encouragement spiritually. We were glad to note that our Church still stands for the Old-fashioned Way of Holiness. Many were the shouts of victory in no uncertain tones.
