JOURNAL OF DAILY PROCEEDINGS

10:00 A.M. Tuesday, August 23, 1966

Rev. C. Wesley Lovin led the conference body in singing "Leaning on the Everlasting Arms" and "Glory to His Name."

Dr. Virgil A. Mitchell, General Superintendent, asked Rev. C. Wesley Lovin to give the morning devotions. He chose as his text Acts 1:8. Rev. Claude Scott, a member of the Ohio Conference, led in prayer.

By direction of the General Conference (See Appendix A, Par. IX and X) of The Wesleyan Methodist Church of America, Dr. V. A. Mitchell called the thirty-seventh session of the Tennessee Mission Annual Conference of The Wesleyan Methodist Church of America to order.

Miss Agnes G. Houser was asked to serve as secretary pro-tem.

Dr. Mitchell stated that by directive of the General Conference (See Appendix A, Par. IX, Lines 5-10) officers of the Conference would be elected from those who signed the Statement of Adherence to the Discipline of The Wesleyan Methodist Church of America (See Appendix B).

It was voted that the first six rows of seats forward and the rostrum constitute the Bar of the Conference.

Names of ministers and lay delegates signing the Statement of Adherence to the Discipline were read.

Five elders, one conference preacher, and four laymen were seated.

Moved by N. C. Hoggle, supported by Edward Schade and approved by vote of Conference body that the Second Wesleyan Methodist Church, Nashville and Grace Wesleyan Methodist Church, Nashville, be received as members of the Tennessee Mission Annual Conference.

Moved by N. C. Hoggle, supported by Edward Schade and approved by vote of the conference body that M. R. Gatlin and delegate, Earl Wright, be seated as members of the Conference body.

Moved by Willa E. Harvey, seconded by Edward Schade, and approved by vote of conference body that B. C. Smith and dlegate, Lloyd S. Jordan, be seated as members of the Conference body.

Moved by Edward Schade, seconded by M. R. Gatlin and approved by vote of the conference body that a Nominating Committee of five be elected: The following were elected: Edward Schade, W. C. Crowe, M. R. Gatlin, Alvin McCammon, and H. A. Harvey.

The Nominating Committee was excused to prepare its report.

Names of laymen who signed the Statement of Adherence to Discipline were read. It was moved by N. C. Hoggle, supported by Willa E. Harvey and voted by the conference that those signing said statement be made honorary members of the body, to participate in conference discussions but not having right to vote.

Dr. R. C. Mullinax, President of Central Wesleyan College, brought greetings and gave his official report on the College.

The Committee on Nominations presented the following partial report which was adopted as read -- each committee being voted on separately.

BOARD OF TRUSTEES: Elders Edward Schade, H. A. Harvey, N. C. Hoggle; Laymen Alvin A. McCammon, W. C. Crowe.

ITINERACY AND ORDERS: Elders Edward Schade, H. A. Harvey, N. C. Hoggle, and Willa E. Harvey.

BOARD OF MANAGERS: Elders Edward Schade, H. A. Harvey, N. C. Hoggle; Laymen Alvin A. McCammon, and W. C. Crowe.

CHARACTER: Taylor Jackson, Michael Houser, J. A. Cassady, and H. A. Harvey.

SUNDAY SCHOOL BOARD: M. R. Gatlin, Dave Cardwell, Roy Gill, and Robert McIlwaine.

VACANCIES: Taylor Jackson, Michael Houser, J. A. Cassady, and H. A. Harvey.

The Committee on Character reported that the characters of N. C. Hoggle (elder), Edward Schade (elder), C. R. McCabe, M. R. Gatlin, and R. C. Smith (conference preachers) had been passed. By vote of the conference body this report was adopted.

Dr. Mitchell stated that by directive of the General Conference (See Appendix A, Par. I) the body could: (1) Elect a president from among those declaring loyalty to the Discipline or (2) Elect the Executive Secretary of Church Extension and Evangelism as President.

W. C. Crowe and Alvin McCammon were appointed tellers.

Officers were elected (by ballot) as follows:

President - C. Wesley Lovin Vice President - Edward Schade Secretary - Agnes G. Houser Treasurer - Alvin A. McCammon

By vote the conference was adjourned for dinner, to reconvene at the call of the chair.

Dr. Mitchell, General Superintendent, called the business session to order at 2:00 p.m.

Mr. W. C. Crowe led in prayer.

Roll was called: five elders, three conference preachers, and six lay delegates answered roll call.

Reading of the minutes were omitted.

Election of trustees was declared null and void since they must be elected by ballot. Ballots were cast and the following were elected trustees:

Elders: Edward Schade (3 years)

H. A. Harvey (2 years)
N. C. Hoggle (1 year)

Laymen: Alvin A. McCammon (3 years)
W. C. Crowe (2 years)

Alvin A. McCammon was elected trustee for Central College and Carl Taylor was elected alternate trustee for Central College.

The Nominating Committee gave the following report which was adopted by vote:

<u>PASTORAL RELATIONS</u>: Elders N. C. Hoggle, Edward Schade, H. A. Harvey: Laymen Alma Lane, W. E. Crowe and Charles Cayce.

JUDICIARY COMMITTEE: Elders Edward Schade, N. C. Hoggle, H. A. Harvey, and J. A. Cassady.

<u>COMMITTEE ON APPORTIONMENT</u>: Recommended that the General Budget be accepted; and that the Board of Managers survey the needs and make recommendations for annual conference budget items.

STATISTICIAN: Miss Agnes Houser was elected Statistician.

BOARD OF MANAGERS: By motion the Board of Trustees was elected Board of Managers of the Tennessee Conference.

The Committee on Pastoral Relations was excused for committee work.

A motion carried that the date of the next Annual Conference be referred to the Conference Board of Managers.

A motion prevailed that all unfinished business be referred to the President and his Advisory Board.

By motion it was voted that a committee composed of the Conference President, Conference Secretary, and Board of Managers, read, edit, approve, and make provisions for publishing of the Conference Minutes.

- Claude McCabe, pastor, Oak Ridge, gave his report and W. C. Crowe, delegate, gave his testimony.
- N. C. Hoggle, pastor, First Wesleyan Church, Knoxville, read his report and Alvin A. McCammon, delegate, gave his testimony.
- Edward Schade, pastor, First Wesleyan Methodist Church, Nashville, read his report.
- The following superannuated ministers gave testimonies: H. A. Harvey Willa E. Harvey, and J. A. Cassady.

REPORT OF COMMITTEE ON ITINERACY AND ORDERS:

Item I: M. R. Gatlin - Inasmuch as he is a Conference Preacher and served as pastor for 17 years of the mission which was later organized the Second Wesleyan Methodist Church, Nashville, Tennessee, and having completed the Course of Study, we recommend he be ordained, time and place to be determined by Committee on Itineracy and Orders.

Item II: Classification of Students

Second Year - Earl Wright, Second Wesleyan Methodist Church, Nashville Third Year - Earl Seibers, Knoxville First Church; Bernard Smith, Grace Wesleyan Methodist Church, Nashville; Claude McCabe, Oak Ridge.

The above recommendations were adopted by vote.

The president nominated and the conference elected the following as the President's Advisory Board: Elder N. C. Hoggle and Layman W. C. Crowe.

A motion prevailed that the Statistician receive and compile the statistical report and mail reports back to pastors.

RECOMMENDATION: That the remainder of the Wesleyan Methodist Churches within the bounds of the Tennessee Conference be left in the hands of the President and his Advisory Board with power to act in accordance with the provisions of the General Conference actions and the current edition of the Wesleyan Methodist Discipline.

The report and recommendation of the Pastoral Relations Committee was adopted.

Moved by Rev. Edward Schade, seconded by H. A. Harvey that the Conference President and Conference Trustees become the trustees for the Tennessee Corporation. Motion carried.

The chairman announced that the Statement of Adherence to the Discipline of the Wesleyan Methodist Church will be left open until September 15, 1966 for further signatures to be affixed.

General Superintendent Virgil A. Mitchell declared that in accordance with action of the General Conference of The Wesleyan Methodist Church of America the transactions of this body today will constitute the official acts of the Tennessee Mission Conference of The Wesleyan Methodist Church of America. The purported conference held July 19, 1966, is illegal and its actions null and void.
