Standing Rules

No. 1. The Conference Treasurer is authorized to close his books two weeks before the opening date of Conference, therefore all receipts and monies should be in his hands by that time if credit on the Statistical Report is desired.

No. 2. The President, after his fourth round of Quarterly Conferences, shall mail the delegates' credentials to the Conference Secretary who shall be the Committee on Credentials. It shall be his duty to prepare the roll before Conference convenes.

No. 3. All persons introduced to the Conference shall be given honorary seats with the right to speak on all questions, but not to vote.

No. 4. The office expense of the President and the Secretary and the Treasurer shall be paid by the Conference. Also all conference supplies shall be purchased by the conference.

No. 5. The Secretary and the Treasurer shall be paid twenty-five dollars per year for their services.

No. 6. The Conference Treasurer shall be bonded each year.

No. 7. An abbreviated form of the Pastors' Statistical Report shall be used for conference reading.

No. 8. The annual Conference shall elect a Nominating Committee of three to meet prior to the next Annual Conference and nominate the working committees for the session.

No. 9. The Conference President and the Board of Trustees shall constitute a Committee for the Building and Location of Churches and Parsonages.

No. 10. Each pastor shall be allowed time out from his duties as pastor to hold two revivals each year if he so desires. The church he serves as pastor shall not withhold his salary while he is absent on such authorized revival. In case any extra expense is involved in filling the pulpit while the pastor is engaged in the said revival such extra expense shall be paid by the church whose pastor is absent holding the revival."

Journal of Daily Proceedings

Monday Night, August 13

The Conference was called to order by the President, Rev. W. T. Brinson.

The Ellrod Brothers of the S. C. Conference were in charge of the music and singing. Rev. J. R. Swauger, Our Home Missionary Secretary, brought a message from Psalms 84:6, on the "Valley of Baca."

Tuesday Morning, August 14

The song service was led by J. T. Strickland. The Scripture was read by F. H. Harris. A Communion Service was observed.

The business meeting was called to order by the President.

The roll of Elders and Annual Conference Preachers was called. The Committee on Credentials reported and the roll of lay delegates was called. This report was adopted. In the absence of Mrs. Valene Bennett, Mrs. Allie Deen was seated as alternate delegate. In the absence of Mrs. Della Hanson, Mrs. Neal Palmer was seated as alternate delegate.

The Conference Bar was set to include the first three seats across the tabernacle, except the left side, and the first three on the side.

The Committee on Nominations gave a report, which was adopted. (See Reports).

The Committee on Courtesy reported and Rev. J. R. Swauger, Home Missionary Secretary, was introduced to the Conference and spoke words of greeting.

A motion prevailed that Brother Swauger be asked to preside during the remainder of the Conference. Brother Swauger presided.

W. M. Sigafos resigned from the Committee on Statistics. His resignation was accepted and this vacancy referred to the Committee on Nominations.

The Committee on Courtesy reported and Mrs. Padgett and Mrs. Harrison were introduced to the Conference. Also introduced were the Ellrod Brothers of the S. C. Conference, who gave words of testimony.

A motion was carried that all persons introduced to the conference be honorary members of the Conference with the right to speak on all matters.

The Committee on Moral Reform gave a report which was adopted and voted to be offered to the Wesleyan Methodist for publication. (see reports).

The President's report was given and adopted. (See Reports).

The Committee on Nominations gave an additional report, and C. C. Harris was added to the Committee on Statistics.

A motion prevailed that the Committee on Public Worship be responsible for the orders of the day.

The report of the Committee on Tithing was given and adopted. (see Reports).

The report of the Committee on Education was given and adopted. (see Reports).

The Committee on Public Worship gave a report which was adopted, as follows: Election of officers, 3 o'clock Tuesday p. m.; General Address, 7:45 p. m. Tuesday; Educational address, 10:30 a. m., Wednesday; Orphanage Address, 11 o'clock Wednesday Morning; Public Missionary Service, 7:45 Wednesday Night.

The Committee on Courtesy reported and J. T. Strickland and Lonnie Strickland were introduced to the Conference and gave words of greetings.

The report of the Committee on Memorials was given and adopted. (See Reports). The time for the Memorial service was referred to the Committee on Public Worship.

The hours of the Conference were adopted as follows; to convene at 8:30 A. M. until 11:45, to meet again at 1:00, to adjourn by motion.

Adjourned by motion.

Tuesday Afternoon

The song service was led by Bobbie Jean Watts. The devotions were conducted by Brother Ellrod. The Conference was called to order by the Chairman. The roll was called and approved.

A motion prevailed that the Conference approve the revision of Article V in the Discipline as stated in the recommendation read by Rev. Swauger as follows; "Article V. THE SUFFICIENCY AND FULL AUTHORITY OF THE SCRIPTURES. 12. The Holy Scriptures contain all things necessary to salvation; so that whatsoever is not read therein, nor may be proved thereby, is not to be required of any man, that it should be believed as an article of faith, or be thought requisite or necessary to salvation. In the name of the Holy Scriptures, we do understand the books of the Old and New Testaments. These Scriptures we do hold to be the inspired and infallibly written Word of God, fully inerrant in their original manuscripts and superior to all human authority.

The Canonical books of the Old Testament are;

Genesis, Exodus, Leviticus, Numbers, Deuteronomy, Joshua, Judges, Ruth, 1 Samuel, 2 Samuel, 1 Kings, 2 Kings, 1 Chronicles, 2 Chronicles, Ezra, Nehemiah, Esther, Job, Psalms, Proverbs, Ecclesiastes, The Song

of Solomon, Isaiah, Jeremiah, Lamentations, Ezekiel, Daniel, Hosea, Joel, Amos, Obadiah, Jonah, Micah, Nahum, Habakkuk, Zephaniah, Haggai, Zechariah, and Malachi.

The Canonical Books of the New Testament are;

Matthew, Mark, Luke, John, The Acts, The Epistle to the Romans, I Corinthians, 2 Corinthians, Galatians, Ephesians, Philippians, Colossians, I Thessalonians, 2 Thessalonians, I Timothy, 2 Timothy, Titus, Philemon, Hebrews, James, 1 Peter, 2 Peter, 1 John, 2 John, 3 John, Jude, Revelation.

Psalms 19:7; Luke 24:27; John 17:17; Acts 17:2, 11; Rom. 1:2; 15:4; 16:26; Gal. 1:8; I Thess. 2:13; 2 Tim. 3:15-17; Heb. 4:12; James 1:21; 1 Peter 1:23; 2 Peter 1:19-21; Rev. 22; 14, 19."

A partial report of the Pastoral Relations Committee's report was given. A partial report of the Auditing Committee was given, stating that the books of the treasurer had been examined and found to be correctly kept. This report was accepted, automatically adopting the treasurer's report. (See Reports.)

A recommendation was made by the Auditing Committee that the Conference Treasurer be bonded each year and that this be made Standing Rule No. 6.

The Committee on Courtesy reported and Brother George Davis of Hephzibah Orphanage was introduced.

The report of the Committee on Sunday Schools was given and adopted. (See Reports.)

The report of the Sunday School Secretary was given by Mack Thompson for J. M. Roberson and adopted by the Conference. (See Reports)

A motion was made that the Conference President be relieved of duties as a pastor, that he hold all four quarterly conferences, on week-ends, and that he hold revivals throughout the conference, and organize new churches. A motion that this report be referred to the Committee on Pastoral Relations was lost. The original motion was lost. A motion prevailed that we reconsider the question of referring the above motion to a Committee for special study. A motion was carried that a committee of five elders be elected to study the duties of the Conference President. A motion prevailed that the chair appoint this committee. F. H. Harris, Mack Thompson, C. M. Payne, W. T. Brinson, W. M. Sigafos were appointed.

The Committee on Courtesy reported and D. L. Jones, Field Representative of Central College was introduced to the Conference.

A motion prevailed that the use of the pastor's abbreviated form of the statistical blank for Conference reading be made Standing Rule No. 7.

The name of F. H. Harris was called and his report given. The

name of W. W. Wigglesworth was called and his character was passed. Letters from R. C. Crossman were read by the Secretary and President, and his character was passed. The following names were called, their reports given and their characters passed: C. M. Payne, E. C. Hord, A. C. Legg, Mack Thompson. A letter from Brother Jack C. Osborn and Brother Jim Miller was read by the secretary who was instructed to answer. W. M. Sigafos and W. T. Brinson gave their reports and their characters were passed. The name of Mrs. G. H. Doty was called and her character was passed. H. R. Gunby and J. M. Merrell gave their reports and their characters were passed. A five minute recess was taken.

A motion to adjourn was carried.

Tuesday Night

Brother J. R. Swauger, Home Missionary Secretary, brought the Denominational Address. His text was 330 E. Onondaga Street, Syracuse, New York. He finished his message with the needs of Home Missions and a plea for the South Georgia Conference to move out and grow. Recommendations for "A greater South Georgia Conference Campaign" were read, and \$684.00 was raised in cash and pledges for this fund.

Wednesday Morning, August 15

A motion prevailed that all books borrowed from the Conference Library be returned as soon as possible.

A motion was carried that the Conference Board of Trustees and the President of the Conference shall constitute a committee for the Building and Location of churches and parsonages, and that this shall be made Standing Rule number Nine.

A motion prevailed that the report of the Apportionment Committee not be read, but adopted with the secretary instructed to make any necessary corrections.

The second reading of the Pastoral Relations Committee was given.

A motion prevailed that the Conference Memorial service be held in connection with the regular Camp Meeting Memorial service.

A motion prevailed that the Conference President and his Advisory Board be given the authority to see into the matter of a charter for the South Georgia Conference with the authority to act in securing one of needed.

Adjourned by limiation of time.

Wednesday Afternoon

The song service was led by W. C. Wright. The Devotions were read by W. M. Sigafos.

J. R. Swauger had to leave, so W. T. Brinson presided.

The roll was called. The minutes were read and corrected.

The report of the treasurer of the Ashburn Camp Meeting Committee was given and adopted. (See Reports.)

A letter from Mrs. W. J. Davis was read by the secretary, concerning the house on the Ashburn Campgrounds, and voted to be referred to the Ashburn Camp Meeting Committee.

The Committee on Examining Church Record Books gave a report which was adopted.

The report of the W.Y.P.S. Election was given by W. C. Wright, and adopted by the conference. (See Reports.)

The report of Mr. and Mrs. W. C. Wright, as song evangelists, was given and adopted. (See Reports.)

Presidents and delegates be assessed \$3.00 each for the next Annual Conference Entertainment. A motion prevailed that Brother Scott, Sister Lewis, and Sister Long be given \$8.00 each for their part in entertainment of Conference.

A motion was carried to recess for Committee Work.

The Chairman called the Conference to order.

The third reading of the Pastoral Relations Committee was given and adopted. (See Reports.)

A recess was taken.

The Chairman called the conference to order.

A motion prevailed that only the totals of the statistical report be given. This report was given and adopted with minor corrections to be made. (See Reports.)

The report of the Ashburn Camp Meeting Committee was given and adopted.

A motion prevailed that 300 copies of the minutes be published. A motion prevailed that the Secretary be reporter of the Conference.

The Nominating Committee nominated Miss Lala Sports a committee on post office addresses. She was elected.

The minutes were read and corrected.

A motion to adjourn prevailed.

CONFERENCE PRESIDENT'S REPORT

Mr. Chairman, Members of the South Georgia Conference now in session at Hortense Campground, and friends; it is in a spirit of deep gratitude and humility that I submit the following report;

At the last session of your Annual Conference you elected me to the office of president, and I assure you that I accepted with a sincere appreciation and a keen sense of unworthiness to fill such a great responsible position. Only after much prayer and waiting on the Lord I entered into that great field of labor and the Lord has been very kind and gracious to me in the great work. He has given unto us solutions for at least some of the problems that have been ours, and I believe that He will continue to do so. How we thank Him for what He has done!

There has been no resignation of any of the pastors, but instead there has been whole-hearted cooperation. (Now a great big hearty thank-you, my dear brethren, with a prayer for God's richest blessings upon you.) Our pastors have laboured sacrificially in their fields to advance the cause over which God gave them oversight. There has been no deaths in the ministerial family of the conference and again we bow our heads and thank Him who doeth all things well. Our retired ministers have all survived and are with us still. Brethren, they are part of our conference still and our hats should be off to them, not only for what they have done, but for what they mean now. They are part of our responsibility. Let's discharge it nobly and support them always with a full pension budget.

I must mention in this report and that, with great sorrow and deep sympathy that awful tragedy that came to our beloved Woman's Conference Missionary President, Mrs. J. D. Day, along with four other members of the highly respected Day family. To them we extend our deep sympathy and pledge to them our continued prayers.

I have made four visits to each of our churches and charges, and held all four of the quarterly conferences. I have endeavored with all my ability to advance the great cause of Christ, and to promote the work of the conference by encouraging the classes to hold up Wesleyan standards which we believe to be scriptural in every sense of the word. COMMITTEE ON DUTIES OF THE CONFERENCE PRESIDENT

Your Special Committee appointed to study the duties of the Conference President met in two different sittings to consider the problem.

We feel that this is a very serious matter and ought to be given extended thought before a final conclusion is reached.

We discover that the key problem revolves around finances, and that until this problem is solved there is not a great deal that can be done.

If a president were to be sent into the field for full-time Conference duties exclusively three things would have to be supplied:

1. A place of residence. 2. Finance to pay a living salary. 3. Finance to pay operating expenses.

Because of our present inadequate finance we cannot feel free to recommend a full time president at this time, however serious we may recognize the need.

On the other hand, because of the urgency of the situation we do not feel that things ought to be allowed to drift on without any effort on our part to remedy the condition. We therefore propose the following recommendation, as a start toward rebuilding our Conference:

1. That a campaign to be known as "A greater South Georgia Conference Campaign" be inaugurated to be promoted by the Conference President and his special committee.

2. That this Special Committee be continued through the year to be known as the "Greater South Georgia Campaign Committee." It shall be the duty of this: (1) To further study the matter of a full time President. (2) To locate a suitable residence for purchase or rent for a Conference President's home. (3) To seek ways of financing the expenses involved and (4) to promote actively, the Greater South Georgia Campaign. This committee shall meet at least once every quarter and more often if it so elects.

3. That a special "Greater South Georgia Conference Campaign Fund" be established as a beginning of the effort to help the "Greater South Georgia Campaign." This fund shall be established by an initial gift of \$100.00 from the Department of Home Missions, by gifts of \$5.00 or more from each church in the conference, by gifts from individuals and by a budget of twenty-five cents per member from each church in the conference, said budget to be paid before the end of the first quarter.

4. That a standing rule be added as follows: "Each pastor shall be allowed time out from his duties as pastor to hold two revivals each year if he so desires. The church he serves as pastor shall not withhold his salary while he is absent on such authorized revivals. In case any extra expense is involved in filling the pulpit while the pastor is engaged in the said revival such extra expense shall be paid by the church whose pastor is absent holding the revival.

TITHING COMMITTEE

Scripture Lesson—Mal. 3: 8, 10. If we as a so-called Christian people would do as the Word says we could have revivals all over this nation. We have taken things in our own hands and have run the whole earth in a hole. We are cursed with all kinds of insects to destroy our produce on the farm and the city folks have all kinds of diseases, such as Polio, Cancer, T.B., and many others, and there is a remedy for it all in the Book of all books!

God commands one tenth of our income, Mal. 3:10, here it is. In verse 11 there is some conditions to this.

The Jews here ask the Lord what have we done? Where have we left off from doing our part? So . . . God told them where, plainly. MORAL REFORM

Thus saith the Lord, stand ye in the ways, and see, and ask for the old paths, where is the good way, and walk therein, and ye shall find rest for your souls. Jer. 6: 16

When the prophet uttered the words referred to, there was great need of moral reform among God's chosen people. History repeats itself as years come and go, so there is ever a repetition of the need of moral reform.

Today there is vast need of moral reform in every department of human life, socially, politically, commercially, economically, and even religiously. Our moral life has been so completely submerged in the rising tide of moral corruption until in many instances our morals have sunk below the level of brutes.

First, there is great need of moral reform in individual life for it is the individual that makes up the collective body. There needs to be a reform in the individual life that will create a true sense of personal responsibility, that will so change the conduct until people at large will be impressed with the virtue of moral purity.

Then there is tremendous need of moral reform in home and domestic life. The home is the foundation stone of all other departments of life. Destroy moral qualities of the home and any nation is gone. Today the American home is a wreck. Sanctity and a sense of marriage obligations is almost a thing of the past. Separation and divorce is rampant. There is now a divorce claim for every three marriage licenses granted, with the number of this shameful record on the increase every year. Lawyers and easy divorce courts are fattening on the spoils of moral corruption to a degree that if there is not something done to turn the tide, sense of home responsibility will be gone forever.

Then there is crying need for moral reform in our educational system. Our public schools are now becoming little than incubators for crime breeding. The modern dance is being advocated and taught to the pupils, and this dance performance is nothing but a secondary sexual

love feast. No wonder that reliable informers tell us that full one half of our young girls have lost their virtue. Real true virtue is the most valuable jewel that any woman can possess, and it is just as important for men as it is for women if the stupid men only had sense enough to know it.

There needs to be moral reform among mothers with every class of womanhood today. A woman's conduct has a greater effect on the standard of morals than does a man's. Let the women of this country set an example of proper standard of morals, and you will see a vast improvement in the morals of men. Man has lost respect for woman in the degree that she has lost respect for herself, and now we are faced with the fact that both sexes have lost their self respect, which has produced a moral degradation that threatens to wreck the whole structure of moral purity.

Instead of the old fashioned wives and mothers of a few years ago, who loved their husbands, their children and their home, we now have the little hand-painted, streamlined, cigarette-smoking, home-deserting, gad-about, running to night-clubs, honkey-tonks, and vice dens of every type, looking for an excuse to file divorce claims, and get a fat alimony if possible. Such moral degradation will soon destroy the life sinews of any people. Home ought to be a little moral paradise where husband, wife, and children love each other to an extent that any thought of separation is like tearing the heart out of the human bosom.

Our mothers would have screamed if they, with their daughters had been seen in any such suggestive vulgar nakedness as prevails today. Parents are certainly to blame for the low standard of morals now prevalent among young people.

There is great need of moral reform in the political life of our country, all the way from the White House down to magistrate and Police Court. There is such moral corruption of civil life until bribery, paid crime protection, whitewash, betrayal, and national scandal is popping out like putrifying sores with a stench that makes any half decent man heave with disgust. Righteousness exalteth a nation, but sin is a reproach to any people. The exposures recently brought to view in our civil life is enough to alarm the most stupid mind in existence. More than forty billion dollars is spent in America each year to gratify the gambling craze. More than thirty billion is spent in law enforcement, and yet the steam roller of vice moves on with a momentum that is alarming. Poor people are being burdened with taxation that is unbearable with a lamentable cry being raised for an increase of taxes all the time. History informs us that every nation that has gone down in the past has gone down through unbearable taxation, yet our civil leaders never learn anything. God means that we learn from pages of history and take to heart the lessons of providence.

Then there needs to be moral reform in our commercial and economic life when enterprises will compensate their help in proportion to their

dividends, and the employee will be satisfied with what is reasonable and right. As it is, each party is constantly maneuvering for an advantage over the other party. We don't care what wrong the other fellow suffers, just so we get what we want. It is all right with us if we bankrupt things beyond repair. Personal selfishness is the one thing that gets first consideration now, there is little respect for the other party. Party politicians and would-be reformers are constantly telling us how to eliminate all of our discord, but things refuse to bend to mortal control.

Most of all we need moral reform in religious life. Our church people are victimized by a love of ease and pleasure. The sacrificial self-denying spirit is hard to find. Church people have become as greedy and grasping as most any other class.

As a consequence of this type of religion the world has lost interest in the church, and the church has lost power to interest the world. The professing church has become rich and increased in goods, and therefore have need of nothing, so of course they can get along without God, for Jesus is on the outside, knocking for admission. Our religion has largely become a huge joke, so impotent that the devil never stirs for all our religious pretenses.

This condition is due largely to a compromised pulpit. The devil never howls when there is nothing for him to oppose. If every pulpit in churches that are supposed to be orthodox had have spoken loud and clear against the moral and social evils of the times, such moral corruption and degradation as we are now confronted with, would never have been possible. There is no use to scratch the surface of the skin, expecting to cure the rotten things rooted deep in the interior. We have got to go to the heart, root and core of the condition, if we ever expect to secure any lasting and permanent benefit. We may advocate and sponsor all reform and social service movements conceivable, and thereby secure little transitory benefit in spots, but we will never cure the prevailing evils of the hour by mere outward reform. The heart of man must be made new for out of the heart are the issues of life. We have too much man-made religion to meet human requirements, we have got to have something that God is in. Back to Behel, back to the old time family altar of prayer. Back to the old-fashioned uncompromising Gospel that speaks in no uncertain sound without fear or favor. Back to the life of fervent prayer in both pulpit and pew. Back to the life of humility, consecration, sacrifice and self-denial, which comparatively few people in pulpit or pew seem to know very much about. Back to the faith once for all delivered to the saints. Back to the old time prayer room where people will pray with such deep agony until they are exhausted and can pray no more. If we want true and lasting reform it is going to cost us something to get it, and unless we are willing to pay the price we will never obtain it. Back to the old time revival where everything will not be run by cut and dried human

program, but by leadership of the Holy Ghost where human creatures will get out of His way and give Him a chance to present the whole rigid truth, so that confessions and restitutions will be made, reconciliations will be effected, and the church bound together in unbroken unity. When this is done the world will be mightily effected by the influence of moral purity.

We need a reform of downright honesty in the professing church, one that will make us face facts as they really are, and make us confess our sins and failures, and lead us to true repentance instead of trying to justify ourselves by excuse-making arguments. An ounce of humility is worth more than a ton of excuse-making argument in an effort to justify ourselves. This reform needs to effect the pulpit as well as the pew and stop preachers from connivance and place seeking, so that they will allow the Spirit of God to choose for them instead of choosing for themselves like Lot did. His choice with God left out cost him a mighty big price twenty years later when everything he had went up in fire and smoke, and all of his family were lost except two unmarried daughters, and their later conduct showed plainly how their morals had been degraded by their residence in Sodom.

Back to the old time Wesleyan Methodist class meeting when the class leader will take the class one by one, and probe them with pointed, heart searching questions that will lead them to the conclusion that some one has furnished him with a world of information before the class meeting started. A little dried up half-hearted testimony meeting is no part of a real class meeting. There is too much room to twist and dodge in a testimony meeting.

You may call me an old timer with a warped and stupid understanding of the progress of this modern age if you want to, but the prophet Jeremiah was evidently an old timer who believed thoroughly in an old time Gospel, because he knew that it had been fully tried and stood the test.

Our trouble in our so called modern progress is, that we have turned our backs on God. We have sought information from every source except the old Bible, and the result is moral infamy and deep degradation. We have expelled God-fear and consciousness of sin. Anything we want to do is right in our estimation because we want to do it. We have fixed our own law and standards, and God's Holy Word has been tabooed. There is no hope for the right moral reform until we get back to the Bible.
